

ROOSEVELT WILL BACK BEVERIDGE

Promises Speech in Aid of Insurgent Chief, but Feels Way Cautiously.

MANY VISITORS RECEIVED

Though Beveridge Opposed Tariff He Pulled With Taft on Other Measures and Managed Statehood Bill in the Senate.

"I have no doubt Mr. Roosevelt will give out anything he wishes to become public about the interview," said Mr. Beveridge. "I gave my views on the Indiana situation fully, in a formal statement several days ago," he added.

"Did you come away pleased with the results of your visit?" The Senator's smile broadened until he laughed aloud. "Well," he said, "I have had many talks with Mr. Roosevelt in the last few years, but never in my experience have I had one more satisfactory than that of today."

Further than this Mr. Beveridge would not go. "I start on my vacation tomorrow," he added, "and needless to say, I go in a very happy frame of mind."

Mr. Beveridge said he came to Oyster Bay by appointment and that his visit had nothing to do with the other visitors here today.

"I found Colonel Roosevelt," he said, "more alive and more interesting in things than ever."

Churchill Tells of His Fight. Winston Churchill was as careful as Mr. Beveridge to keep back any specific information as to the conversation between Theodore Roosevelt and himself.

Colonel Roosevelt has been interested in the fight since it began in 1906, when I ran for Governor," he said. This year Robert R. Bass of Peterborough, is a candidate for Governor. He may be classed with the insurgents, but the New Hampshire Republican organization has not opposed his nomination.

Mr. Roosevelt wanted to know about the situation in New Hampshire, and, as I am an old friend of his, I came down to tell him.

"Did Mr. Roosevelt indicate his attitude in regard to the fight in New Hampshire?"

Only by his friendly attitude. He said nothing to show his views.

Then Mr. Churchill produced a paper on which he had written a statement. Here it is:

"Our whole purpose in New Hampshire this summer is to make Mr. Bass Governor and to elect a Legislature to support him. We have done nothing else, we have meddled with nothing else. We know Mr. Bass is uncompromising. He has been with the progressive movement since it started. He is incapable of making political deals."

"The people of the state trust him and his nomination and election will be a clear-cut victory, a signal stage in the fight we began four years ago."

Mr. Carter looked gravely at the interviewers and informed them the people in his part of the country were not hearing much about the insurgent movement just now. The Senator went alone and returned to New York alone.

On his return from Sagamore Hill he said that while his visit was not a political one, he had gained considerable information about the situation in the West.

"I assured him," said Mr. Carter, "that the alleged division in the West were greatly exaggerated and that many of us were trying to obtain the same ends through different methods."

Mr. Carter said he had assured Colonel Roosevelt that the strength of the insurgent movement in the Northwest had been overestimated. The Senator was asked if there was any possibility of a breach between President Taft and Colonel Roosevelt, and he replied:

"I can see no danger of it. Mr. Roosevelt will probably have more of a soothing influence than any other."

In addition to the political talks, Colonel Roosevelt also found time to talk about hunting in Africa. John Burroughs, the naturalist, who spent the night at Sagamore Hill, and T. J. Ader, who had stayed in for luncheon, swapped stories of the jungle with him. No politicians are expected at Sagamore Hill tomorrow.

Roosevelt to Speak in Fargo, N. D. FARGO, N. D., July 7.—Colonel Roosevelt has promised Congressman Hanna that he will deliver an address in Fargo on Labor day, September 5. The invitation was extended by the Federation of Labor through Mr. Hanna.

CUSTOMS RECEIPTS BULGE Biggest Total in Country's History Follows New Tariff Law.

WASHINGTON, July 7.—A statement prepared at the Treasury Department by direction of Acting Secretary Hills shows that the customs receipts for the fiscal year 1910 amounted to \$337,942,890.

For the greater part of the year, the Payne-Aldrich tariff law was in force and Mr. Hills said the receipts were the largest for any year in the history of the Government. The receipts for 1909 were \$300,000,000.

CABINET OFFICER LAUDED Government Employee, Resigning, Gives Ballinger Due Credit.

BALLINGER COMES WEST

TOUR OF INSPECTION MAY TAKE SEVERAL MONTHS.

RECLAMATION PROJECTS AND INDIAN RESERVATIONS TO BE VISITED IN COURSE OF LONG TRIP.

WASHINGTON, July 7.—Secretary of the Interior Ballinger left Washington today for a trip of inspection westward, which may cover a period of several months. He was accompanied by E. C. Finney, assistant to the Secretary, and a stenographer.

Mr. Ballinger's itinerary includes visits to Fort Belknap and Blackfoot Indian reservations, in Montana, and probably to the Flathead Reservation in the same state. He will inspect irrigation projects on these reservations.

After visiting the agencies he will go to Seattle and from there will make several trips to reclamation projects to inspect conditions.

The Board of Army Engineers designated to examine the reclamation projects and advise upon the expenditure of the \$20,000,000 issue of certificates of indebtedness probably will take up its duties some time prior to August 1. The board will expedite its field work as much as possible and will be ready to report to the President early in the fall.

First Assistant Secretary Pierce will act as Secretary of the Interior during the absence of Mr. Ballinger.

POSTAL BANKS OPEN JAN. 1 Hitchcock Says They Can't Be Started Till New Year.

CHICAGO, July 7.—Postmaster-General Hitchcock, who was in this city today, expressed the opinion that no postal savings bank could be established before January 1, 1911.

He made this statement during a conversation with Postmaster Campbell. Mr. Campbell was never in connection with the Interior Department July 25 to take up the practice of law in Denver.

NEWELL HAS CONFERENCES But Director Refuses to Say if One Was With T. R.

WASHINGTON, July 7.—Frederick H. Newell, Director of the Reclamation Service, whose differences with Secretary of the Interior Ballinger have created general comment, returned to Washington today from New York, where, it is believed, he talked yesterday with ex-President Roosevelt.

The residence of the director lends color to the report that one of the objects of his trip was to consult with Colonel Roosevelt concerning the friction with the Secretary of the Interior. He declined to admit or deny that he had had a conference with the ex-President.

Mr. Newell said he had conferred in Baltimore and New York with E. N. Baker, president of the Second National Conservation Congress, which will be held in St. Paul September 6 to 9. The purpose of his meeting had been to discuss plans for the convention.

The programme, he said, would be submitted to both President Taft and ex-President Roosevelt for their approval. The Congress, he added, would be as simple and direct as possible. The speeches would emphasize the fact that the conservation policy was not for the purpose of holding back anything from the present generation, but was designed for the utilization of the resources today without destroying their future usefulness.

STEAMSHIP BEAVER SETS NEW RECORD

Run From Portland to Los Angeles Is Made in 43 Hours Under Bad Conditions.

HEAVY FOG INTERVENES

Despite Delays Liner Comes in on Schedule—Throng of Notables Greet Laden Boat on Its Arrival at Port.

LOS ANGELES, Cal., July 7.—(Special.)—Today was a gala day at the harbor when the new five-day service of the San Francisco & Portland Steamship Company was initiated by the arrival of the Beaver, with 100 passengers and 600 tons of freight. The run from Astoria to San Francisco was the fastest on record. The new steamer clipped off the distance in 35 hours from Astoria and 43 hours from Portland.

Had it not been for a heavy fog last night the Beaver might also have established a new record between this port and San Francisco. For two hours off Point Conception, the big coaster proceeded under slow bell. Even with this handicap the Beaver made the run in 25 hours.

As the Beaver entered the harbor this morning the President, the only liner on the Coast, except for her sister, the Governor, was leaving for Seattle. The two steamers exchanged salutes. On her last trip up the Coast the President raced with the Beaver for six hours between Cape Mendocino and Cape Blanco. After a neck-and-neck run for nearly the entire distance, Captain Kidson, of the Beaver, called on the engine-room for another knot of two, and the Beaver shot across the bow of the President and left her behind.

Captain Kidson Proud of Record. "And I am going to blow about this record for a whole year," said Captain Kidson today. "For our schedules will not permit another race until then. I got a nice wireless message from Captain Cousins, of the President, over that race."

A crowd of several hundred people gathered at the dock today to greet the Beaver. Among the notables were T. A. Graham, general passenger and freight agent of the Southern Pacific; C. H. Lehman, president of the Independent Steamship Company; Messrs. Brandt, Duncan and Flint, agents for the Pacific Coast Steamship Company; and G. L. Blair, general freight agent of the company. The Beaver will sail on her return trip tomorrow morning at 10 o'clock.

AUTO OFF TO CRATER

FAMOUS LAKE NOW REACHED BY MACHINE.

REGULAR STAGE SERVICE OPENS TODAY

FROM MEDFORD—CARS TO RUN THREE DAYS OF WEEK.

MEDFORD, OR., JULY 7.—(Special.)

The first auto in the regular Crater Lake stage service will leave for the lake tomorrow. Regular trips are to be run during the season, leaving Mondays, Wednesdays and Fridays.

The machines will leave at 7 A. M. later in the season if the business is such as to justify it.

Crater Lake County has issued a neat pamphlet giving complete information as to the trip for the benefit of the tourists. The auto stage line will prove of great benefit to those wishing to visit the lake which has heretofore been accessible only to such visitors as were willing to forego the ordinary comforts of traveling, hire their own conveyances and endure all the incident delays of passing through an almost unexplored region.

This season the Crater Lake Company will open, on the rim of the lake, a fully-equipped kitchen and dining-room and will provide comfortably-floored tents for sleeping accommodations, heated with oil stoves. By the close of the season, a fully-equipped lodge will be finished.

It will contain, among other attractive features, four massive fireplaces, one of which will be placed on the outside of the building and will be used for campfires, where strangers will meet and part as friends, where story and song will blend with joy and gladness and the life of man be forgotten.

Oil Combine Agrees to Pay Fine and to Stop Illegal Practices. Must Build Refinery.

ENID, OKLA., JULY 7.—The ouster suit

of the State of Oklahoma against the Waters-Pierce Oil Company was settled today when the company promised to pay a fine of \$75,000 and cease the practices the state held to be unlawful.

Violation of the anti-trust law was charged. The agreement provides that the state shall receive \$25,000 in 60 days, \$25,000 in six months and the other \$25,000 in nine months. The company promises not to maintain any restraint of trade in petroleum products in the state.

The Waters-Pierce Company also promises to erect or acquire a refinery at a cost of not less than \$15,000,000 near a suitable city in the oil fields. The signing of a stipulation resulted in the dismissal today of the quo warranto suit brought by Attorney-General West against the company.
