SIX PERISH IS REPORT FOREST FIRES IN BRITISH COLUMBIA HEM IN SETTLERS. While Father Flights Flames, Four Members of Family Die as They Seek to Escape.

FOREST FIRES IN BRITISH COLUMBIA HEM IN SETTLERS. While Father Flights Flames, Four Members of Family Die as They Seek to Escape. VANCOUVER, B. C., Sept. 14.—(Special.)—A special to The World from R. T. Heston, a correspondent on the scene of the Fraser district bush fires states that four members of the family of William Morrison, a rancher, living near Hazelton, are reported to have perished while seeking escape through the flames that menaced their home. The father was fighting fires in another part of the district. Heston reports two deaths between Hazelton and Mud Bay has continued Deputy Fire Warden Gordon. Only a heavy and continued down-pour of rain can stem the fierce progress of forest and bush fires now raging across the Fraser River from New Westminster. Up to the present, not including the value of timber destroyed, which can hardly be estimated, and the small amount of property burned, it is thought \$50,000 will cover the damage, but the flames are rapidly becoming a menace to surrounding towns and valuable timber limits, including sections most prized in the lower mainland. The town of Surrey is closed up and the citizens are all fighting the flames, which have destroyed a number of homes there. A 130-foot bridge near Blaine, one over the Serpentine and several smaller ones have been burned and Hunter's Mill at Hazelton destroyed. The loss to the latter being \$5000. A score of homes have been licked up in nearby localities. The chief danger seems to be at White Rock, where Chief Fire Warden Gladwin has gone to direct the firefighters. Peacock Case to Be Tried.
