WHALE KILLED BY BOMBS Long Beach Residents See Exciting Struggle With Leviathan.

LONG REACH, Cal., Feb. 8 .- The fishing launch Camiguin, Captain Cook, which was fitted out some months ago rith a whaling gun for the pursuit of whales, which are often seen in the waters of the Catalina Channel, made its first catch today, and after an ex-citing struggle off the local harbor front, killed a 35-foot California gray The leviathan was sighted off the

Sam Pedro breakwater and led the Camiguin a chase of several miles be-fore the crew could put a shot into it. The explosion of the bomb drove the whole into a furious torment, his struggles imperiling the lives of the five men in the crew and two more shots were exploded in him before he succumbed and lay quiet on the waves. A large number of small craft loaded with sightseers took part in the chase and witnessed the killing.
