

COAST UMPIRES TO WORK ON SCHEDULE

Graham Will Introduce Plan of Directing Movements This Season.

SCHEME IS NEW IN WEST

Men Will Draw Straws on Opening Dates, and Thereafter Travel According to Prearranged Route, Says League President.

SAN FRANCISCO, Feb. 20.—(Special.)—Judge Graham, president of the Pacific Coast League, is going to inaugurate an innovation in baseball circles in the West by mapping out a regular schedule for his umpires during the coming season.

Instead of the old system of assigning umpires from week to week, Graham will have his men on schedules for the entire season and he hopes to do away with much of the wrangling which resulted last season because certain of the umpires were stationed in some cities too frequently and in others far too short a period.

The staff of umpires, which consists of McGroarty, Hines, and Finney, will be called together by President Graham shortly before the season opens and will be allowed to draw straws for the three routes which will be mapped out. After it is settled in which towns the umpires will open the season, each man will follow a regular schedule to follow out.

This is the first time in the recollection of local baseball men that such a scheme in handling the umpires has been put in force and President Graham hopes to accomplish a deal of good to all hands around.

ARMY MIDDLEWEIGHT SAID TO BE COMING "CHAMP."

Both Boxers Who Will Appear at Vancouver Tomorrow Have Good Ring Records.

Otto Berg and Jack Duarte will fight at the Vancouver, Wash., auditorium, at 8 o'clock tomorrow night. Berg is an artilleryman from the East, holding the middleweight championship of the United States Army. He whipped Al Neill in Astoria in two rounds, and fought a ten-round draw with Fritz Holland, of Spokane. Holland has a decision over Jack Leater. Jack Grant says he believes Berg to be the coming champion middleweight fighter of the United States.

Duarte has fought 22 fights, and has had two decisions against him. One of these was in a six-round fight with Fritz Holland, which was declared a draw, and the other a four-round bout with Johnnie O'Keefe. Duarte has never been knocked out. He stopped Ace Clements, of Portland, in a ten-round fight. There will be two six-round preliminaries at the auditorium tomorrow night, one between Chick O'Connell, of San Francisco, and Harry Harrison, of Astoria, weight 125 pounds. The other is between Private Courtney, of Vancouver Barracks, and Young Mitchell, Duarte's sparring partner, weight 130 pounds.

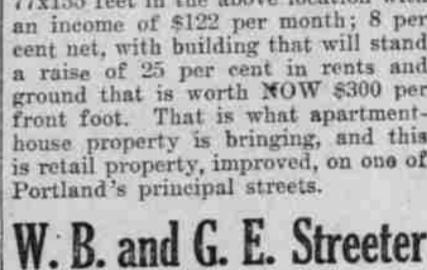
