

SNOWSIDE KILLS 3 WOMEN, 1 MAN

Avalanche Sweeps Boarding-House in Colorado Mountains Into Canyon.

3 OF VICTIMS ARE WOMEN

Man Held by Heavy Timber, Unable to Respond to Cries for Help by Wife and Others Who Perished.

DENVER, Colo., March 12.—Four persons were killed and one injured by a snowslide that destroyed the boardinghouse at Gold King mine near Gladstone, in Southwestern Colorado, today.

Information received tonight from Telluride, Colo., eight miles west of Gladstone, states that hundreds of tons of snow and rock swept the boardinghouse into a deep canyon.

Manager Drue, of the boardinghouse, was held fast by the heavy timbers. Though not seriously injured he was unable to extricate himself to go to the aid of his less fortunate companions, whose cries were heard for some time after the avalanche.

The dead: Mrs. F. O. Drue, wife of Manager Drue; Mrs. Carrie Lewis; Samuel Hoar; Maria Fahne.

Residents of Gladstone saw the slide. A rescuing party was formed and hurried through the deep snow to the Gold King. All were dead except Drue. One's position was such that he was not released until eight hours later. His feet and hands were badly frozen, but otherwise he was not seriously hurt.

Working beneath masses of snow and ice, which threatened to come down any minute, the rescuers late today succeeded in recovering the four other bodies, which were taken through the deep snow to Silverton.

SEASIDE BANK INSOLVENT

Court Decree Says Officers Committed Illegal Acts.

ASTORIA, Or., March 12.—(Special.)—A final decree in the case of Will Wright, State Bank Examiner, against the Bank of Seaside, was granted by Judge Gahlin in the Circuit Court. It declares the defendant bank insolvent, says its officers and directors have committed many illegal acts, such as to prohibit the bank from further continuation in business, and to require that its affairs be wound up and the assets be distributed among the creditors.

The officers are restrained from attempt to collect amounts due the bank, and Frank S. Godfrey, the receiver, is authorized to sell all the bank's property, either by private or public sale, after publishing due notice of his appointment as receiver.

RADICALS PLAN WALK-OUT

Chauveteurs and Transfer Men Are Urged to Join Adams Company's Men, but Decisions Are Postponed for Time.

NEW YORK, March 12.—(Special.)—Excited by the reports of the strike among the drivers of Adams Express Company, the local unions belonging to the International Brotherhood of Teamsters came forward today at the night meetings with demands for a general strike, which should have the effect of tying up pretty nearly everything on wheels in New York.

At one time tonight it looked as if the Chauveteurs and Hackmen's Union, with 1750 men, the Tealing and Transfer Union, comprising the 1000 drivers in the employ of the General Transfer Company and Doda Express, and the drivers and helpers of the other express companies in the "Big Five" would join the Adams Express Company drivers and helpers in one gigantic walkout, beginning Tuesday.

As these meetings adjourned one after the other, toward midnight, it became known that most conservative counsel had prevailed. The local unions, meeting on Saturday night in the discussion of an immediate and general strike, decided one by one not to go out, at least, the strike question was postponed to the weekly meeting Tuesday night of the general council of the International Brotherhood of Teamsters. Even that body, in the face of the lockout, must refer the question of a strike to the National body, whose headquarters are at Indianapolis.

Colonel Isaac Trumbo Evicted by Bank.

SERVANTS LABOR FOR FOOD

Once Noted Lawyer and Multi-Millionaire Is Cast Out to Satisfy Loan of \$11,000, Which Was Made Twelve Years Ago.

SAN FRANCISCO, March 12.—(Special.)—Colonel Isaac Trumbo, who made a fortune as counsel for the Mormon Church, and who lived in the Amelia Palace after Brigham Young's death, was evicted from his old home here yesterday to satisfy a loan of \$11,000 made 12 years ago, on which no interest had been paid. The German Savings Bank, which lent the money, gave Trumbo ample opportunity to pay, but when the amount reached \$18,000 the bank foreclosed.

Colonel Trumbo came here about 15 years ago, when several times a millionaire. He built a fine home on Sutter street in a fashionable district and lavished large sums on wall and ceiling decorations painted on canvases and placed on the walls. He also bought many fine paintings by European and American artists. Here he entertained lavishly and loved to show his friends his art treasures, which were of an estimated value of more than \$250,000.

Gradually Trumbo's fortune melted away in bad mining investments and for the last nine months he has lived in his art palace without any modern conveniences. The gas and water were shut off because of his failure to pay the bills. Good meals were served to Trumbo by his old cook and his negro body servant, who did work for the neighbors to get the money to buy food.

The bank's officers tried to get Trumbo to sell some of the tapestries and paintings, but he refused persistently. In the last few months the neighbors say they saw Colonel Trumbo with a candle in his hand going the rounds of his art gallery and admiring the pictures. The wages of the old servants amount to \$7000, but they have remained loyal without pay.

Trumbo's brother, Howard, his only near relative, lives in Florida.

BIG LYNX INVADERS TOWN

Brute Five Feet Long Caught in Clackamas Highlands Yard.

OREGON CITY, March 12.—(Special.)—A fence five feet high in the heart of Clackamas Highlands to steal blue-ribbon chickens, a giant lynx was trapped after it had invaded the barnyard in safety for many nights. One paw escaping the clutches of two traps, the brute fought the captors fiercely. It was killed by E. Hope and Andrew Taylor, neighbors on Clackamas Highlands, whose chickens were long preyed upon by the cat.

The lynx measured five feet from head to tail and weighed 115 pounds. After leaping the high fence surrounding Mr. Hope's barnyard, the lynx would open the door of the chicken-house and make away with one or more of the prize-winning fowls. The chickens were valued at \$10 apiece.

'FULL CREW' BILL OPPOSED

Railroads Assert Burden Useless, but Employes Favor It.

SEATTLE, Wash., March 12.—Representatives of all railroads operating in Washington met here today to consider bills for opposing the "full crew" bill passed by the last Legislature and now before Governor Hay, awaiting his signature.

The bill provides that all passenger trains must be supplied with crews of five men, all freight trains of more than 20 cars with crews of six men and light engines with conductors.

The railroads assert that if the bill becomes a law it will inflict a heavy burden on them without increasing the efficiency of the service or protecting the public more than at present. The railway employes are ardently advocating the bill and will probably send a representative to Olympia to urge Governor Hay to sign it over the protests of the companies.

VANCOUVER BONDS BOUGHT

State Takes \$11,475 Worth at 5.5 Per Cent for 20 Years.

VANCOUVER, Wash., March 12.—(Special.)—The school district, comprising the city of Vancouver, has sold bonds to the sum of \$11,475 to the State of Washington at 5.5 per cent for 20 years. The bonds may be paid for all or in part after one year. Four other bids from Eastern bidders were rejected.

This money will be used to buy three school sites to be held by the school district until they will be needed. The schools are almost crowded to capacity and will be but a short time before more schools will be built.
