FIRST-HAND FACTS SOUGHT

H. A. Jackson, John I. Springer and Fred W. Graham, of Great Northern, and R. W. Foster, of Burlington, Go in Private Car.

A private car attached to the regular North Bank train leaving here yesterday morning carried a party of local Hill officials to Fallbridge, Wash., from which place they proceeded over the Oregon Trunk to Metolius for the purpose of gaining first hand information on Central Oregon.

The party was composed of H. A. Jackson, assistant general freight and passenger agent of the Great Northern Railroad; John I. Springer, traveling freight agent of the same line; Fred W. Graham, Western Industrial and Immigration agent of the Great Northern; and R. W. Foster, assistant general agent of the Burlington. They expect to remain in the interior for a week.

Mr. Jackson, who leaves soon for St. Paul to accept the position of assistant general traffic manager to which he recently was promoted, wishes to view the territory of which he has heard so much and which the Great Northern has been exploiting so extensively.

"I want to know something about that country before I go East," he said yesterday morning. "I have been telling people what a great section of the state it is and never have seen it. I have been satisfied to take the words of others for it."

"I know that when I get back to St. Paul everyone will be asking me about Central Oregon, as that section is receiving more attention just now than any other."

BAY OCEAN WANTS PORT

PETITION CALLS FOR VOTE ON THAT SUBJECT.

Tillamook and Bay City Commissions Confer on Harbor Improvements to Be Made.

TILLAMOOK, Or., March 20.—(Special.)—A petition was filed today with the County Clerk, calling for an election to form a Port of Bay-Ocean Commission. President Holmes thereupon called a meeting of the Tillamook Commercial Club to confer with the Port of Tillamook Commission and A. A. Russell, superintendent of construction at Bay Ocean. All of the morning was taken up with discussion of harbor and harbor improvements, with the idea of getting something done right away. There was a large attendance.

The Churchill-Matthews holdings at Dufur consist of 300 acres of good horticultural land, 1000 acres of which have been planted to apples. The remaining 2000 acres will be cleared and subdivided into small tracts for the market.

"We were experiencing severe weather in Astoria when we started on this trip," said H. W. Banigan, of Burlington, last night, "and for that reason doubly appreciate the delightful weather conditions we find here. Oregon is receiving a great deal of effective advertising throughout the states of the Central West through the medium of the Great Northern, which is conducting an exhibition train through those states. In this way great interest is being aroused in your state and many of our people are now on their way here to locate. Others will follow."
