

MRS. SCHENK HELD ON ORDER CHARGE

Killing of Husband Ends Celebration of Friends' Wedding Day.

WOMAN'S NERVES BREAK

Staid Pleasures at Church Social Are Followed by Drinking, Dancing and Visit to Music Hall. Shooting Is Climax.

CHICAGO, March 20.—Mrs. Charles Schenk, who confessed the shot her husband Saturday morning, after a night of revelry, was held today by the grand jury on a charge of murder. While giving her testimony, Mrs. Schenk was overcome and fell, striking her head against a desk, receiving a painful cut over the eye. She related the incidents of the party, which she said, had been in celebration of the 10th wedding anniversary of "Chick" Fraser, an ex-National League ball-player. She said she had been put to bed by other women of the party, but was awakened some after by Schenk calling her from downstairs. She got a revolver, fearing burglars, and hurried to the top of the stairs. Then she said she "could see her husband slumping on the stairs." She admitted that the revolver was discharged, but said she did not know of firing the shot and had no knowledge of the later events. The discovery of a second bullet, found in a register on the second floor, put an entirely new phase on the shooting, according to the police, and gave them the theory that Mrs. Schenk shot her husband deliberately after a quarrel.

"Chick" Fraser testified that, with his wife, he had formed one of six couples that began a night of gaiety at a church euchre party. "After the church party, at which we had lunch but no drinks, we went to Park Ridge, to a hotel, where some members of the party and myself have been living," said the ex-catcher. "It was my wedding anniversary, so I got a quart of whiskey to celebrate. Then we got a quart of champagne and a quart of sour wine for the ladies. Drinks were served to all, but I did not see Mrs. Schenk drinking. "Then we went to a music hall in Park Ridge and at about 10:30 went over to Schenk's home. There we had more beer, whisky and wine, and finally moved the furniture out of the dining-room and danced. Mrs. Schenk got dizzy, and later, I learned, she had been put to bed. Everyone was happy."

REACTION ON IN PORTUGAL

Royalists Spend Money Freely and Republic Delays Election.

LISBON, March 20.—The monarchists, taking advantage of the divisions and antagonisms among the Republicans and distributing money lavishly to spread dissatisfaction in the capital and throughout the provinces. The Government's postponement of the election for the fourth time, until May 15, has made a disagreeable impression on the public. The announced reason for this delay is the submission to the people of a bill of a president and government is that the clergy have undue anti-government influence in various northern districts and there is need of more time to further the Republican campaign. The British foreign office has informed the Portuguese government that it will receive a representative of the republic quite unofficially, and will not recognize him in a diplomatic capacity. It is on those conditions that Teixeira Comar, the new envoy, goes to London. It is understood that Washington will follow this course in the case of the Portuguese representative sent to the United States.

JONES GETS 2 WEEKS' STAY

Judge Wolverson Delays Time for Beginning of Sentence.

Federal Judge Wolverson yesterday extended for two weeks the time when William N. Jones must begin serving his jail sentence of four months. The action was taken upon motion of United States District Attorney McCourt, who received a telegram from the Attorney General saying President Taft desired to reconsider his decision refusing Jones a pardon.

COURT DENIES COX

Alleged Cincinnati Perjuror Loses Contentions.

PLEA OF BIAS IS FAILURE

Judge Hunt Refuses to Act on Affidavit Against Judge Gorman, and Judge Swing Will Not Allow Injunction.

CINCINNATI, O., March 20.—Developments emanating directly from the charge of perjury against George B. Cox, in the common pleas court here came fast today and in each instance the attorneys for Cox came out second best, at least temporarily. From the time when Presiding Judge Hunt refused to act on an affidavit declaring Judge Frank Gorman "biased and prejudiced" until Judge Swing ended by refusing to grant an injunction against Judge Gorman's trying the case, there was not a quiet moment. In handing down his decision, Judge Hunt said the statute providing for the filing of a perjury affidavit to swear a judge off the bench is so framed that it applies to other counties in Ohio, but not to Hamilton County. Judge Hunt recommended that if there was any doubt about the decision, a mandamus proceeding against him, to be decided by the upper courts, would settle the matter. According to the mandamus proceeding was filed in Judge Swing's court, and a hearing set for Saturday. Hardly had this news trickled from the courthouse before Judge Gorman ordered George B. Cox before him to plead to the indictment of perjury. The Sheriff's office reported that Cox soon would be in court. The prosecutor, after waiting half an hour, sent a man for Cox. This man met Sheriff Cooper, who told him Cox had been notified by telephone to appear, and they turned back to the courthouse. Another delay followed and Judge Gorman instructed Sheriff Cooper to go after the defendant in person. Before the Sheriff could reach Cox's office, the latter, with an attorney, had departed for the courthouse. Cox's attorneys offered a motion to quash the indictment and gave notice of their intention to file a plea in abatement. Judge Gorman set the hearing on the motion for tomorrow morning. Thereupon the Cox attorneys attempted to gain further delay by filing an application in the Circuit Court for a temporary injunction to restrain Judge Gorman from hearing any phase of the case, pending a decision on the mandamus suit by which they sought to obtain a ruling as to whether Gorman could be sworn off the bench for alleged "bias and prejudice." The injunction proceedings were brought before Judge Swing, who denied the application.

SELLING'S GOAL \$20,000

SUBSCRIPTIONS TO CHINESE FAMINE FUND SLOW.

Of Second \$5000 Amount Now Donated Is \$2800—Churches and Sunday Schools Give.

Ben Selling yesterday issued a gentle reminder to the public that he expected to keep up the good work for the Chinese famine fund until he got \$20,000. He was not going to be content with a cent less. He felt that it was a duty which the public owed to the distressed and suffering in the northern part of China. "The conditions in that country," said he, "are indescribable. The loss of life I believe is the largest within modern times when famine is considered as the cause. I do not believe that any man will express an opposite view when I say that the duty of all is to give something to help the unfortunate in this foreign land. It is so easy to save a life and when only a few dollars will do it."

FRANCHISE IS GRANTED

Deal Now on for Line From Melottus to Prineville.

PRINEVILLE, Or., March 20.—(Special.)—Prineville City Council granted a franchise to the Prineville & Eastern Railway Company at a special meeting Tuesday night. The matter was warmly discussed and was granted on the proviso that it be used within three years from date. The Prineville & Eastern Company is now negotiating with the Hill interests to sell the franchise and rights of way for a branch line from Melottus to Prineville. From present indications it seems that this deal will be closed soon.

NEGRO'S INJURIES BAR FROM COURT

Booker Washington Supported by Tuskegee Normal Institute Board.

EDUCATOR DEFENDS ACTION

He Declares Assault of Ulrich to Have Been Unprovoked—Carpenter Says He Saw Negro Peeking Through Keyhole.

NEW YORK, March 20.—Injuries received last night by Booker T. Washington prevented the negro educator from appearing in court today and postponement of the charges against Albert Ulrich, the carpenter arrested last night on Washington's complaint of felonious assault, was taken until tomorrow. Ulrich was detained in \$500 bail. Many leading men offered aid and sympathy today to Washington, whose bandaged head is mending fairly well. Dr. Washington's secretary said he was doubtful if he could appear in court tomorrow, when the case is scheduled to be tried. Many sympathetic telegrams from every section of the United States, and telephone calls were received by Dr. Washington, while many persons called at the hotel, according to his Ulrich declares, to the fact that he was acting within his rights when he chased the negro for several blocks, and inflicted a beating. "I was ignorant that the fellow was Booker T. Washington," said Ulrich in an interview, "but my wife complained to me that she had met him in the hallway of our flat house in West Sixty-third street, and told me of the man's remarks. Naturally I was incensed."

ROOSEVELT BIG FACTOR

PEOPLE WANT HIM OR LA FOLLETTE, SAYS FOLK.

Ex-Governor Declares Progressives Will Control Next Republican National Convention.

SPOKANE, Wash., March 20.—"Indications are that the Progressives will control the next Republican National Convention and although this did not seem so a few months ago, the Roosevelt sentiment has increased considerably recently," said Joseph W. Folk of St. Louis, ex-governor of Missouri, who arrived in Spokane Sunday afternoon. "Those who speak of Roosevelt as down and out are much mistaken," continued Mr. Folk. "He wields wonderful influence. If the rank and file of voters have their way and they have learned to do so, their selection will be Roosevelt or Senator La Follette, of Wisconsin, for the Presidential nominee. If the voters do not have their way and the Federal machine runs over them they will be heard from later."

STRAIGHT TICKET TABOO

California Has Ballot Law Which Makes Voters Work.

SACRAMENTO, Cal., March 20.—Governor Johnson signed today the Boynton Australian ballot bill, providing for a ballot with no party insignia. By the terms of the bill the party affiliation of every candidate, except judges and the superintendent of public instruction, is placed after his name on the ballot, and nowhere else. "It makes it impossible to vote the so-called 'straight ticket,' and compels the elector to make his mark opposite the name of every candidate for whom he desires to vote. Names of candidates for city offices and for the legislature appear on the ballot in alphabetical order, in all other instances where more than one Assembly district is involved, they appear alphabetically in the district having the lowest numerical designation and rotate in succeeding districts."

\$90,000 BONDS SUBSCRIBED

Chehalis & Cowlitz Railway to Begin Work at Once.

CHEHALIS, Wash., March 20.—(Special.)—The total subscriptions to the bonds of the Chehalis & Cowlitz Railway reached the sum of \$90,000 last night. The soliciting committee that was out Saturday secured an additional \$15,000 yesterday when \$60,000 was reported. By tonight it is expected the total will reach \$100,000, with several well-to-do interests yet to come in. The local subscriptions will likely reach \$125,000 before the subscriptions are all in. Work is to begin at once and will be pushed just as fast as possible. The project is being managed by one of the organizers of the company will have charge of the work, and is an experienced man in railroad building, having been engaged in the actual construction part of the work.
