

SNOW AND WIND HIT TWO STATES

Snatched by Tornado, Boy Is Carried Quarter of Mile to His Death.

LAKES TO FEEL COLD WAVE

Ante-Bellum Mansion Is Blown to Bits as Storm Sweeps Path. Family From Cave Sees Cyclone Deal Death to Member.

CHICAGO, April 30.—Driven by a high wind, a snow storm is raging over northwestern Kansas tonight. Temperature drops of 35 degrees from yesterday are reported. This storm is believed to be a continuation of the severe wind storm which hit sections of Missouri yesterday and this morning. At one place carrying a load of 10 year a quarter of a mile and dashing his brains out on the ground. The boy's mother was injured and will die.

The weather bureau predicts that the cold wave now over the Northwest will move eastward, reaching the Ohio Valley Tuesday and New England Wednesday.

Snowstorm Is Expected.

A snowstorm is expected tomorrow or Tuesday in the Upper Lake region, and unsettled weather will prevail throughout the North Central States for several days.

In all the reports of bad weather from various parts of the country, those from Missouri tell of the most damage. So far as is known, the only loss of life occurred at Warrensburg, Johnson County, Missouri.

In the tornado that swept a path a mile wide across Northern Johnson County, Missouri, yesterday, Kelly Fain, the 10-year-old son of William T. Fain was carried a quarter of a mile by the wind and was thrown against the ground with such force that nearly every bone in his body was broken and his brains were dashed out. His mother was struck by flying timbers and fatally hurt. His father's home, a mansion of ante-bellum days, was blown to atoms.

Children Dash to Cave.

The elder Fain and his three children were returning from a field when the storm broke. He urged them to run to a cave in the yard of their home. Two of the children reached the cave and were saved. The little boy could not run fast enough and was carried off before the eyes of the family.

A tornado struck Sedalia, Mo., at 10 o'clock this morning and damaged property in a path two blocks wide and a mile and a half long. Mrs. Isaac Reed and George Alspaugh were cut by flying glass, in both instances timbers being blown through their windows.

Houses were torn from their foundations, and large trees were torn up or snapped in twain. The roofs of two buildings were blown off and carried a block away.

STOCK MARKET RECOVERS

Comparison With Last Week's Activity Shows Upward Trend.

NEW YORK, April 30.—Day by day contracts in the stock market last week threw little light on the speculative sentiment expressed in the operations. But comparison with the previous week it was possible to discern a distinct movement of recovery and a subsidence in activity.

In the bond division there occurred another revival of demand and upward tendency of prices, comparable to that of the opening of the year. This movement may be ascribed largely to action of bank resources in the reserve centers and this again is a consequence of diminished demand for credits which argues a lessened trade activity.

Advices in regard to some of the leading industries, notably steel and textile, are confirmatory of this implication.

Features of the bond market included new issues of railroad bonds of longer maturity. Reports of railroad earnings for March indicated success in the cutting down of running expenses and corresponding benefit to the value of railroad shares resulted.

BRITISH OFFICER FIRM

Commander of Shearwater Says He Was Warranted in Mexican Affair.

VICTORIA, B. C., April 30.—The British stoop of war Shearwater, which landed a Maxim gun and 32 men at San Quentin, Mex., when that town was threatened by the insurgents, arrived in port today after a long cruise in the South Pacific. When informed that the Mexican government had lodged a protest with Great Britain because of the landing of the Shearwater's men on Mexican soil, Commander Vivians stated that should the same conditions arise he would act similarly again, despite the protests.

There was a written request by British and other foreign residents for protection and the armed force was landed to guard them, not to occupy the town, which was absolutely unprotected, the residents having fled when they learned the rebels were approaching.

Man Under Bonds Accused.

PENDLETON, Or., April 30.—(Special.)—Accused of committing a second crime while on bond awaiting trial for the first, the man of the name of R. M. Vermillion. He was arrested at Helix recently, charged with passing a forged check on the hotel keeper at that place. He was arrested yesterday at Meacham on a charge of obtaining money under false pretenses. He is said to have represented himself to be a collector of the Walsh grocery store of this city.

POLICE GUARD BABE

WASHINGTON, April 30.—Police are guarding the McLean mansion to prevent the kidnaping of Vincent Walsh McLean, the "million-dollar baby" son of Edward B. McLean, and grandson of John R. McLean and the late Thomas Walsh, the Colorado millionaire mine owner. Since last summer the parents have been apprehensive of an attempt to kidnap the child, who sleeps in a golden crib presented by the late King Leopold of Belgium, who was an intimate friend of the Colorado mining king. Detectives were employed last summer to guard the baby at Star Harbor and they were charged never to permit him to get out of their sight.

About the time the famous Hope diamond was delivered at the McLean home here a suspicious man made his appearance in the neighborhood and appeared fear that an attempt at robbery would be made. But it is learned that the nurse who has charge of Baby Vincent reported to Mr. McLean that the suspicious stranger followed her whenever she had the child out for an airing.

Mr. McLean again placed a guard of detectives around the baby to the satisfaction of the police and has deemed it necessary to call upon the police for assistance. Patrolmen have been assigned to posts outside the house and the nurse will be maintained to frustrate any attempt at kidnaping.

When William Loeb was secretary to President Roosevelt, policemen were directed to guard his home because of threats to kidnap his child.

TWO HURT IN HOTEL FIRE

GUEST FALLS INTO CREEK WHEN SHEETS ARE SEVERED.

Proprietor's Son Leaps From Second Story, Landing on Spike, in Pendleton Disaster.

PENDLETON, Or., April 30.—(Special.)—Two men were seriously injured in a fire which destroyed a half block in the heart of Pendleton and for three hours threatened the entire town with destruction early this morning.

Stephen Cline, son of the proprietor of the Hotel Royal, in which the fire started, jumped from a second-story window and struck a spike which penetrated his side and pierced his lung.

Eph Williams attempted to let himself down from a second-story window by means of a rope of two sheets. The knot became untied, and he dropped into Pine Creek, suffering a broken hip and other injuries. Both men are in St. Anthony's Hospital. Other occupants of the hotel escaped in their nightclothes.

The cause of the fire, which started at 1 o'clock, and continued until 5, is unknown. The hotel, a feed store and a barber shop were entirely consumed, and the blaze finally being stopped after it had ruined a near-beer hall.

The loss will be more than \$25,000, and is only partially covered by insurance.

INSURANCE MAN RELEASED

Alleged Cheyenne Embezzler Wins Habeas Corpus Plea.

TACOMA, Wash., April 30.—(Special.)—Sitting in special session at the Court house this evening, Judge Clifford granted a habeas corpus application of Clark Veatch, arrested here Saturday night by Cheyenne, Wyo., officers on a charge of embezzling \$500 from the Prudential Insurance Company at that place and the agent was given his liberty. He will be compelled, however, to appear before Governor Hay tomorrow morning and show cause why he should not be extradited.

The case dates back 13 months. Inspector Boles, of the Prudential Company, says that Veatch, while district manager at Cheyenne, wrote policies for Army officers stationed at Fort A. D.

BONES OF EIGHT FOUND

MISSING TEACHERS GIVEN UP AS DEAD IN WRECK DEBRIS.

Cause of Disaster on Pennsylvania Railroad Believed to Have Been Spreading of Rails.

EASTON, Pa., April 30.—As far as it is possible to ascertain here and at the scene of the accident, eight persons were burned to death, three fatally injured, two others so seriously injured that their lives are despaired of and scores of persons were cut, burned and bruised in the wreck of the teachers' special from Utica to Washington on the Belvidere-Gettysburg division of the Pennsylvania Railroad at Martins Creek, N. J., yesterday.

The line was reopened for traffic today. Bones of eight persons have been taken from the debris and the wrecking crew has quit work.

The missing, who are given up as dead, are Miss Beattie Walker, teacher, Miss Susan Sessions, friend of the teacher, Mrs. Mary Allen, Miss Sophia Knott, Miss Louise Lindeman, Miss Sarah Jones, all Utica teachers; Harry Wilmer, Trenton, N. J., baggage-master of the train, and James Bicknell, Philadelphia, tourist agent for the road.

Miss Eleanor Rutherford, a teacher in the Utica schools, died in the Eastern Hospital last night, as did also Walter Avner, of Trenton, N. J., engineer of the ill-fated train, and Charles Person, conductor of Stroudsburg, Pa.

Miss Augusta Lyte, of Utica, is in a critical condition in the hospital suffering from general burns and shock, and George W. Parsons, of Lambertville, N. J., fireman, is severely burned. Neither is expected to survive.

Officials of the railroad company are uncommunicative as to the cause of the wreck. It is the general belief that the rails spread and caused the train to leave the track and plunge over an embankment. Trackmen had been at work at the point of the disaster, and it is said the tracks were jacked up, but no signal was sent and that the engineer, believing he had a clear track, rushed into a death trap.

Of the 150 passengers, only a few now remain near the scene of the wreck, most of those able to travel having returned to Utica and Syracuse last night and today.

Fisher to Visit Oregon.

OREGONIAN NEWS BUREAU, Washington, April 30.—Representative LaFerty entertained the new Secretary of the Interior at supper at the New Willard last night. He strongly urged the merits of the Western extension of the Umattilla project as a "second North Yakima." He called attention to the fact that Oregon contributed \$5,000,000 more to the reclamation fund than it received, and pleaded for greater recognition. The Secretary listened attentively and promised a personal visit to that section as soon as his duties would permit.

Speer Deserted by Tovey.

DENVER, April 30.—Representative Lawrence M. Tovey, who joined the supporters of Robert W. Speer early last week, returned to his former allegiance today and voted with the anti-Speer faction in the joint ballot for United States Senator. The anti-Speer Democrats today cast the bulk of their votes for Charles R. Wad. The ballot follows: Democrats, Ward 30; Speer 26; Maupin 1; Martin 1; Thomas 1; Republicans, Roof 25; Absent, 15; Necessary to choice, 51.

CENSUS DATA FOR OREGON CITIES OUT

Great and Small Gains in Population Are Features of State Table.

TEN PLACES SHOW LOSS

Many Incorporated Towns Record Only Tiny Increases in Decade. Salem's Growth Largest Outside of Portland.

OREGONIAN NEWS BUREAU, Washington, April 30.—Notable increases in population are shown in the revised report of the census of Oregon cities and towns just completed by the Census Bureau, and 10 increases are also recorded. Outside of Portland the growth of Salem is the greatest, the capital city now housing 14,094 people, compared to 4253, its population when the census was taken in 1900. Fully as interesting are the slight increases in population in a decade shown by many cities. Astoria, in Umattilla County, gained only 43 since 1900; Baker, 75; Bay City, Tillamook County, 78; Beaver Hill, Coos County, 30; Copperfield, Baker County, 20; Dundee, Baker County, 17; Gervais, Marion County, 22; Mount Angel, 8; Ione, Morrow County, 16; Pendleton, Umattilla County, 54; Verona, Columbia County, 7; Warrenton, Clatsop County, 24, and Yamhill, Yamhill County, 71.

Among the cities for which loss of population is recorded are Adams, Grant County, 10; Butteville, Grant County, 10; Harney, Harney County, 10; John Day and Long Creek. The population dwindling of Butteville is the worst; the count in 1900 being 547 and only 49 10 years later.

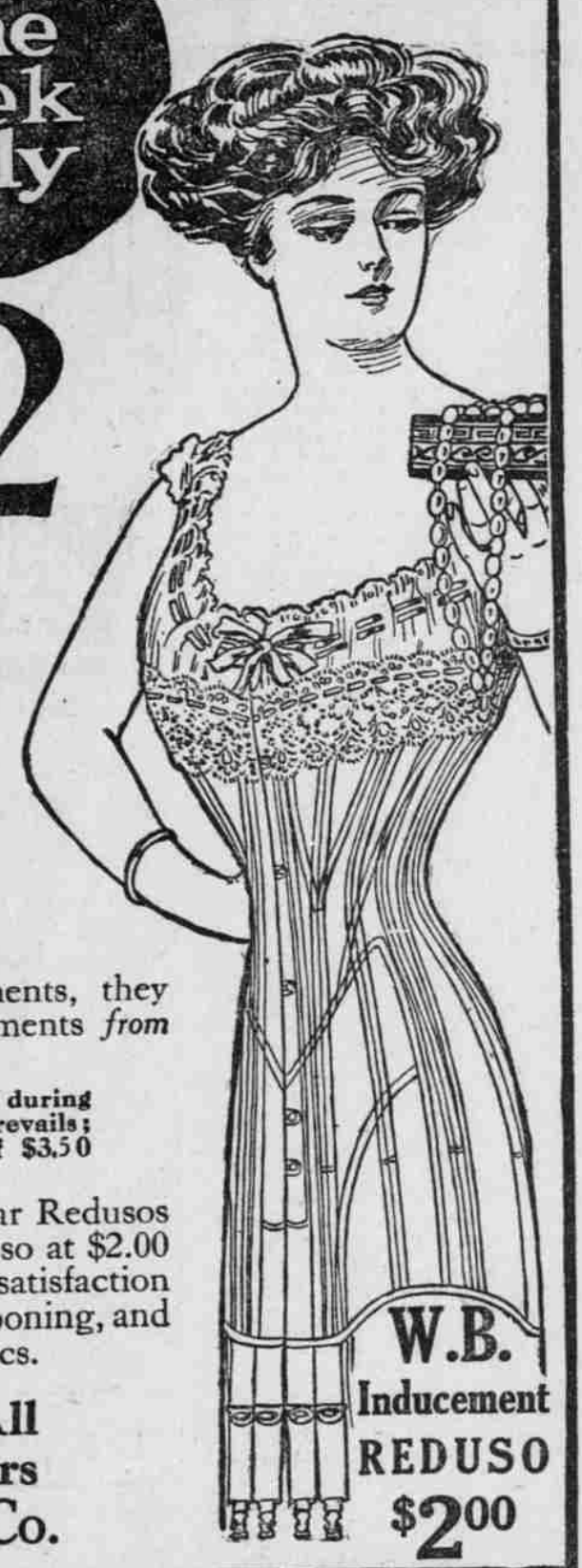

WHITE SLAVERS EXPOSED

Idaho Federal Grand Jury Will Probe Alleged Wholesale Traffic.

BOISE, Idaho, April 30.—(Special.)—A grand jury probe during the Pocatello term of the Federal Court will be the result of evidence in the hands of the District Attorney relating to an organization formed and operating extensively in Idaho, Utah, Oregon and Washington to lead women into lives of shame.

Sensational disclosures are expected next week in the examination of Quan Ha Ray, a Cooran, and C. C. Ostrander, an alleged procurer, who are charged with inducing women and girls who lived at Pocatello and nearby towns to go to Ogden, where they were placed on the "white slave" market.

The prisoners are said to have agreed to expose an organization that operated extensively in Salt Lake, Portland, Spokane and Wallace. The victims of procurers are taken, it is alleged, either to Salt Lake or Ogden, thence to the larger cities on the Coast, or they are released out of Salt Lake to Pocatello, thence to Baker and "farmed out" on the Pacific Slope.
