

PRUNES RAMMED IN DENSE SEA FOG

One Steamer Sinks, but 319 Passengers and Crew Are Taken to Safety.

OTHER SHIP KEEPS AFLOAT

Survivors of Accident to Merida Transferred to Admiral Farragut and Then to Hamilton, but First Named Vessel Sinks.

NORFOLK, Va., May 12.—A near-tragedy of the sea, filled with many thrilling narratives of human risk and escape, occurred off this coast early today, when the Ward line steamer Merida, bound from Havana, Cuba, for New York, with 319 souls on board, sank in 35 fathoms of water 55 miles northeast of Cape Charles, after she had been ramméd by the fruit steamer Admiral Farragut, bound from Philadelphia for Port Antonio.

Every person aboard the Merida was rescued and but one was seriously injured, the wife of A. Peon, a land proprietor of Progreso, Mexico, who, with his entire family, was bound for Paris to await the end of the Mexican troubles. Mrs. Peon was injured internally.

Collision Comes in Fog. The Merida was struck by the Admiral Farragut during a dense fog after a delightful voyage from Havana. In five hours the Merida was at the bottom of the ocean, but her passengers and crew were safely aboard her small destroyer.

The steamer Hamilton, bound from New York to Norfolk, was summoned by the Admiral Farragut by wireless and took aboard the rescued passengers and crew of the Merida. She landed them in Norfolk at 7 o'clock tonight.

Battleship Convoys Farragut. The Admiral Farragut, which carried but one passenger, proceeded for the breakwater under convoy of the United States battleship Iowa, which answered the wireless appeals for assistance. The Iowa was standing by the Farragut when the steamer Hamilton left with the rescued passengers and crew for Norfolk.

The Admiral Farragut, after ramméd the Merida several times, staggered away with a bad hole in her port bow, and was feared she might sink.

HENEY DOES NOT SUGGEST

Lawyer Confers With Wickersham About Willard Jones Case.

OREGONIAN NEWS BUREAU, Wash., May 12.—Before leaving Washington today, Francis J. Heney had a conference with Attorney-General Wickersham in reference to the latest application of Willard N. Jones, of Portland, as to imprisonment for failure of his sentence. Heney withheld a specific recommendation but defended his own course in selecting the Jones jury from nine counties, saying the proceeding was both legal and justifiable. He moreover denied that any effort was made by Government agents to see different before the jury were sworn. The general effect of his talk was derogatory rather than in the interest of Jones' appeal. The action has yet been taken by the President.

WOOD PROPOSES RESERVE

He Tells House How to Have 270,000 Soldiers Within Call.

WASHINGTON, May 12.—Disarmament of nations is a dream, declared Major-General Wood, Chief of Staff of the United States Army, before the House committee on military affairs today.

In opposing a change in the term of enlistment from three to five years, General Wood urged as an alternative his plan for the establishment of a permanent corps of regular soldiers who have been retired after three years of service.

He declared that the Army should be on a stronger basis, notwithstanding the persistent movement for disarmament and permanent peace through arbitration.

With the establishment of a reserve corps, there would be 270,000 men within call of the War Department within seven years.

EMPIRE FESTIVAL OPENS

King George Attends First of Coronation Ceremonies.

LONDON, May 12.—The Festival of Empire, a combination of an industrial exhibition with pageantry illustrative of the striking periods and episodes of the history of different parts of the British Empire, was opened at Crystal Palace today by King George and Queen Mary. It was the first public ceremony of their majesties since the court mourning for King Edward ended, and the first of a long series of functions which promise to make the coronation season memorable. The crowds lined the court as the exhibition passed. Whitehall Reid, the American Ambassador, participated in the opening ceremony.

PRUNE INDUSTRY IS HURT

Government Confiscates 19 Boxes Labeled "Oregon Pride."

OREGONIAN NEWS BUREAU, Washington, May 12.—The Oregon prune industry will get a black eye before the country if there are many more prosecutions under the pure food act similar to that held in the District of Columbia, in which 19 boxes bearing the label "Oregon Pride Brand Prunes, Fancy Oregon Prunes, Packed by Northwest Fruit Association—Albany, Or.," were confiscated.

Whenever there is a prosecution of this sort, Dr. Wiley, of the Department of Agriculture, puts the offending package on the official blacklist and sends broadcast a bulletin detailing the violation of the law, and giving names and dates. This is what Dr. Wiley's circular has to say about this particular shipment of Oregon prunes: "On or about August 4, 1910, there were offered for sale in the District of Columbia 19 boxes of prunes labeled as follows: Oregon Pride Brand Prunes, Fancy Oregon Prunes, Packed by Northwest Fruit Association—Albany, Or. Samples of this product were procured and examined by the Bureau of Chemistry, United States Department of Agriculture, and 15 per cent or more were found to be infested with worms crawling in the crevices, the remainder containing both excreta and sugar mites. As it appeared from the above examination and report thereon that the product was adulterated within the meaning of the food and drugs act of June 30, 1906, and liable to seizure under section 10 of the act, the Secretary of Agriculture reported the facts to the United States Attorney for the District of Columbia.

His attitude, he finally explained, was guided by humanitarian motives. Four hundred soldiers, thirty hungry, and with no possible chance of victory over an army that numbered nearly 1000 were saved, in his opinion, from a pitiful fate by the surrender.

It is explained in defense of General Navarro that he was unable to maintain his outer trenches because he did not wish to fire into American territory, the insurrectos entering the town with the American line behind them.

General Navarro, it is declared, thought his only chance for battle was well within the town and in his fortifications. The insurrectos, soon however, cut off the water and food supply, and the federal soldiers began to suffer from the second day's fighting when the insurrectos were throwing bombs and setting fire to the frame buildings.
