

# GRADUATES FROLIC ON CAMPUS

### Tug-of-War and Pretty Flower Parade Make Merry Day at Oregon "U."

### DIPLOMAS GIVEN TODAY

#### At Regents' Meeting, Resignation of Dr. A. J. Giesey From Medical School Is Accepted—Portland Boy Wins Prize.

UNIVERSITY OF OREGON, Eugene, Or., June 20.—(Special.)—So full and varied was the commencement programme today that the gay-bedecked heads of proud parents and dotting aunts were troubled considerably in an effort to keep pace with the friskier and more pleasurable movements of their younger contemporaries. Reunion and reception events followed in quick succession and when dusk had advanced it seemed that the real activities were just beginning.

#### Sisters Lead Flower Procession.

At 7:30 o'clock this evening a beautifully executed flower and fern procession paraded along the winding paths of the campus quadrangle. The procession was led by two sisters, Mrs. C. M. Collier ('80), and Miss Mary McCormack ('82), the oldest graduates present. They bore large bouquets of Shasta daisies and extended first welcome on the approach of the 1911 graduates, who carried natural ferns and red rambler roses. This pretty custom was instituted several years ago by Luella Clay Carson, formerly dean of women at the University of Oregon, but now president of Mills College.

#### New Regents at First Meeting.

The five newly-appointed university regents attended their first board meeting today. They are: Governor West, Secretary of State O'Neil and Superintendent of Public Instruction Alderman, whose membership was created by recent legislative enactment, designating them as the regents of Education, and Regents A. C. Dixon and Charles H. Fisher, both of Eugene, who were regularly appointed by the Governor on April 15. They were present with the exception of Senator Miller.

#### Dr. Giesey Resigns.

The resignation of Dr. A. J. Giesey from the medical school faculty in Portland on account of ill health was accepted upon the reluctant recommendation of the medical department. He was today made emeritus professor of clinical gynecology. Dean Joseph's report further recommends two faculty additions, several curriculum changes, and a provision whereby medical graduates will hereafter be required to come to Eugene to receive their diplomas. The change is advocated by the Portland branch because "it is fitting" and because "it will serve to link more closely the university with the medical department." It will involve the lengthening of the medical school year from seven and one-half months to eight months.

#### Sanitary Department Asked.

The establishment of a department of sanitary science is also being fostered by the administration, which holds that the increase of commonwealth efficiency is the central purpose of university work and that this efficiency is dependent most of all upon the vitality of the people. The contemplated department is to embrace all branches of personal and public hygiene, school hygiene and inspection; a study of the sources of infection; research concerning the construction of sewers and water supply systems; and advocacy of pure-food standards and sanitary housing arrangements; and a general furtherance of the spirit of eugenics.

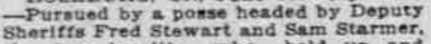
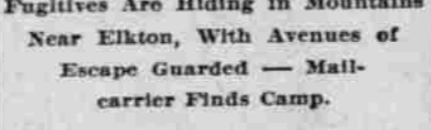

robbed the mail car of the "Shasta Limited" near Yoncalla late Friday night hiding in the mountain districts in the vicinity of Elkton. The officers declare that escape is impossible and are confident that the outlaws will be captured tomorrow. Picking up a fresh scent near Skelly early yesterday, the Penitentiary bloodhounds in charge of Guard Miles led the posse in a westerly direction for about 15 miles before they halted. Investigation revealed human tracks and an hour later the hounds again caught the scent and continued hot on the trail for three miles, when the posse stopped for the night.

#### Mail Driver Finds Camp.

Early this morning the posse again took up the pursuit of the fugitives and late today are said to be near where the bandits are supposed to be hiding. A mail driver between Elkton and Scottsburg reported late today the discovery of a camp on his route which had been abandoned only a few hours before. The bloodhounds are leading the posse in that direction and the officers believe that the outlaws are only a few hours in the lead. Unless the men are thoroughly acquainted with the mountain districts, there are only two routes by which they can get out of the Leon Lake region. Both avenues are closely guarded by Sheriff Gage, of Coos County, and his deputies, and escape appears improbable.

#### Loot May Total \$1000.

Postoffice Inspector Morse, who has in his possession a quantity of stolen loot, said today that he believed the outlaws secured money aggregating at least \$1000. Twenty-nine registered letters, many of which contained money, were overlooked by the robbers and were forwarded to the Postoffice officials at Spokane today. Many of the packages containing jewelry and other articles of value were simply ripped open, the contents mutilated, and cast aside.

#### From the manner in which the contents of the sacks were examined the Postoffice inspector believes that the robbers are amateurs and have had little experience in holding up trains.

It is Mr. Morse's opinion that most of the money secured by the bandits was found in the pouch consigned to San Francisco. In this pouch, he says, there might have been a substantial remittance to one of the San Francisco depositors.
