

HOPKINS IN DARK AS TO 'JACKPOTS'

Man Whom Lorimer Defeated In Position of Man Sand-bagged in Crowd.

WITNESS IS NOT SPECIFIC

"Lorimer Great Organizer," Is Answer to Question as to Illinois Senator's Popularity Among Democrats.

WASHINGTON, June 23.—"Jackpots" or corruption funds in the Illinois Legislature constitute one of the traditions of politics in Illinois, according to the testimony of ex-Senator Hopkins before the Lorimer investigating committee of the Senate. Mr. Lorimer succeeded Mr. Hopkins in the Senate.

Whether any of the jackpot funds or other corruption funds had been used to defeat him for Senator, he was unable to tell the committee of his own knowledge. He explained, however, that he would be the last man to know of such corrupt practices because he was at the time of the election of a Senator "in the position of a man in a crowd knocked down with a bludgeon, who knew no more about it than the crowd, but was hurt worse than it."

Nearly every phase of the Lorimer case was gone into when Mr. Hopkins was on the stand. He declined to answer specific questions as to whether he suspected Lorimer was using corrupt methods to defeat him, or as to whether or not he believed certain members of the Legislature had been bought.

Mr. Haney, counsel for Lorimer, protested against the witness leaving the stand without expressing an opinion on the rumor that 25 Democrats who voted for Lorimer on the last ballot received money.

"Cloud" Not Lifted.

"It leaves a cloud on those men," insisted the counsel. "He did not require the witness to answer."

Judge Haney attempted to get the witness to admit that Lorimer had always been popular with the Democratic party and had repeatedly carried a Democratic district.

"I knew he was a great organizer," was as far as the witness would go. Hopkins told how he had spent headquarters in Springfield and how he had tried to keep his forces in line the day Lorimer was elected. He told of the defections of Representative Lawrence and others.

Hopkins said he heard that two other members he was going to lose were Logan and Durfee. Both of them had been at his hall at 11 o'clock the night before the election, the witness explained.

"And ate my apples and smoked my cigars," Mr. Hopkins added.

"Ats your what?" inquired Senator Gamble.

Apples Kept at Headquarters.

"My apples; I kept a barrel of apples." "Where did they go after they left your room?"

"My friends told me they went to Senator Lorimer's room."

"Was there anything in the apples or cigars that might have made the change over night?" inquired Senator Kenyon.

"Think not. They were the same brand I had used for five months."

Mr. Hancock, in relating what Mr. Funk had told him, said he did not distinguish the words used by Mr. Funk in the conversation. The effect of it was, however, that Mr. Hines had asked Mr. Funk to contribute to meet the expenses of Mr. Lorimer's election.

When cross-examined by Judge Hines, of Lorimer's counsel, Mr. Hancock said he had not denied recollection that Mr. Funk used the word "expenses," but said it might have been "costs."

Mr. Hancock told of Mr. Funk's asking his advice as to whether he should make public the alleged request. This was during the consideration of the Lorimer case by the Illinois Senate.

"I told him that it was a matter of his conscience," said Mr. Hancock. He added that he told Mr. Funk it probably would result in hostility to the company of which they were officers.

Judge Hines asked who was expected to take the attack, and the witness replied that Lorimer and his friends were feared, because they were in conflict with those who opposed them.

ARCTIC HERO DIES

Captain D. H. Jarvis, Life-saver, Commits Suicide.

TRIP TO CLUB ENDS LIFE

After Reading Portion of Kipling's "The City of Dreadful Night" Famous Alaska Pioneer Shoots Self in Seattle Clubroom.

SEATTLE, Wash., June 23.—Captain David H. Jarvis, formerly of the revenue cutter service, who won fame and a gold medal from Congress for a heroic rescue of Arctic whalers, and who was for many years the active head of the Morgan-Guggenheim enterprises in Alaska, shot and killed himself today in a room in the Seattle Athletic Club. On an envelope found on a desk at which he had been reading he had written in a trembling hand, "Tired and worn out."

Before he shot himself he had been reading a book of Kipling's short stories, and he had laid down the open book at a point about half way through "The City of Dreadful Night," Captain Jarvis in his 49 years of life had been a tremendous worker, and he had used himself up by his labors. This is the explanation of the suicide which his friends give. He apparently went from his home to the club for the purpose of ending his life.

David H. Jarvis was born in Berlin, Maryland, August 24, 1862, and entered the revenue cutter service at New Bedford, Mass., in 1883. As lieutenant in command of the revenue cutter Bear, he organized and led the overland relief expedition to the starving whalers at Point Barrow in 1897-98. After sailing as far North as the ice would permit, Lieutenant Jarvis organized a land

expedition to the six imprisoned vessels. The expedition traveled 1800 miles into a wild and unknown country, bringing succor to the sailors who were suffering from lack of food, shelter and security. In recognition of his bravery, Congress voted Captain Jarvis a gold medal bearing his profile in bas relief. On April 2, 1899, Captain Jarvis was married to Miss Ethel Taylor, a niece of Hettie Green. He subsequently resigned from the revenue cutter service.

Captain Jarvis became identified with the corporations which have since been the Morgan-Guggenheim syndicate.

DOCTOR MOB'S VICTIM

PROSSER CITIZENS TAR AND FEATHER W. S. MOORE.

Physician Charged With Crime Seized and Anointed and Told to Get Out of Town.

SPOKANE, Wash., June 23.—(Special.) Dr. Warren S. Moore, who is under heavy bond awaiting trial at Prosser, Wash., on a charge of committing a crime against Alta Highfill, daughter of E. T. Highfill, City Marshal, was today tarred and feathered by a number of Prosser citizens.

Before Police Justice J. G. Boyle, of Prosser, who was trying a case against Highfill, Moore was told that he should be placed under bond to keep the peace. Moore testified that while he was about to leave with his father for Malheur, he was seized by several citizens and, after being shot through the arm by one of them, he was taken to the L. X. L. livery barn and given a coat of tar and feathers and one week in which to settle up his business here and leave town.

In the trial above referred to, Marshal Highfill was placed under \$200 bond to keep the peace on the complaint made by Dr. Moore, and also was placed under an additional bond of \$500 on a complaint made by the doctor's father, Dr. W. H. G. Moore, of Malheur, whom it appeared in the trial had been compelled, at the point of a gun held in his hands, to leave his son at the mercy of the enraged citizens.

MORMONS GLAD OF HAVEMEYER'S AID

Promotion of Beet Sugar Enterprises Held Beneficial to People.

CHURCH RULES BUSINESS

Ex-Bishop Tells How Consumers Paid Price Based on Freight, Although Commodity Was Not Transported.

WASHINGTON, June 23.—That the Mormon Church in soliciting the aid of Henry O. Havemeyer to extend its beet sugar industries was seeking solely the welfare of its people was declared today by Thomas R. Cutler, vice-president of the Utah-Idaho Sugar Refining Company, before the House sugar trust investigating committee.

Mr. Cutler discussed freely the business policy of the church, and was frank in revealing details of dealings with Mr. Havemeyer.

The sugar committee also examined Chester S. Morey, president of the Great Western Sugar Refining Company, of Denver, a combination embracing 16 Colorado beet sugar factories in which the American Sugar Refining Company has acquired a half interest.

Trust Interests Widespread.

The committee has thus far disclosed the American Sugar Refining Company interests in the Michigan beet sugar industry, the Utah beet sugar factories and the Colorado group of factories and from John D. Spreckels, of California, who will arrive tomorrow, it expects to show that the corporation has influential interests in the factories of that state.

Before Mr. Cutler concluded his testimony he was examined at length as to the business purposes of the Mormon Church.

"Why does the Mormon Church go into the sugar business and other business enterprises?" asked Representative Hinds, of Maine.

"Anything that affects the material as well as the spiritual welfare of its people, the Mormon Church encourages," said Mr. Cutler. "It provides occupations for the people in many other lines of business, as well as in the beet sugar industry."

Church in Business, Also.

"Then the Mormon Church," queried Representative Madison, of Kansas, "is not only a spiritual organization, but also a business organization?"

"To a great extent that is true," Mr. Cutler replied.

"The Mormon Church now owns stock in the Union Pacific Railroad?" Mr. Madison asked.

"I doubt it; I wish it did."

"Well, the president of the church owns Union Pacific stock at least," Mr. Madison continued. "And not only as a matter of encouraging thrift, but as a cold-blooded business proposition, it owns interests in irrigation companies, agricultural enterprises, woolen and sugar factories and other industries, does it not?"

"To a certain extent. It would have to carry on business enterprises that way, or they would fail."

Bishop Is Business Manager.

Mr. Cutler explained that the business enterprises of the church are managed by the presiding bishop who acts as business manager. Questioned regarding the tariff, Mr. Cutler said that "how for free trade" in sugar was being made by the cane refineries and that it would ruin the beet sugar business.

In discussing sugar prices in the West, Mr. Cutler said the price of sugar for Utah, Wyoming and the Intermountain territory was fixed by the Pacific Coast price list determined daily at San Francisco, based upon Hamburg price and the local conditions.

"Do you follow those prices?" asked Chairman Hardwick.

"Yes, we have to follow them."

"From whom do you get those prices?"

"From the Western Sugar Refining Company and the California & Hawaiian Sugar Company. We make our price list the freight rate from San Francisco for the local and less 20 cents, the differential between cane and beet sugar."

Freight Charge Is Added.

"Then in Utah, Idaho and that territory you charge the consumer the freight, although the sugar doesn't travel the distance?" asked Mr. Hardwick.

"Yes, that's the way all the prices of commodities must be fixed."

At the time the deal was made whereby Mr. Havemeyer bought one-half of the original Utah Sugar Company before the concentration and formation of the Utah-Idaho Sugar Refining Company, Mr. Cutler said he had acted as the agent of his own people and did not consider himself as an agent of Mr. Havemeyer. After that Mr. Havemeyer, he said, left the management entirely to the wisdom of the western men.

tative Madison said, "Is that every-one seems to think Henry O. Havemeyer was a masterful man, yet no one was willing to follow his advice."

Mr. Cutler said he remembered a letter he once received from Havemeyer relating to the sugar market, in which he thought it would be a good time to unload, in view of the tremendous Cuban crop and that the market price might go very high or it might go very low.

Now, what would I gather from such a letter as that?" Mr. Cutler exclaimed. "Absolutely nothing."

President Smith Starts East.

SALT LAKE CITY, June 23.—Without waiting for a subpoena to appear before the House committee investigating the sugar business, Joseph F. Smith, president of the Mormon Church, and also of the Utah-Idaho Sugar Company, started for Washington today. With him was Bishop Nibley, another officer of the sugar company.

8000 BIBLES IN PARADE

DEMONSTRATION IS FEATURE AT SAN FRANCISCO.

Methodist Official Declares That Evangelical Churches Are Facing Grave Problem.

SAN FRANCISCO, June 23.—A parade of men, estimated at 5000 in number, each bearing a Bible, tonight formed the most spectacular feature of today's session of the International Sunday School Association convention. One section of the parade consisted of Civil War veterans, the parade was reviewed by women delegates and by the convention officials, in addition to thousands of assembled spectators.

Among the important features of the day's session was the report of W. C. Pearce, superintendent of the adult department. The report says that the past triennial has been one of continuous progress in adult Bible-class work.

In a paper on "The Ten Years—An Asset and an Opportunity," Dr. Edgar B. Clark, assistant corresponding secretary of the Board of Sunday Schools of the Methodist Episcopal Church, said:

"The evangelical churches of America are facing a very serious situation. The six leading denominations showed a net increase of only 284,000 members in the year 1910. This represents the combined efforts of more than 160,000 churches and 17,000,000 church members. Each net gain of one represents the work of 41 church members and the cash outlay of more than \$650."

The speaker said that unless there was a change for the better the church sooner or later would face the problem of extinction.

WOODMEN CHANGE RATES

Special Session of Head Camp Will Consider Subject.

BUFFALO, June 23.—The head camp of the Modern Woodmen of America in executive session here today, acted favorably upon the recommendation of the law committee that a special session be held for consideration of changes in the rates.

Chicago was named as the place and the first Tuesday in January, 1912, as the date for the special session of the head camp.
