

HOW HINES HE HELPED LORIMER

Accounting so Lax Corporation Man Has No Trace of \$100,000 Checks.

GREAT SUMS "FORGOTTEN"

Packing House Manager and Banker Connected With So Many Concerns He Cannot Remember Names of All of Them.

WASHINGTON, June 28.—His method of bookkeeping and his loyalty to the Democratic party alike were under fire today, when Edward Tilden, bank director, packing-house manager and corporation man generally, appeared before the Senate Lorimer committee to testify that he was no way interested in the raising of a fund to elect Mr. Lorimer to the Senate.

Attorneys for the committee, attorneys for Senator Lorimer and members of the committee itself asked Mr. Tilden in every conceivable style of question whether he had anything to do or knew of anyone who had anything to do with the raising of a fund to elect Senator Lorimer, either before or after the election.

To each question the witness declared with emphasis that he did not.

List Too Long to Remember.

Tilden was subjected to an examination as to his relations to corporations. He mentioned that he was president of the National Packing Company and added the names of five other Chicago corporations of which he was president, besides being the head of concerns in other cities. He was "confused" when asked by Senator Keaton to tell how many corporations he was president, "because of the many concerns."

He "thought" he was director of banks in Sioux City, Ia., St. Joseph, Mo., and San Francisco, and he gave a long list of banks in which he was stockholder, but forgot until nearly at the end of his testimony to mention a bank in East St. Louis, Illinois, as treasurer or in some other capacity, he testified, he had the right to draw checks on the bank accounts of "25 or 30 corporations."

Accounts Loosely Kept.

The witness testified that he did not keep accurate books of his personal business—merely loose-leaf summaries of checks written instead of check stubs. Senator Kern had the witness describe in minute detail his personal bookkeeping. The witness said he was not proud of his system, but that it answered the purpose, namely, that of keeping track of money until he was paid. He said he had a check for \$100,000 for personal expense might not be entered in his personal accounts, he said, and he "might or might not be able to tell, for instance, in 1908, whether he had lent or paid anyone \$100,000."

"We might be able to tell if we all went at it," he added, "but such a big salary to run the business of the corporation and I know a great deal less about my own affairs than those of the company."

Books Not Called For.

The committee did not ask Mr. Tilden to produce his bank books for inspection. The committee told him "for the present and possibly for all time" it was through with examination of him.

Knowledge of Fund Denied.

Rush Culver, lumberman, lawyer and Mayor of LaSalle, Mich., began by contradicting Edward Hines' testimony at Springfield, saying that he had never seen Hines since Lorimer's election to the Senate, and continuing to deny that Hines ever had told him that he cost a "barrel of money" to elect Lorimer.

"He introduced me to Lorimer, then a Congressman, and said he might be the next Senator from Illinois," declared the witness.

"Did you ever hear of the use of money in the Lorimer election?" asked Hines.

"Yes," responded McLeod.

"Where?"

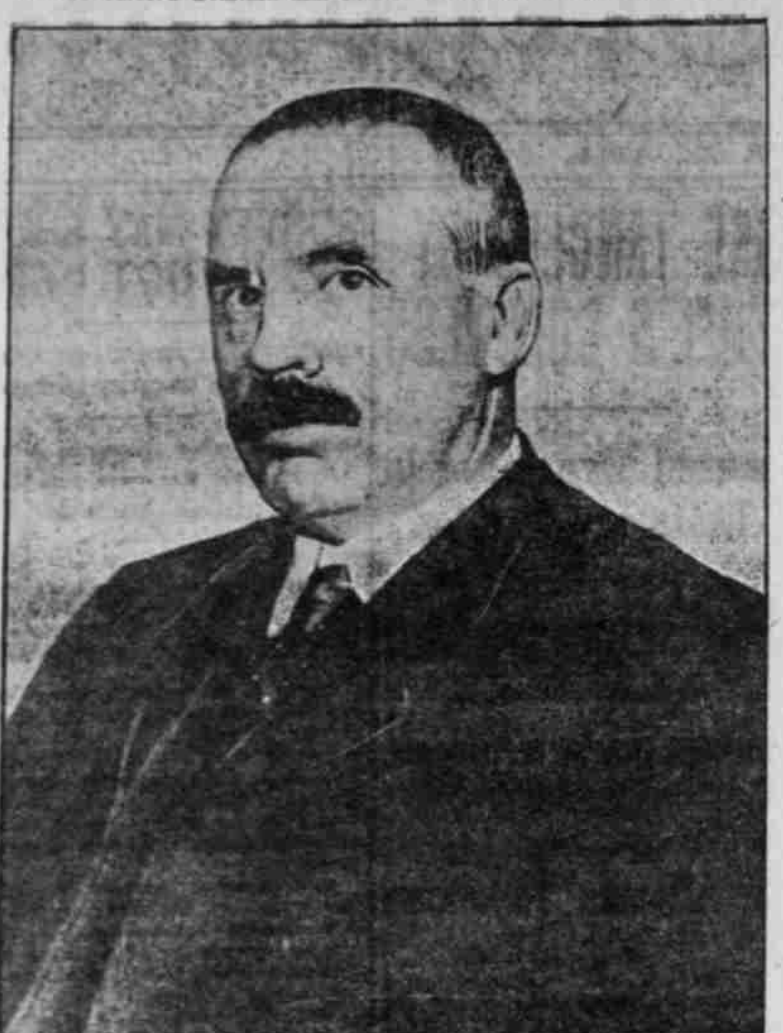
Seal Killing Declared Feasible.

OREGON GAINS ONE

Reapportionment Bill Gives State 3 Representatives.

WASHINGTON ALLOWED 5

Senate May Not Act on Measure Until Winter, but It Is Expected to Become Law in Time for Elections in 1912.

OREGONIAN NEWS BUREAU, Washington, June 28.—The Congressional reapportionment bill that will be formally reported to the Senate next week will, if it becomes law, give Oregon three Representatives in Congress, Washington Ave, Idaho two, Montana two and California 11.

This is an increase of one each in Oregon, Idaho and Montana, two in Washington and three in California. No arrangements have yet been made for the consideration of this bill in the Senate and it is quite probable that it will be ordered to the floor at the regular session next winter. In some form or other it is expected to pass the Senate and become a law in time to permit of the election of the additional Representatives in November, 1912.

Senators Not Enthusiastic.

In states where Legislatures have not or do not provide for redistricting Representatives will be elected at large, so that no states will be deprived of the increased representation authorized by Congress.

Thus far there is comparatively little enthusiasm among Senators over the passage of the House bill as it has minor objections, there being quite a general sentiment that the size of the House should not be increased. However, many Senators are inclined to accept the view of the committee that it is a matter which prominently concerns the House and in the end it is expected that the House bill, providing for 433 members of the House, will be finally passed.

If the bill does not pass the Senate at the special session it probably will be given early consideration next session. The President will be sent to the President for approval by the end of this calendar year. Meanwhile there will be ample time to permit of the nomination of new electors, either at the primaries or the conventions next Spring.

La Follette Objects to Increase.

The purpose of adopting the measure increasing the House by 42 members over the present House was to prevent a decrease of the membership of the Senate committee present at a meeting today, Senators LaFollette, Dupont and McLean, voted in approval of the increase, the other seven decided to allow the House to have its way in a matter so peculiarly pertaining to its own affairs.

The report will be withheld a week to give Mr. LaFollette time to prepare a minority report, which will be presented by Senator Bailey.

(Continued from First Page.) Intimidated in any manner. I had her in my arms all the time."

At the remembrance McManigal broke into sobs and when he could control himself he said bitterly: "Her mind had been poisoned by the slick guys on the other side. I would give my life for that woman if it would do her any good, but not for the others."

Note Is Asked For.

McManigal said that when his wife first visited him in the County Jail last Saturday, shortly after her arrival in this city, she told him she had wanted 15 minutes to talk to him.

"She wanted me to write a note to Clarence S. Darrow, the attorney for the McNamara case," said Mr. Darrow, "I want to see you," continued McManigal.

"She told me that unless I did so I would never see her again. That broke me all up, and I commenced to cry. Under that influence I wrote the note. Later, I returned to my cell and thought it over. Then I wrote another note, repudiating the first and absolutely refusing to see Darrow or any other person on the other side."

McManigal said he had not been promised immunity or reward of any kind by the prosecution. He declared his wife had been subject to nervous prostration for years and so accounted for her fainting and hysterical condition yesterday in the grand jury courtroom.

McManigal Quits Talk.

He started to continue his talk about her swoon, but suddenly checked himself, saying: "I'm afraid to talk too much; I might give evidence."

McManigal said he had not been subjected to any "third degree" treatment and that he had been kindly and uniformly treated throughout his incarceration.

"Why, while I was in custody in Chicago I played ball in the alleys with the officers," he said. "I climbed telegraph poles for exercise and was allowed to walk in the parks. I even had a glass of beer."

McManigal appeared without coat or vest and with his shirt open at the neck, and throughout the interview puffed steadily on a cigar. He looked in good health and invited his interviewers to call upon him again.

Contempt proceedings were begun today against Mrs. McManigal because of her refusal to answer what the prosecution declares were pertinent questions when she appeared before the grand jury yesterday.

The questions will be read in open court Saturday to determine if she should answer them. If they are declared pertinent she will be given another opportunity to answer and if said by the prosecution to face a jail sentence if she refuses.

BRIDGE MEN PAID OFF

BROADWAY WORK CONTINUES DESPITE STRIKE.

Few Discontented Leave After Obtaining Their Money—Kansas City Gang May Be Hired.

Except that a few of the old men accepted their pay checks and removed their apparel from the scene of operations, there was no change in the strike situation at the Broadway bridge yesterday, the company continuing operations with sandhogs available, who numbered less than the strength required for one shift. More of the strikers are to report today to be paid and it is not improbable that some of them will return to work.

Representatives of the Union Bridge & Construction Company telegraphed to President Stewart, at Kansas City, last evening regarding the status of the strike. It is believed Mr. Stewart will assemble another force of sandhogs there and hurry them to the city, to proceed under present conditions means that there will be greater expense entailed in keeping the pressure plant going than the number of men at work warrants and unless outsiders are sent here it is feared that the building of the bridge foundations will be retarded seriously.

The company has granted an advance of 25 cents a day but the men insist on from 50 to 75 cents additional and that can only be passed on by executives of the corporation at Kansas City, as President Stewart was not asked for the raise when he was in the city last week.

TREAT REQUIRED UNJUST TO FARMER

Cummins and Borah Criticize Reciprocity Agreement as "Betrayal of Trust."

Taft's Stand Repudiated

Bristow Says President Does Not Represent Republican Party in Crusade for Free Trade in Agricultural Products.

WASHINGTON, June 28.—Beginning with Senator Cummins' attack today on the reciprocity measure, legislators turned to the agricultural interests of the country, and concluding with Senator Borah's denunciation as a Republican betrayal of the farming interests, the Senate debate was all antagonistic to the agreement and critical of the President and his methods. The Senate gave only partial attention to the speeches, although they were among the most important that will be made against the bill. Several times a call of the Senate was demanded. Senator Nelson, of Minnesota, finally proposed that as little attention was given to the subject, the Senate take a recess until November or December.

President Called Usurper.

Senator Cummins, who will continue his speech tomorrow, attacked not only the construction of the reciprocity agreement itself, which he said put the whole burden of free trade upon the farmer without giving him any benefit in the way of reduction of duty on manufactured products, but he also criticized the power exercised by the President to negotiate it and to bring it to the point of a definite agreement between the two countries.

In doing this, Cummins said, the President had usurped the powers of Congress and had exceeded the power lodged in him to deal with foreign nations upon revenue questions. If a reciprocity agreement were to be made with Canada, he said, the original proposal should have come from Congress, instead of through Presidential advances, which had brought the agreement to a point where Congress was asked to ratify it. It could not be changed or amended.

Farmer Is Excluded.

"I know that the day has come for the farmer," declared Senator Cummins, "to be excluded from the benefits of the protective tariff. The farmer has been written; it needs only to be signed. It needs only to begin, to exclude him from the company of the manufacturers of the United States."

Senator Borah's criticism was based on the record of the Republican party as the advocate of protection for the Western farmer. He quoted from Republican platform campaigns, resolutions, campaign arguments and definitions of policy, to show that the abolition of the protection on farm products was a betrayal of the Republican party. Senator Borah said both political parties were now striving for the vote of the cities and the support of the press.

Party Authority Attacked.

"Instead of saying both political parties, you should say the Democratic and the Administration," interjected Senator Bristow. "I am not willing to concede that President Taft in the crusade in which he is now engaged for free trade in agricultural products represents the Republican party. He does not represent the majority of the Republican members of the House or Senate and I believe he does not represent the sentiment of the majority of the Republicans of the country."

"The Administration now in control," said Senator Borah, "came into power on a pledge to protect the farmer. The time was when the farmer was not disputed with in this chamber, that such legislation as this was destructive of his prosperity. This is a Republican in the Senate was his attorney. Now, because he calls in a New York attorney to present his case before the finance committee, he is accused of being the friend and companion of the trusts and the big interests."

Borah Charges Betrayal.

Senator Borah said the establishment of free trade in agricultural products was either a denial of the principles for which the Republican party had heretofore stood, or "coarse and brutal betrayal of the most loyal constituency the party organization has ever had."

"No page in political history can equal the betrayal by the Republican party of this great and loyal constituency," he said.

Senator Borah said he sympathized with the press in its desire for relief from the oppressive combination that is said to control the production of agricultural products.

"The attempt to 'settle the trust question at the customs-house,'" he declared that action against a paper trust, if it existed, should be by civil and not criminal procedure in the courts.

WOMAN SUES ORCHARDISTS

Rogue River Company Accused of Seeking Arrest Falsely.

SAN FRANCISCO, June 28.—(Special.)—Mrs. Carrie T. Randall, formerly employed by the Rogue River Valley Orchard Company, today brought suit for \$10,000 damages against the company in the Superior Court, alleging that she employed a false agent to seek her arrest for embezzlement.

She declares in her complaint that in October, 1910, the officers of the company represented to her that they were prosecuting Attorney of Alameda County, that she had embezzled \$400 and sought to have her arrested. She was arrested, and "coarse and brutal" treatment was administered. She should not be prosecuted, but in the hearing the case against her was dismissed for lack of evidence.

to prevent or eliminate such pollution the good grace and will of many small communities have to be depended upon. Concerted action by such communities is hard to obtain, and in some cases, almost a hopeless task. There are several reasons for this. Various communities seldom agree as to the amount of pollution they are responsible for.

Temptation Is Great.

"It is true that the temptation to discharge raw sewage into the large watercourses is great. We can only remedy this with difficulty. A reasonable line must be drawn somewhere. The trade wastes of our large industries have to be discharged. Many of the trade wastes can be purified but partially.

"We have therefore to confine ourselves to trying to keep the large common drinking reservoirs, such as are represented by the Great Lakes, in a good, wholesome condition. The introduction of the purification of sewage is an educational task, much more so than the purification of a water supply.

"You can demonstrate to the people in a community that the death rates are high, and that the water supply is responsible for it. The people will fight for a pure water supply and get it frequently. They will fight for clean water by physical inspection, except it be for a mineral sediment and a growth of algae at the bottom."

Raw sewage may actually purify itself during storage prolonged for weeks, to a state where it is impossible to detect its presence in the water by physical inspection, except it be for a mineral sediment and a growth of algae at the bottom.
