

Alaska Cannery Fire Loss Alleged to Be Misrepresented.

Misropresentation in submitting the proofs of losses resulting from the burning of a cannety at Nushagak, Alaska, is charged against the officers of the Alaska-Portland Packers' Asso-clation by four insurance companies that wrote insurance on the property that was destroyed. This charge that was destroyed. This charge against the packers' organization was made by the insurance companies in answers that were yesterday filed in the United States Court responsive to the complaint of the packers in a suit to compel the payment of the insur-

The interested insurance companies re: Agricultural Insurance Company, are: Globe & Rutgers Insurance Company Svea Fire Insurance Company and the National Union Fire Insurance Com-pany, of Pittaburg. F. M. Warren, of this city, is president of the packers' association.

It is contended also by the insurance companies that the packers already have collected from other insurance companies \$125,000 insurance, which, companies \$125,000 insurance, which, it is alloged, in itself is in excess of the value of the property destroyed. In resisting the payment of further in-surance, the protesting companies in their answers set out that the plain-tiffs asserted they were ignorant of the cause of the fire when they actual-ly had knowledge that it was caused by the smoking of their employes: represented that the total insurance was only \$155,141, when it was \$250.-

represented that the total insurance was only \$152,141, when it was \$250, 000; placed the loss of supplies at \$21, 659, when it did not exceed \$10,000; valued the salmon at \$120,482, when it was not worth more than \$100,000, and the loss was only \$20,000.


