They are Lleutenant Governor Sweetser, Faul Chagstone and Steven D. Taylor, State Auditor. The elimination of Allshie, it is believed, will bring out numerous other can-didates.

Withdrawat Is Announced.

Judge Allahie made the announce-

ment of his decision in an open letter. If a says in part: "I regret that I am not able to see my way clear to announce that I will be a candidate for Governor. I have considered the question very veriously and have reached the definite conclu-sion that I will not be a candidate for the nomination for Governor at the 1912 primary.

'It is a distinct honor to any man It is a distinct nonor to any man to be the chief executive of this com-monwealth; it is equally as great an honor to be held deserving and worthy by the people to serve them in that high office, and I am much gratified at these expressions of commeridation at these expressions of commencements and confidence, coming as they do from citizens of the state I have been mor-ing during the last nine years. These considerations, however, admonish me that the duties at hand are as important and grave and the necessity of their falthful discharge is as vital to the people as are the duties of the Governor of the state.

Sacks are marked, but the consumer who purchases small quantities is ig-norant of the real quality of the prod-

uct. The State Dairy and Focd Commis-sion has been led to this step by the efforts of the Federal authorities to stop the sale of inferior rice through the method of polishing, which is not only injurious but lessens the food value of the rice as well. A circular letter prepared by Commissioner Bailey, directs that all rice which is coated with glucose or tale must be labeled on the package, "Coated with Glucose and Tale. Wash Before Us-ing."

"It is not the proportions of glucose and tale that are inductous to health as much as what is taken away from the rice before those are applied that robs the grain of its nutraive value," said E. T. Judd, of the Commissioner's office yesterday. "Uncoated rice is rice which has been polished and the rice meal removed, but without the applica-tion of glucose and tale."

BOISE, Idaho, Sept. 31 .--- (Special.)-To marry and classify the act as purely a business transaction to collect a \$200 debt proved disastrous for Alice M. Montgomery, an entrywoman, who attempted to hold a 160-acre homestead, consisting of valuable land.




