If we do not want to lose the tonfidence of the people we should let the other commission alone and proceed to a conclusion with our work."

City Auditor Barbur and R. W. Montague sought to smooth out the mild justification that had broken within the committee, but only with partial

committee, but only with partial members of the commission in session. In assuming that the motives of the other commission, as well as the members of the committee representing the City Council were bad, were ting in a manner unworthy of themselves.
"We should not get scared before we get into the battle," counseled City Auditor Barbur, "There is a demand Auditor Barbur. There is a commission government, and we owe it to them to meet with the other commission and use if we cannot unite on one charter to be submitted. We should hold the conference and stand by our guns, and

of we are unable to get together, we will still have our charter and can then go before the people with it."

The discussion was started when Chairman Clark reported the result of a conference between subcommittees, representing the two clarter commissions, and representatives of the City Council, earlier in the day, when it was agreed that a conference should be held by the two charter bodies. The debate terminated without the Commission taking any vote as to whether or not it would take part in the proposed conference, although a majority of the members clearly indicated their intention of doing so. Lane Alone In Opposition

Another tempest was started when Mr. Montagne, responsive to a suggestion from Councilman Baker, proposed a metion instructing Chairman Clark to advise the Council that the Commission (East Side) was ready to receive official recognition from the Council. "Interest of all California now centers upon the coming Panama-Pacific Exposition." said Mr. Hornick. "Up to the present time the chief work has been that of perfecting our organization of committees to handle the big exposition. From the breaking of the ground in the ceremonies Saturday, however, the work will become actually cogstructive. Our fair grounds will differ from those of any previous exposition, in that they occupy the whole city, so to speak. We are planning to put in \$5,000,000 worth of permanent buildings that shall become the property of the city after the exposition. This will include the buildings of the 'civic center,' the auditorium, art gallery and other public buildings. "Grounds have not been allotted to any exhibitors as yet. When the sites are apportioned, however, I think that Oregon probably will be given a preference, owing to her having put in the earliest application and to the earnest assistance she gave in the campaign to secure the exposition for San Francisco." whole city, so to speak.
