

SPECTER OF WIFE TORTURE TO BRIDE

Millionaire Makes Life Unbearable to Chorus Girl He Courted Madly.

TWAIN GLAD TO SEPARATE

Mrs. Helen Louise Dodge Wants Her Experience to Be Warning to Girls About to Marry Rich Men They Do Not Love.

NEW YORK, Oct. 20.—(Special.)—Mrs. Helen Louise Dodge, who has brought a suit in Philadelphia against her millionaire husband, Walter Phelps Dodge, declared today that life with a widower who constantly brings up the specter of former wife is unbearable. No one, she said, can realize, without actual experience, the awful torture that it becomes.

The Dodos were married in London early last year, after Mrs. Dodge, who then was a chorus girl, had yielded unwillingly to the importunate pleadings of her millionaire suitor. Now she says that there is complete accord between them on the subject of a legal separation. His father has threatened to disinherit him if he did leave her, and she wanted to be rid of him. So, she said, both were pleased.

"I wish my experience might be a guide to other girls who contemplate marrying rich men whom they do not love," she said. "I wish they all might see it as I have come to see it: I am sure they would not do it. No money would induce me to marry a man like my husband if I knew what I know now."

Specter Haunts Honeymoon.

"The way he tortured me with his dead wife—the second one," Mrs. Dodge continued, "was almost beyond belief, even in our honeymoon. He used to start up suddenly, while his face would turn ghastly and his eyes stare horribly, and then he would cry out that he saw the spirit of Edith standing near me. Sometimes he would insist that she was walking just outside the window, or was making the bells ring in the house. One morning he awoke to tell me that he was worn out because all night long he had been watching the ghost of Edith standing over me and had to keep awake to protect me from her."

"His little daughter, Rosemary, sided with me; otherwise I do not know how I would have lived. One day I went into our cabin on the steamer, where Walter was playing with Rosemary. He put me out, and said, laughingly, that when he was engaged in playing with his child I must keep away. But little Rosemary followed me out and said she loved me just the same. "Six months of this kind of life, tortured constantly by his habit of invoking the spirit of his dead wife, Edith, made me feel as if liberty would be cheap at any price."

Both Glad to Separate.

"I do not love to marry him. I think I have learned a lesson that every girl, on the stage and off, should profit by. Now that his father has made it plain to me that he would prefer a divorce to the endless pleasure of torturing me, our way has been made. We are going to separate and we are both glad. Mrs. Dodge's mother said that Dodge had besieged her daughter after being introduced by a mutual friend. "There were days when Mr. Dodge would ask her several times to marry him and after pleading with her at her home would take his dismissal and go down town and call her up on the telephone and ask her to renew his pleading," she said. "He would call evenings and stay until 11 o'clock. I had made it a rule that my daughters should not have company after that hour. He would keep calling her up on the phone until she had to quit answering the ring to get any rest at all. He wanted her to marry him and take a wedding trip to Europe, but she put him off. Then he went to London and called her a proposal from there, and she yielded and took a steamer and they were married over there."

"Say to girls who have a chance to marry rich men whom they do not love," was Mrs. Dodge's parting advice, "that they must—tell them not to do it, that's all."

DIVA GIVES VIEWS

Cavallieri, Expecting Divorce, Soon, Talks of Marriage.

STAGE IS ACTOR'S PLACE

Unhappy Wife of William E. Chanler Declares Artists Should Not Wed Outside of Their Profession.

PARIS, Oct. 20.—(Special.)—Mme. Lina Cavallieri, the prima donna, who expects to get her divorce from William E. Chanler, of New York, within a week or 10 days, declares that actresses should not marry out of their profession. Also, she says that to insure domestic happiness, husband and wife should belong to the same race. "I do not say this because Mr. Chanler is an American and I am an Italian," she adds.

Not only does the diva hope to get her longed-for freedom from Chanler very soon, but she expects that New Yorker to pay over to her the sum of \$75,000. When she gets the divorce and the \$75,000 they will part good friends, she says. "I have been a year without singing," said Mme. Cavallieri Chanler. "London and Moscow pay me \$10,000 a night. New York pays more. I was promised a sum of money by Mr. Chanler when I married him. He assured me an income of \$20,000 a year. I have not seen a cent. But all I ask is that my husband pay me \$75,000, which he prevented me from earning."

"I regret that I was married. An actress should not marry, except with very good reasons. When both are artists, I have nothing to say. Some such are very happy. They have the same view of life, the same pleasures and enjoy the same leisure hours. An actress cannot live happily with a mere society man, the butcher, the baker, the candlestick-maker, or with anyone else except an actor. "I love my art. I did not realize how necessary it was to me. I cannot breathe any air freely except that of the theater. I could not abandon the stage for home-life; I could not cease to be Thais, Herodias or Manon, just to be Mrs. Chanler. HUNTING CALLED LARCENY

Government Asserts Ownership of Wild Game in Park.

HELENA, Mont., Oct. 20.—Claiming as Government property the animals in National parks, the United States Government has brought charges of larceny against Thomas Shields and Archibald Patterson. The men were charged with killing an elk and a deer in the Glacier National Park. This is said to be the first time the Government has ever definitely asserted ownership of wild game.

JUSTICE COURTS REMAIN

Los Angeles Jurist Holds Amendment Must Not Do Mischief.

LOS ANGELES, Oct. 20.—Judge Willis, of the Superior Court, handed down

a decision today declaring that constitutional amendment No. 12, approved at the special election October 16, did not abolish Justice Courts.

In ruling that the Justice Courts of the state still exist, Judge Willis said that where there were two interpretations of any measure it was his duty to follow the one which would not work mischief. He declared that it was not intended by the law or the constitutional amendment that any complete system should be replaced by any incomplete system. He held that the term "inferior courts" used in the amendment meant "Justice Courts" and asserted that the amendment merely gave the Legislature the power to establish more of such tribunals as it saw fit.

To rule otherwise, he said, would mean to abolish more than 2000 of what he called the "poor man's courts." The issue will be taken to the Supreme Court.

HILL IS GLAD TO CANCEL

Great Northern Willing to Take Back Big Ore Measures.

ST. PAUL, Oct. 20.—James J. Hill, chairman of the Great Northern Railroad, made it plain today that if the United States Steel Corporation wants to cancel its lease of the Great Northern ore properties in Minnesota, it is welcome to do so. On his return from Washington he was asked: "Do you think that the United States Steel Corporation can afford to let up on the Great Northern property?" "The issue will be taken to the Supreme Court."

"If they can afford to do so, we certainly can," he replied. "If the Steel Corporation wants to cancel its lease, that is its privilege. There is there—the stuff to make steel of."

"Outside of our properties, the Steel Corporation has not enough ore to run it for 25 years."

REGIMENT HEAD CHANGES

Colonel Jackson to Succeed Van Piete at Fort Lawton.

Jackson, Twenty-sixth Infantry, has been relieved of command of that regiment at Detroit and assigned to take command of the Twenty-fifth Infantry, with headquarters Fort Lawton, Wash. Colonel Robert C. VanPiete, now at Fort Lawton, is relieved of command of the Twenty-fifth Infantry. He has yet been issued assigning him elsewhere.

First Lieutenant Martin Novak, of the Twenty-fourth Infantry, is promoted to captain and assigned to the Twenty-fifth Infantry. The regimental commander will designate the company he is to command.

NEW STATES WELCOMED

Texas City on Border, Holds Jubilee for Its Neighbors.

EL PASO, Tex., Oct. 20.—A military parade and formal exercises of welcome to Arizona and New Mexico were features today of El Paso's statehood jubilee, which is being attended by thousands from all parts of the Southwest. The formal ceremonies will be held at Port Bliss.

Governor Colquitt, of Texas, extended the welcome and Governor Sloan, of Arizona, and Governor Mills, of New Mexico, responded and accepted the handsome silk flag, the gift of El Paso.

WEST TO GET MAN BACK

O. Andrew Jackson, Who Violated Parole, Will Return to Oregon.

SACRAMENTO, Oct. 20.—The regulation of the Governor of Oregon for the return of O. Andrew Jackson, who is wanted for having violated his parole and is under arrest in Los Angeles, was honored by Governor Johnson today.

After breaking his parole Jackson went to Los Angeles, where he was arrested for having attempted to pass a bogus check.
