



Says Roosevelt's Attitude Is All Advertising.

> Bird S. From my information its present success is largely due to its escape from wildcat business ventures and Socialistic tendencies that have re-tarded other Coast states.

It is believed that his Administration would be one to win confidence and that the unrest and unsettled condi-tions of the past few terms would dis-appear.


