WASHINGTON, Jan. 17.—The Interior Department and the Forest Service were attacked in general debate in the Fenate today by Senator Borah of Idaho, who advocated a general remodelling and liberalizing of the homestead land

laws.

Mr. Borah suggested reducing from five to three years the time after satering before proving up, and that settlers be allowed to leave their homesteads to earn a living while complying with the law as to residence.

He said there was frequently a delay of from 10 to 12 years in getting title to homesteads on reclamation lands, often compelling settlers to abandon their land. Mr. Borah contended that settlers in the National forwere at the mercy of the forest
