VERDICT FOR \$1500 RETURNED.—In the suit of the St. Johns Lumber Company against G. J. Leavitt, returned yesterday Judge Wolverton discharged all the Jurymen for the term except those on duty. Judge Brien is expected to return from California on February 18 to hold jury trials and previous to that time another venire will be asked for as the grand jury will be in session and a number of cases pending have been set for dates during February and March.

Because they overslept on one occasion and lost their nerve on another, Paul Young and H. Wolf, prisoners at the City Jail, failed to hold up the bank of Ashley & Rumlind, at Second and Stark streets, said Young, in giving his testimony in the Municipal Court yesterday. The prisoner is only 17 years old, while his companion is mature and a Socialist agitator.

Wolf worked upon the boy, he says, by inveighing against the conditions which made it useless for a man to try to make an honest living. The lad, whose parents live in St. Johns, had been lodging with a brother at First and Market streets. He fell in with Wolf and became a convert to his industrial ideas. Wolf then proposed, he said, that they rob the bank, and they pooled their money to buy a revolver. Young was to go in first, ask for a check cashed and then present the weapon, commanding all those in the bank to lie down on the floor. Wolf was then to take up all the money in sight, and flee, leaving Young to cover his escape and back out later.

The coup was to have been made Saturday, but the conspirators were asleep until too late. Yesterday they were to have carried it out, but Young became frightened. The Patrolman Cameron arrested him for carrying a concealed weapon, and his statements led to the arrest of Wolf.

The older prisoner was defended in the Municipal Court by a soap-box orator who was a candidate for Municipal Judge at the last election. The court ruled that the future defendants who are not attorneys will not be allowed to plead cases. Wolf was sentenced to serve six months, and was turned over to the Juvenile Court.

Nearly 200 men and 400 boys are now registered in Bible study classes of the Portland Young Men's Christian Association. This is the largest enrollment in Bible study in the history of the Y. M. C. A., and in this particular the Portland association is surpassed by few in the country.

Tonight is the regular Bible study night at the association, nine classes being scheduled to meet. Besides these there are several classes meeting on Sundays and Fridays and the special course of lectures that are being conducted by Dr. John H. Boyd, pastor of the First Presbyterian Church, on Saturday noon.

Seven new Bible classes are to be organized next week. One of these will meet on Monday at 7 o'clock, one on Tuesday at 4, a third on Friday at 7, and four on Wednesday at 7.

This summary shows that only two associations have larger enrollment in Bible study than has the Portland Y. M. C. A., and that it is tied with Cleveland, Ohio.
