## Act Forbidding Consigning of Liquor Daughter of Pioneer Salem Family to "Dry" Zones Favored:

Officers of the Oregon Anti-Saloon League have joined with other temper-ance organizations throughout the country in an appeal to Congress for the enactment of the Kenyon-Sheppard bill. This measure makes it unawful to transport intoxicating liquors from one state or territory in the United States or under its jurisdiction into another state or territory when such liquors are designed to be used in any other district by the consignee violation of the law of that particu-

lar mate or territory.

The purpose of the proposed legisla tion is to prevent the shipment and importation of liquor into any state or territory where local option or Prohibition statutes have been enacted. In a recent decision, the United States Supreme Court held that liquor was a amodity and as such could shipped into communities or states rerdiess of the statutes prevailing in

Each member of Oregon's delegation Each member of Oregon's delegation in Congress has been requested to support this measure in a letter that has been forwarded by J. P. Burke, super-intendent and attorney for the Anti-Saloon League in this state.

## Washington Governor, Asked About

Sentiment, Extols President.

OLYMPIA, Wash, Feb. 20.—(Spe-al.)—William B. McKinley, director f the National Taft Bureau, today sent a telegram to Governor Hay asking him to express an opinion con-cerning the sentiment in Washington. In reply Governor Hay said that attempts of state administrations to in-fluence votes was "repugnant to good citizenship" and therefore he has refrained from entering into the Prestdential nomination controversy. Personally, he says, the United States, in his opinion, will make greater progresg under President Taft than any other and that Taft "has proved an even stronger and abler Executive than Mr. Roosevelt promised the American people he would make when he so earnestly indersed him in 1908." Governor Hay says President Taft has caused many of the policies of his "Illustrious predecessor" to be enact-ed into laws and that for his part he does not believe in "awapping horses" in midstream. Therefore, he concludes, he believes it is the duty of every progressive Republican to work for the renomination and re-election of President Taft.

WEATHER CONDITIONS.

The Alaskan storm appears to have passed rapidly eastward, and its path was too far north to cause any material atmospherio disturbance over the Pacific Northwest. The southern Rocky Mountains' disturbance has meved to Louisians and has increased greating in the Lower Mississippi Valley, and precipitation from the Southern Rockies to the Ohio Valley, snow falling as far south as Central Texas. Precipitation has also occurred on the North Atlantic Coast, in British Columbia, Western Washington, Western Orsgon and Northern California. High winds were reported from Oklahoma, a maximum velocity of 63 miles an hour from the north having occurred at Oklahoma City. The weather is colder in Central Washington, and from the Rocky Mountains eastward except in Colorade and along the Gulf and Atlantic coasts. It is colder in New Mexico, 30 degrees colder in Central and Northern Texas, and 24 degrees colder in Oklahoma.
