

MEMBERS NAMED BY MAYOR OF DIFFERENT OPINIONS AS TO FORM OF DOCUMENT.

AGREEMENT MAY BE HARD

Newly Appointed Committee Express Themselves Anxious to City's Needs.

With a wide diversification of ideas as to what form of charter, providing commission government for Portland should be placed before the people for adoption or rejection at the next general election, members of the committee appointed by Mayor Rushlight to attempt to harmonize the various views as expressed in the charter committee's report to the city council, members of the committee have difficulty uniting on any form of charter.

Idea, as expressed by the members of the committee yesterday, show that there are as many different opinions as there are members of the committee. Each member seems to have deep-rooted views which a commission charter efficient.

Members Are Hopeful. Despite this wide divergence of opinion, there seems to be a general feeling that it will be able to get together and harmonize their views into one general charter, so that the people can have an opportunity to have their say on the subject.

The charter as it stands now, said Mr. Woodward, "has been adjudicated by the courts until it is bombproof as regards litigation. Therefore, it is not to be tampered with to use to readjust the present charter to fit the needs for a commission charter. The committee appointed by the mayor represents a wide diversification of ideas."

It is my opinion that the voter should be given a charter amendment containing the rudiments of a commission form of government and should be presented with the extraneous issues in the form of separate amendments. The voter should not be asked to take a number of wholly unsatisfactory propositions along with the rudiments of commission government merely to get that form of government adopted.

"The commission, I think, should be given power to institute such a commission form of government, to issue municipal improvement bonds in small denominations to the people of the city and to establish municipal works and industries to secure employment for the unemployed."
