

14 DEMOCRATIC PARTY MAY LOSE RIGHTS 25 Per Cent Vote for Representative Required for Use of Direct Primary Law.

LEADERS URGE INTEREST

With No Candidates in First and Third Congressional Districts Fear Is That Organization May Not Exist as Political Party.

Seriously thinking Democrats are beginning to realize that the wholesale practice of nominating their party in the Republican primaries, coupled with a constantly increasing Socialist vote, will eventually deprive the Democratic party of the privilege of nominating candidates under the provisions of the direct primary law.

When registering as Republicans, Democrats are contributing materially to the disorganization of their party. The ranks of the Democratic party are being further depleted by donations to the Socialist cause. Between these two demoralizing influences leading Democrats are becoming discouraged and are taking steps to preserve their party organization, but to recruit its membership as well.

One section of the direct primary law defines a political party as "an affiliation of electors representing a political party or organization, which, at the next general election, will be polled for its candidate for Representative in Congress at least 25 per cent of the entire vote cast for that office in the state. Every such political party shall nominate all its candidates for public office under the provisions of this law and not in any other manner."

In other words, when the Democrats fail to cast 25 per cent of the total vote cast for Representative in Congress, it will cease to be a political party, as recognized in the direct primary, and no longer can nominate its candidates in that manner. Although the time for the next general election is not until March 23, the Democrats to date are without candidates for Representative in the First and Third (Multnomah County) Congressional Districts in the absence of candidates for these offices, by which the identity of a political party is measured by the direct primary law, there will not be a general election in the next general election next fall.

It is true that the Democrats in the last general election cast 22 per cent of the total vote polled for candidates for Representative in Congress, but that was two years ago and there were interesting contests in both congressional districts. In the First District the Democratic candidate received 18,232 votes, against 25,112 cast for the Republican. Prohibition and Socialist candidates. The Democratic nominee in the Second District polled 15,472, as compared to 28,533 for the candidates of the other three parties.

Democratic Registration Low. Registration figures in Multnomah County to date are particularly disappointing to Democratic leaders, who have done everything within their power to stimulate party loyalty and insure a full and honest registration of Democrats under the Democratic banner. The figures show that the ratio of Republicans and Democrats that have registered is about five and one-half to one, the same ratio as prevailing in the other counties. It is known that hundreds of Democrats registered as Republicans and took part in the Republican primaries.

The total registration for the primary election in September, 1910, was as follows: Republicans, 28,197; Democrats, 5,001; Prohibition, 259; Socialist, 418; Independent, 574. In 1911, the party record not given, 521. Registration for the April primary this year will not close until April 3, but the total by that date is believed to be: Republicans, 21,511; Democrats, 2,906; scattering, 1,495; total, 25,912.
