

CLERK ASSERTS HE GAVE PENDER MAIL

Unopened Paper Found in Cabin of Wehrman Adds to Weight of Testimony.

HAMMER IS RULED OUT

Judge Says Defendant Was in Jail When Implement Was Found on Property — Bench Warrant Out for Sheriff Stevens.

ST. HELENS, Or., June 6.—(Special.)—Features of today's session of the Pender murder trial were the testimony of Guy Whitney, a clerk in the post-office at Seaside, that he delivered to the defendant on September 4 the paper found unopened in the Wehrman cabin; the issuing of a bench warrant by Judge Campbell to compel the attendance of Sheriff Stevens, of Multnomah County, who had failed to respond to a subpoena; a ruling out of evidence by Judge Campbell of the hammer presumed to be Pender's, which was found in the Riley and Hesson cabin; and the demand of Attorney Logan, of the defense, to know of Detective Levings if Levings had not suggested flight to Pender previous to his arrest and had not offered at that time to loan the defendant \$10. Levings made denial.

Court adjourned nearly an hour ahead of the regular time this afternoon because Sheriff Stevens, after being informed by telephone that the judge had ordered the bench warrant, failed to report. Judge Campbell gave instructions to Sheriff Thompson to have Sheriff Stevens in court at 9:30 A. M. tomorrow.

Clerk to Be Summoned. Mary Adams, who last September was a clerk in the store of Watts & Price, in Seaside, in which the postoffice is located, also is to be summoned to the prosecution to testify as to whether or not she waited on Pender at the postoffice window September 4. The defense has striven throughout to leave the impression that probably she did. The prosecution discovered today that this witness is in Portland. N. E. King, an expert from Portland today testified that the bullets which killed Mrs. Wehrman and her baby were fired from the 35-caliber pistol which the state contends was stolen from and returned to the Riley and Hesson cabin. The ruling out of the hammer is acknowledged to be a severe blow to the state, as it would have supplied the necessary link. The testimony given yesterday by Riley and Hesson was responsible for Judge Campbell's action. He recalled that Pender was in jail at the time it was discovered by the investigators and could not be responsible for the hammer having found its way back to his premises.

Although Sheriff Thompson was allowed, without objection from the defense, to say that Riley had said that Pender owned and handled the hammer, then gone to the defendant's place and returned with it, Attorney Logan objected to permitting Detective Levings to testify similarly and was sustained. Riley had declared that Levings had said Pender might be the owner of the hammer and that it was on Levings' suggestion that he went across the road to Pender's place to search for it. Levings and Thompson have testified that Sheriff Stevens was with them when the implement was found and it is on this point that the state particularly desires the testimony of the Multnomah County official.

On cross-examination Guy Whitney admitted in answer to impeaching questions that he had told Mr. and Mrs. G. H. Snitzer, relatives of the defendant, and others that he did not give Pender the mail on September 4, but he was none the less positive in his statements today.

COAST OVERLOOKS CHANCE

Opportunities Go Begging in Latin-America, Says ex-Consul.

Members of the Progressive Business Men's Club yesterday attended a luncheon at the Multnomah Hotel. Addresses were made by ex-Consul Newell and Judge Basier, of Grants Pass. Next Monday the club will have as its luncheon guest Dr. David Starr Jordan, of Leland Stanford, Jr., University. Mr. Newell spoke of commerce in the Latin American republics. He told of the wealth in these countries and of the opportunities which are going begging.

Portland and the whole Pacific Coast, he said, were running a grave risk of losing a golden opportunity, which would come with the opening of the Panama Canal. At present it is almost entirely English and European money which is responsible for the rapid development of Argentina and other states. As a result, trade with European countries is increasing, while exports from the United States to South America show a decrease in the last few years.

SUIT FOR DAMAGES LOST

C. G. Sandstone Shown to Have Been Aggressor in Fight.

A damage suit for \$10,000 brought by C. G. Sandstone against Antone Webber as a result of a fight in which the plaintiff was badly beaten, was decided in favor of Webber by a jury in the Circuit Court yesterday. Sandstone alleged that he was permanently injured by Webber, his collar bone being broken and his arm and leg being badly wrenched and lacerated. It was shown by the attorneys for Webber that Sandstone was the aggressor in the fight and that Webber administered the beating after Sandstone had started trouble. The jury was out 15 minutes.

The first echo of the case was heard some time ago when Webber pleaded guilty in the Circuit Court to a charge of assault and battery. He was paroled on this count.

FLOWERS SHOWER GIRLS

Fair Tourists Will Speak for Suffrage Cause in East.

As the train bearing the eight young women, who are to tour the East under the management of the Pacific Northwest, a farm journal, steamed out of the Portland station yesterday, showers of roses and rose petals filled the air, the platform and the train. They were the final tribute from members of the College Equal Suffrage League, members of which were at the station to see good-bye. The car occupied by the young women was decorated with rose bouquets were given to each of the girls and the aisle was carpeted with rose petals.

Each of the girls wore buttons marked "Votes for Women," each of them is pledged to speak for universal suffrage at the National Convention, at the White House and on other occasions.

FEDERAL INTEREST IN DARROW SHOW

Defense Makes Point of Fact That Franklin Confessed First to Lawler.

BURNS' WORK DENOUNCED

Prosecution Disavows Connection With Efforts of Detective to Implicate Gompers, Laying Blame on Defense.

LOS ANGELES, June 6.—Bert H. Franklin testified today on cross-examination in the trial of Clarence S. Darrow for alleged bribery that he had made his first confession of guilt at the office of and in the presence of Oscar Lawler, special government prosecutor in the dynamite conspiracy investigation; that he had first been approached with a view to getting him to turn state's evidence by a deputy United States Marshal and that later he had applied for employment to the Merchants' and Manufacturers' Association, which took a prominent part in the McNamara prosecution.

At the conclusion of Franklin's cross-examination today members of the defense declared better progress had been made with the case during the day than at any time since Franklin took the stand ten days ago. Re-direct examination by Assistant District Attorney Ford was then begun and may not be concluded before tomorrow's adjournment.

Rogers Denounces Burns.

Franklin was on the stand all day, but his ordeal at the hands of Chief Counsel Rogers, for the defense, was broken several times by verbal controversies between opposing counsel, one of which included a denunciation of William J. Burns by Rogers.

In connection with his attack on Burns Rogers accused the prosecution of attempting to strike at Samuel Gompers, president of the American Federation of Labor, and declared that one of the Burns detectives who had been in attendance at every session of the trial had sought to reach the ears of a juror with remarks made while seated in the section occupied by members of the press. The latter charge caused an hour's recess for the purpose of investigation, at the conclusion of which the detective was exonerated by Rogers in open court.

Detectives Name Involved.

Rogers' denunciation of Burns grew out of continual objections by the prosecution to the plying of Franklin with questions concerning his negotiations with the District Attorney. He had asked the witness if he had not, after making his confession, in which the names of Burns and Gompers were used, been told to bring Gompers' name into his testimony whenever the opportunity arose.

The District Attorney insisted that Burns had nothing to do with the prosecution and that no one sought to implicate Gompers in the Darrow trial.

"Burns men are concerned in every detail of this case," retorted the defense, "even to hounding our witnesses and watching our office and distorting our places. No man could truthfully say that William J. Burns' men, employed by the National Erector's Association, were not behind this case in every particular."

District Attorney Fredericks said that no one had sought to implicate Gompers in the present case, a statement which brought Rogers to his feet.

Anti-Gompers Feeling Charged.

"It is a matter of common knowledge," he declared, dramatically, "that the United States in this district, through Oscar Lawler, and in other districts, has made a strenuous effort to connect Mr. Gompers and to bring his name in, and it is a matter of common knowledge right from the evidence in this case that the Federal Grand Jury at Indianapolis sent for this checkbook; it came into this court from Indianapolis, where his own investigators were charged with the investigation of these other charges. It is our contention that this prosecution against Darrow is but a step against Gompers. Mr. Burns is announcing everywhere that he is going to get Gompers if he can, through Darrow."

The prosecution took vigorous exception to these utterances.

"If Burns has anything against Mr. Gompers and is following Mr. Gompers, that is his business, not ours," said District Attorney Fredericks. "We have no charges to prefer here against Mr. Gompers in any way, shape or form, and if Mr. Darrow, as this witness has said, had not mentioned the name of Gompers and if it had not been brought out on cross-examination of this witness, the name of Gompers would never have been mentioned in this case."

Prosecution Denies Alibi.

"Oscar Lawler may be the attorney for the National Government, investigating some of these cases, and the lines may cross, and there may be information passed back and forth, but there is absolutely no effort to drag anyone in here, and when counsel make that statement it is misconduct."

Counsel for the defense laid much emphasis on Franklin's claim to the office of the Merchants' and Manufacturers' Association, officials of which organization Rogers designated as friends of the Darrow prosecution. Franklin said that he had gone there seeking employment after he had made his confession to the district attorney and that the men he met there were all old friends.
