

HIGH WIND STORM IN INLAND EMPIRE

Dust Hurricane Does Damage, Estimated to Be Large, to Fruit Crop.

GRAIN ESCAPES UNHURT

Tempest Hits Lakes, Overturning Houseboats; Roofs Are Blown Off and Wires Are Down. Ignorant People Panicky.

SPOKANE, Wash., June 21.—(Special.)—The most peculiar and at times alarming dust storm, assuming occasionally the velocity of a gale, blew through the Inland Empire late yesterday. The sky grew dark, everything was enveloped in a haze, and electric lights were turned on an hour earlier than usual.

There were even some ignorant people who thought the end of the world had come. While shade trees, shrubbery, telegraph poles and wires were prostrate in hundreds of localities and the property damage must be large, the most serious damage seems to have been done on Lake Coeur d'Alene, where houseboats on the lake were either blown away or sunk, and it is feared that there has been loss of life. From Kennewick on the west to Idaho, on the east, the storm played havoc with growing fruit, but the damage is not so severe because it thinned out the fruit and saved the orchards the work later on. Roofs of houses have been blown off in a score of localities and outbuildings demolished, but, strangely, all of the reports coming to Spokane say that no damage seems to have been done grain in the fields.

ROGUE RIVER APPLES HELPED

Rainfall Will Increase Crop 100 Cars, Other Fruits in Proportion.

MEDFORD, Or., June 21.—(Special.)—That the rain Thursday will add 100 cars of apples to the fruit crop of the Rogue River Valley was the statement of Professor P. J. O'Garra, county pathologist, tonight. "The conditions for apples have been good all season," said the professor, "but this rain has made them ideal. It came at the best possible time and insures the marketing of practically all the fruit set at the present time. Instead of 450 cars, I make the prediction there will be 550 cars and with the pears and small fruit, 800 cars will be a conservative estimate for this section. Medford will also ship out hundreds of bushels of potatoes and the hay crop will be the largest in history. From an agricultural viewpoint conditions never looked brighter in Southern Oregon."

COUNTY PROBE BACKED UP

Pomona Grange Would Continue Investigation in Multnomah.

GRESHAM, Or., June 21.—(Special.)—A report from the committee appointed by Governor West to investigate the financial transactions of Multnomah County for the last six years was the principal feature of the quarterly meeting of Multnomah County Grange Wednesday. The county investigation was instigated by Pomona Grange about a year ago and yesterday's report by A. F. Miller, one of the committee, revealed the intention of the committee and the Governor to finish the work in spite of all opposition or adverse criticism. Some complaint had been made of the cost and attempts were made to have the investigation stopped, but it was hinted that interesting disclosures had determined the Governor to back up his committee by assurances that the work would proceed to a finish, at which time a full statement will be published of its findings. The matter of requiring the treasurer of the Oregon State Grange to pay a fair rate of interest on all day balances in his possession was referred to a committee to make a report at the next session at Orient, in September.

STEAMER IS IN ICE PACK

Steel Vessel Edith, Bound for Nome, Unable to Move Wheel.

NOME, Alaska, June 21.—The steel steamship Edith, which sailed from Seattle June 6 for Nome with a cargo of livestock, provisions and coal, is fast in an ice pack 45 miles southeast of St. Lawrence Island, 200 miles from Nome. Wireless messages from the big freighter said the vessel was so tightly gripped by the ice that she was unable to turn her wheel. A heavy fog was hanging over the ice field. The Edith is the first steamship to report trouble with the ice in Bering Sea this summer, the passenger liners Victoria and Senator, which came through ahead of her, encountering no difficulty.

VANCOUVER GRADUATES 31

Address to Students Made by Professor Todd, of Willamette.

VANCOUVER, Wash., June 21.—(Special.)—Thirty-one students of the Vancouver High School, 21 girls and 10 boys, the largest class in the history of the school, were graduated last night, appropriate services being held in the auditorium of the school. Professor E. H. Todd, D. D., of Willamette University, delivered the commencement address. The salutatory was given by Frances Price and the valedictory by Herschel Smith. This makes about 250 alumni of this school.

BOY BUYS KISSES \$2 EACH

Youth Who Entangled "The Hut" Causes Arrests at Cliff Inn.

"Once bitten, twice shy" would not seem to apply in the case of one Cecil Brackman, 17 years of age. Wednesday night he was having such a big time at the Hut that the proprietor and two waiters were arrested for selling him liquor. Last night Deputy Sheriff Harry Bulger, with R. Phillips and P. Hunter, arrested H. L. Flanders and J. P. Roth, joint proprietors of the Cliff Inn, on the Linnton road, for

supplying the same misguided youth with liquor. "The makes the third road house we have been after in three nights," said Deputy Sheriff Bulger, "which is not a bad record. We are going after them hot and strong, and mean to make a genuine clean up before we are through."

For selling liquor to the Brackman boy until he became drunk, "Bully" Swaggert, proprietor, and Joe De Grouchy and H. H. McDonald, waiters at The Hut, a new roadhouse on the Linnton road, were fined \$250 each in Justice Bell's court yesterday.

It appears that the court inadvertently exceeded its authority in imposing the fines, as the Justice Court, except in specific instances, of which this is not one, have jurisdiction only when the penalty is below \$100 or 90 days. Notice of appeal was given, and the defendants are under aggregate bond of \$1500.

Brackman, whose parents live in Seattle and who is attending a military school here, was allowed to have a high time at the roadhouse. He said he bought kisses from the women present at the rate of 45 apiece, though sometimes he was able to grab a few bargains at the low rate of 50 cents. Funds for the carouse were provided by a check for \$40, drawn on his father.

In imposing sentence Justice Bell scored the defendants severely. It is probable that new proceedings will be required, looking to the indictment of the defendants and their trial in the Circuit Court, which alone has jurisdiction, it is believed.

INQUIRY TO BE WATCHED

TAPLINE SITUATION INTERESTS PORTLAND LUMBERMEN.

Interstate Commerce Commission to Probe Practice Railways in Quoting Rates.

Notice received here Thursday that the Interstate Commerce Commission, under date of June 5, has ordered an investigation of tapline or spurline conditions in the lumber districts of Minnesota, Arkansas, Louisiana, Texas and Mississippi, has raised the fear among Portland lumber dealers and manufacturers that decisions might cause a reduction in freight rates from those states to the markets to the detriment of Northwestern lumber competition. It is likely, for that reason, that the lumbermen will send attorneys to the hearing of the Commission to protect Western interests.

The tapline cases, as they have been known, have grown out of the practices of railroad companies quoting rates from lumber camps to the markets and collecting charges on that basis. Under this system the railway companies have in the past allowed the owners of spurlines or taplines to haul the cars from the mills to the lines of the railway companies, and have received the general charges fixed in the quoted rates from the mill to the market. The Interstate Commerce Commission has ruled that in most of these cases the practice has been unlawful, inasmuch as the spurlines were owned by the lumbermill owners and the railroads were remitting part of the scheduled freight charges.

For that reason the practice was ordered discontinued. As a result, the old freight rates now apply from the terminal line of the spurline to the main line of the railways to the markets, and the dealers are required to pay the additional cost of hauling over the spurlines.

The Commerce Commission now plans to reduce the rates from the terminals to the markets by eliminating the cost from the general schedule heretofore taxed to transportation over the spurlines. For example, if the rate from the mill to the market in Chicago was 30 cents, and out of this the spurline was entitled to 4 cents, the rate under the new schedule from the terminal of the spurline to the market should be 26 cents. Instead of making this reduction the old rate has been maintained. Some complaint had been made of the cost and attempts were made to have the investigation stopped, but it was hinted that interesting disclosures had determined the Governor to back up his committee by assurances that the work would proceed to a finish, at which time a full statement will be published of its findings.

SPOKANE, Wash., June 21.—(Special.)—Trustees of the Spokane Bolo Club have decided to take action that virtually will cause a "bolt" from the state organization, as far as political action in the coming campaign is concerned. In spite of the fact that the state organization has defeated any attempt to endorse a candidate for Governor, the Spokane Club will, at a meeting to be held next week, endorse not only a candidate for Governor, but one for Congress from the Third District and one for Congress-at-Large.

It is practically certain that the endorsements will be as follows: For Governor—M. E. Hay. For Congress, Third District—N. W. Durham. For Congressman-at-Large—Harry Rosenhaupt.

ARMY MULE IS JUSTIFIED

Tests Show It Is Unwise to Rely on Other Locomotion.

MADISON, Wis., June 21.—The Army mule apparently has won his fight for existence. The test of the automobile truck as a substitute for the mule on the march of the provisional regiment has been extensive enough to justify the statement for Governor, made by Congressman-at-Large—Harry Rosenhaupt.

Colonel R. N. Getty, in command, said, however, that the automobile truck would prove valuable in supplementing the regular modes of conveyance. The provisional regiment camped today at Middleton and will reach Madison at 8 o'clock tomorrow morning.

CHINOOK JARON AMUSES PIONEERS

Song and Chatter From Indian Tongue Delights All at Night Reunion.

BUCHTEL NEW PRESIDENT

Secretary Himes Is Re-elected for 27th Time—P. H. D'Arcy Urges All to Write Personal History for Posterity.

Chinook Jargon flew rapidly at the meeting of the Oregon Pioneers Thursday night when Chairman Miller called upon C. H. Walker to talk to the pioneers in this tongue of early days. A song in this mixed Indian language was first sung, Mr. Walker explaining that traders passing from one tribe to another found it difficult to make themselves understood. So the Jargon gradually came in to meet the emergency. "Kah, O Kah mitlita Moses siah" ran the song. The encore ran, "Jesus chako Kopa Sagahle."

The speakers of the evening were Mrs. Olive Meek Riley, A. B. Roberts, P. P. Castleden, of Portland, Cal., and A. G. Lloyd, of Walsburg, Wash. The music was excellent and much appreciated by the pioneers, who were free to express their delight. Mrs. Edna Dobbins with Mrs. Ella P. Jones as accompanist, rendered, "When You were Young, Maggie," and as an encore, "Silver Threads Among the Gold." Mrs. Fred Olson rendered, "Believe me if All Those Endearing Young Charms," and "Last Rose of Summer." "The Land" and "Pop Goes the Weasel Medley," rendered on the violin by Dan C. Bowers were applauded.

Joseph Buchtel Is President.

Officers for the ensuing year were elected as follows: president, Joseph Buchtel, 1853; vice-president, Joseph L. Carter, 1844; secretary, George H. Himes, 1853; re-elected for the 27th time; treasurer, Charles E. Ladd, 1857; directors, Nathan H. Bird, 1848; P. H. D'Arcy, 1857; and Theodore T. Geer, 1851.

The committee on resolutions offered thanks to the Women's Auxiliary for the excellent banquet held at the Armory, to the transportation companies and the citizens of Portland. These resolutions were adopted, as was a resolution supporting the Indian War Veterans in their effort to secure \$30 a month in pensions.

Mr. Himes suggested that the next reunion be turned into a basket picnic at the Chautauqua grounds at Gladstone, on the Oregon City line. This was opposed by P. H. D'Arcy, who said if the pioneers did not wish to meet in Portland next year, he would invite them to enjoy the hospitality of Salem. Mr. Himes then withdrew his motion.

Mr. Himes was instructed to prepare a badge for the ex-presidents of the association.

Chairman Miller provoked a great deal of merriment by referring to Mr. D'Arcy as a "bachelor, a deep thinker and man of wealth."

In a sketch of Joseph L. Meek, Mrs. Olive Meek Riley said that, although there were 15 children in the family, their father had never whipped them. She was born in 1851 in Linn County, opposite Oregon City. The town was washed out in December, 1851. She said her father learned to read from Shakespeare and the Bible, these two books being his only companions.

Records of All Urged. Mr. Castleman, who is 86 years old, told of a trip he made to Scottsburg for powder and shot when the Indian war broke out. He described graphically the hardships of transportation, this ammunition over a blind trail in a wild, unbroken country on a mule's back.

Joseph Buchtel, the new president, was introduced by Mr. Walker. Mr. Buchtel is the oldest photographer in Oregon, Mr. Walker having a picture of himself and sister made by Mr. Buchtel in 1857.

The pioneers were invited to attend the Champagne celebration next year, a tract of 12 acres having been secured by Mr. D'Arcy and others. The chairman urged them to take pains to preserve the history of themselves. "Each of you has a history which should be preserved," he said. "See that some member of your family writes it for you at your dictation before the next pioneers' meeting, or dictate it to a stenographer. It is valuable."

CONNERS VISITS IN YACHT

Buffalo Democrat Finds Bryan at Chicago and Queries Him.

CHICAGO, June 21.—William J. Conners, the Buffalo Democratic leader, has the distinction of being the only convention visitor to come to Chicago in a private yacht. "Go in to be a reporter there, too?"

"Not me; be too busy otherwise."

"Well, I'm here for newspaper work, too—but not doing much of it myself. Good-bye."

HUGHES' STAND FINAL

RABBI WISE SAYS JUSTICE WILL NOT ALTER POSITION.

Proposed "Dark Horse" Quoted as Saying Supreme Court Must Not Be Dragged Into Politics.

LAKE PLACID, N. Y., June 21.—Based on what he has to say in a personal interview had with Supreme Justice Hughes, Rabbi Stephen S. Wise, of New York, a close personal friend of the Justice, issued yesterday a representative of the Associated Press a statement setting forth the real reasons, he says, why Justice Hughes could not allow his name to be considered by the Republican convention at Chicago. His statement follows: "I have just come from a visit to Justice Hughes at camp Abenaki, Lake Placid, and deem it of importance to set forth the reason that led him to refuse to permit his name to be considered in connection with the nomination for President at the convention of the Republican party in Chicago. "His answer has been 'No' and as far as another may judge that answer has been reached without regret. This 'No' is the reasoned and unalterable decision of an unflinching conscience, a decision as honoring to him as has been every hour of his noteworthy public career. "We parted I turned to him and asked the final question: "Do you not conceive that an extraordinary crisis might make it your duty to accept the nomination for President in order to render a great public service?" "Unhesitating and unequivocal was the answer: 'No.' "I have said as Justice of the Supreme Court I am rendering public service and may continue to do so for some years, but the Supreme Court must not be dragged into politics and no man is as essential to his country's well being as is the integrity of the courts."

FASTER WORK PROMISED

Taft Managers Want to Complete Nominations This Week.

CHICAGO, June 21.—At a conference tonight the Taft managers determined to get to work promptly tomorrow on the spot of the nomination of the committee. The committee will present a partial report, which the convention will take up immediately. The credentials of the managers will be read and the order of contests and report piecemeal to the convention. The plan of the Taft managers is to hold two night sessions and press the work so that nominations can be reached Saturday and the convention can close late Saturday night or Sunday morning.

On the other hand there is talk of hurrying matters at all and of prolonging the session until Monday or Tuesday of next week. This apparently does not seem to favor among the men who are in control, nor does it please the great mass of delegates, who are anxious to get home.

TAFT, SMILING, PLAYS GOLF

President Cheerful as He Flees From Politics With Son.

WASHINGTON, June 21.—President Taft dropped consideration of political bulletins late yesterday and motored to Chevy Chase to play golf with his son, Robert. The President's smile was as cheerful as it was Thursday of the third week in June, 1908, when he sat in his office, then in the War Department, and looked over the score of the delegates as they voted for his nomination. The President stayed in the White House last night. He took up again the political threads and there were several telephone conversations with the President's political managers in Chicago.

General Bragg Is Dead.

FOND DU LAC, Wis., June 21.—General Edward S. Bragg, commander of the famous "Iron Brigade" during the Civil War, died today. General Bragg was 95 years old. He served several terms in Congress as a Democrat from Wisconsin, and later represented the United States in Mexico, Cuba and China as general. He was in the Democratic convention in 1854, when, in seconding the nomination of Grover Cleveland he used the expression: "We love him for the enemies he has made."

BIG GIFT MADE TO ART

TWO ESTATES AND TWO MUSEUMS DONATED BY WOMAN.

Magnificent Collections Will Be Maintained Intact in Paris and Chateau Chailis.

PARIS, June 18.—Seldom has a more magnificent gift been made in the name of art than the legacy of Madame Edouard Andre to the Institute of France, by which two estates and two museums, one in Paris, the other the Chateau de Chailis, as well as a capital sum of nearly \$5,000,000 have been left to encourage art in France. The magnificent collections in the boulevard Haussmann and in the Chateau de Chailis are to be maintained intact, and all the officials at present serving retained in their positions. Only the two posts of Director-In-Chief are left to the nomination of the Institute, and literary men have lost no time in flooding the institute with applications for these appointments. Apart from the mere munificence of the legacy, however, there is a great interest attaching to the Chateau de Chailis and the splendid historical estate that has fallen to the French nation.
