

LEHMANN RESIGNS DESPITE PROTEST

Solicitor-General Who Carried
Corporation Tax Case
Through, Is Out.

BULLITT MAY GET PLACE

President Says He Accepts Resignation
With Great Regret—Place
in Democratic Cabinet Is
Said to Be Aim.

WASHINGTON, June 26.—Frederick W. Lehmann, Solicitor-General of the United States, has placed his resignation in the hands of President Taft. It is known that his successor has practically been chosen.

Mr. Lehmann is a Democrat, has been prominently mentioned for a place on the Supreme Court bench, and has been regarded by many as a possibility for Attorney-General if a Democratic administration should come into power.

It is known that Mr. Lehmann resigned against the vigorous protest of Attorney-General Wickersham, who was insistent that the Solicitor-General should remain in his office at least until next spring. Mr. Lehmann could not be persuaded. His plans are not known, though some of his friends believe he may become active in politics in the coming campaign.

Solicitor Refuses to Explain.
Mr. Lehmann absolutely refused today to discuss his resignation. He probably will return to his home in St. Louis, where he was practicing law when President Taft appointed him to succeed the late Lloyd W. Bowers.

Mr. Lehmann completed the corporation tax case successfully in the Supreme Court after Mr. Bowers' death and bore a large part of the preliminary work in the preparation of the Government's suit against the steel corporation.

He prepared the opinion upon which the National City Company of New York proposed, as a giant holding company of banks, decided to change its plans to meet the approval of the Government.

Bullitt Under Consideration.
William Marshall Bullitt, of Louisville, Ky., is said to be under consideration by President Taft as a successor to Mr. Lehmann. Some officials here regard it as settled that the place has been offered to Mr. Bullitt and that he has accepted.

The President accepted Mr. Lehmann's resignation to take effect upon the appointment and qualification of his successor. This will be about the first of next week. The President said he accepted the resignation with great regret and paid a tribute to the ability and record in the Department of Justice of the retiring Solicitor-General.

CASH IS GREATLY NEEDED

President Taft to Point Out Anomalies of Situation.

WASHINGTON, June 26.—President Taft will send a message to Congress tomorrow, pointing out the anomalous situation whereby the machinery of the Federal Government must continue in operation in direct violation of law, and making officials liable to fine and imprisonment unless steps are immediately taken to provide funds for the next fiscal year, beginning July 1.

The President will appeal for the passage of a resolution extending the necessary appropriations of the current fiscal year for a temporary period to tide over the emergency by the failure of the regular and deficiency appropriation bills to be enacted into law.

It is unlawful for any official to create a deficiency or accept the services of anyone gratuitously. Unless Congress acts it is pointed out in Administration circles, one of these laws must be violated to some extent because Government business cannot come to a standstill.

The Navy Department is going slow in risking a violation of the law, the appropriations made, the civil employees of the Navy-Yards and many in the departments here will be furloughed on Monday.

FOUTS DIVORCE GRANTED

Portland Man Goes to Astoria and Wins Separation.

ASTORIA, Or., June 25.—A decree of divorce was granted in the Seneca Fouts against Marjorie E. Fouts, in the Circuit Court here on Monday. Fouts in his complaint alleges that he and Mrs. Fouts were married at Vancouver, Wash., January 1, 1907, and that they have one child, Seneca Fouts, Jr., 2 years old; that Mrs. Fouts has treated him with great cruelty, making his life unbearable; that she has nagged and abused him, accusing him of being false to her.

Particularly, on one occasion, when they were at a party with a number of friends, he declares, she accused him and one of the women present, and this accusation was made in the presence of the assembled guests.

The decree is absolute, and provides that Mrs. Fouts shall have custody of the child, and gives her a \$100 monthly allowance. It also provides for the payment of \$50 monthly by Fouts to Mrs. Fouts for the maintenance of the boy. W. E. Farrell was attorney for the plaintiff.

WASHINGTON MILITIA HOME

Pennsylvania Ends Cruise With Naval Reserves on Board.

SEATTLE, Wash., June 26.—(Special.)—Successfully defending their warship, the cruiser, Pennsylvania, against the attacks of the propeller boat destroyers Fox and Davis in a mimic naval engagement last night in the Straits of Juan de Fuca, the officers and men of the Washington Naval Militia demonstrated their efficiency as a naval reserve force, and concluded the most successful cruise in the history of the organization.

This morning the Pennsylvania steamed into Seattle harbor and the first division was put ashore, while the cruiser proceeded to Tacoma with the second and third divisions.

The target practice and naval maneuvers held off Port Angeles at the conclusion of the 10 days cruise, Monday and Tuesday, gave the militiamen an opportunity to demonstrate under the eyes of Admiral Alfred Reynolds their ability to handle the big guns of the cruiser and make good averages in target practice and to handle the

warship in the face of a hostile torpedo flotilla.

In target practice the Indian division from the Puget Sound Reservation beat both the Seattle and Tacoma contingents by a comfortable margin.

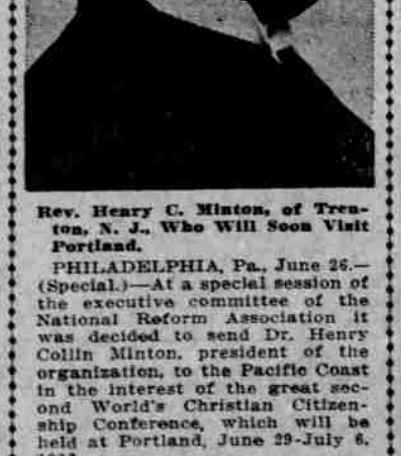
MINISTER TO CONFER WITH EDUCATORS

TALK WITH DARROW RECITED ON STAND

Attorneys Exhausted at End of
Examination of John R.
Harrington.

DEFENSE ARGUES IN VAIN

Conversation Recorded by Telephonic
Device Retold in Court—Darrow's
Lawyers Demand Trans-
script Be Introduced.

LOS ANGELES, June 26.—John R. Harrington, of Chicago, left the witness stand today in the bribery trial of Clarence S. Darrow, after having been under examination for seven days. All that time, with the exception of a few hours, Harrington was subjected to a cross-examination by Chief Counsel Rogers of the defense. At the conclusion, opposing counsel asked for an adjournment before beginning Harrington's re-direct examination, because of mental and physical fatigue on the part of the attorneys.

The entire day was devoted to the conversations between Harrington and Darrow, which had been planned, as the witness testified, so that they could be reported verbatim by a telephonic device.

Defense Demands Transcript.
Once more the defense vainly demanded the transcript of the conversations in order that the memory of the witness might be refreshed. The court said, however, that unless the prosecution introduced the transcript into evidence, the reporter's notes of what he heard by means of the telephone eavesdropper might be introduced by the defense.

Harrington admitted today that he had had financial difficulties with Darrow and that the latter still owed him the difference between \$5500, which he had received while employed by the McNamara defense. He said that he and Darrow had compromised on a final settlement of \$5000 which he had never received.

Talk With Darrow Recited.
The witness testified also that when he had brought Darrow to the hotel he had tried to prevail upon him to let the District Attorney what Darrow knew of the whereabouts of Caplan and Schmidt, the alleged dynamiters of the Times building. Harrington said that Darrow told him that the authorities would be lenient with him if he aided them.

"I told him I thought it was his duty to turn up Schmidt and Caplan," said Harrington. "I also told him there were others involved and that he should not be the only one to suffer."

The witness recited Darrow's reply, and when pressed as to the identity of the "others," said he referred to Antonio Johansson, the San Francisco labor leader.

Members of the defense displayed elation at the conclusion of Harrington's cross-examination.

BOOM SPOILS INDUSTRY

FARMERS SELLING LAND FAIR TO RAISE BEETS.

Sugar Trust Witness Says News of Proposed Factory Defeated Purpose of Enterprise.

NEW YORK, June 26.—In the Government's equity suit for the dissolution of the beet sugar trust, the witness, Thomas R. Cutler, vice-president and general manager of the Utah-Idaho Sugar Company, today gave a land boom resulted in the failure of the Havemeyer company to erect a beet sugar factory near Payette, Idaho.

In 1906, he said, the erection of the factory was contemplated with respect for the power of the beet industry of the farmers to raise a certain number of acres of beets. "When the news of the proposed factory got out," he said, "the farmers began to sell their land and they did not have time to raise beets, and the required acreage was not planted."

United States Assistant District Attorney Knapp made an effort to show that Mr. Havemeyer in his operations in Utah and Idaho had a party to the power of the beet industry.

After being assured that back of the questioning there was no idea that the Mormon church was a party to the suit, the witness replied in the affirmative.

GUARANTEE IS PLEDGED

HUERTA WILL RESPECT GUARD LEFT IN CHIHUAHUA.

Rebel Scouting Parties, Venturing Too Near to Ortiz, Captured Without Casualties.

AT GENERAL HUERTA'S FEDERAL HEADQUARTERS, ORTIZ, Mex., June 26.—The request of General Pascual Orozco, the rebel chief, that General Huerta respects the neutrality of a garrison that he left to protect the city of Chihuahua if evacuated by the rebels, was received here today.

General Huerta communicated his reply as follows: "I will give all guarantees to any forces of Orozco who may leave to protect the people of the City of Chihuahua, provided those forces have the nationality of Mexico."

Some of the rebel scouting parties advanced too closely to Ortiz today and were captured by the federal vanguard without firing a shot.

Nearly all the federal army has crossed the river at Ortiz the artillery alone awaiting the completion of the big Ortiz bridge. This should be finished by tonight.

HERMANN WANTS PROBE

Congress May Investigate Land-Fraud Trials.

Binger Hermann returned to Portland yesterday from a visit to Washington, D. C., and the Chicago convention. He has taken quarters at the Imperial Hotel. His mission to Wash-

ington was to bring about an investigation of the methods used during the land fraud trials in Portland.

"It is proposed in Washington that there should be an investigation through the judiciary committee of either the House of Representatives or the Senate, or perhaps both," he said. "How the investigation will be made will depend on how it presents itself to the committee. It may be that oral testimony will be required. Whether this will be taken by deposition I cannot say."

"There is much interest among Congressmen over the action of President Taft in pardoning Willard N. Jones, and over disclosures made to the President by the Department of Justice. Mr. Taft is astonished at the revelations brought to him by the Attorney-General."

"The Attorney-General was even more emphatic in his denunciation of the procedure here. His report to the President covered 12 closely typewritten pages. In this he summarized the investigations made by the department. It is expected that in the forthcoming annual report of the Attorney-General the result of these investigations will be set forth in detail. The report probably will come before the next session of Congress—the December session. I think the present session will hold until next August, perhaps September."

He did not have a personal interview with the President.

YOUTH SEEKS IDENTITY

BOY REARED IN ORPHANAGE WOULD FIND PARENTS.

Anthony Lane, Aged 16, Interests Officials at Oregon City in His Pathetic Quest.

OREGON CITY, Or., June 26.—(Special.)—A pathetic incident occurred in the County Assessor's office here Tuesday, when a neat and refined appearing boy called to inquire of Deputy County Assessor Johnson if he could give him any information in regard to his adoption papers. The boy was taken into the office of County Clerk Mulvey, and Miss Ivah Harrington, chief deputy in the Clerk's office, looked over the records, but nothing was found to show who the boy was.

The boy said that he was placed in the St. Agnes Baby Home when a mother, and when about two years and a half old was taken by John Bartnick, who resides near Scotts Mills, where he was kept until about nine years of age. Then he was taken by Mr. Bartnick to St. Mary's Home for Boys, which is in charge of the Sisters of Mercy, at Beaverton, Or. From that institution the boy was sent to Mount Angel College, and has just finished his course there. He is anxious to find his parents if they are living.

After arriving here he visited the Home at Parkplace, but could get no information, so he has gone to Beaverton. He says he is going by the name of Anthony Lane. He has the special of a boy of about 16 years of age, his hair is auburn and he uses excellent English. He appears to be an unusually attractive and bright boy and was well clothed.

CHAUTAUQUA PLANS READY

Gladstone Park Will Be Well Lighted—Power Company Donates.

OREGON CITY, Or., June 26.—(Special.)—Secretary Cross, of the Williamette Valley Chautauqua Assembly, has completed arrangements for lighting Gladstone Park during the meeting which will start July 9 and continue 12 days.

It is planned to have more lamps than ever before, and the grounds and building will be almost as light at night as in the day. The Portland Railway, Light & Power Company has agreed to donate the electricity, following a precedent established several years ago. One of the largest crowds at the Chautauqua is expected July 14, when Charles Edward Russell, the journalist, will lecture on "Soldiers of the Common Good."

After serving as managing editor of the Minneapolis Journal and the Detroit Tribune, Mr. Russell went to New York and was a reporter for the New York Herald and for the New York World for several years. He has been a political reporter and reported National campaigns and conventions.

PICNIC TO BE GIVEN 20,000

H. E. Huntington Will Have Large Excursion to Redondo Beach.

LOS ANGELES, June 26.—(Special.)—H. E. Huntington will pay all the expenses of a picnic party of 20,000 persons at Redondo Beach late in the summer. Transportation, lunch, dinner, amusement entertainment and everything to make everybody happy will be provided at the trolley magnate's expense.

His guests will be the 5000 employees of the Los Angeles railway corporation, and it is expected the number will be charged and possibly exceeded. Huntington says he does not care if 25,000 turn out, for he will be ready to look after them in every way. Local special trains will carry them to the beach and back.

HOOD RIVER, Or., June 26.—(Special.)—The County Court has let a contract for a bridge to span the West Fork of Hood River, where the lake branch enters that stream. The bridge will replace the old wooden structure which has stood for so many years. The new bridge will make a passable route for automobiles to a point near Lost Lake. Heretofore heavy cars have not crossed the old bridge.

REGIMENT HAS ITS SHARE OF TROUBLE

Recruit Stabbed in Kitchen Frolic and Soldier Drowns in New Quarters.

ONE DEAD, ANOTHER DYING

Life in Tropics Begins Inauspiciously for First Regiment—Military Patrol May Solve Police Problem.

HONOLULU, June 19.—(Special Correspondence.)—The arrival of a new regiment is usually attended by police court cases of more or less importance, but the First Infantry, lately from Vancouver Barracks, Wash., has had more than its share of trouble since it came two or three weeks ago, and Colonel McGunnagle, the regiment's able and popular commander, is distressed. The oldest regiment in the service was hardly arrived at its Schofield Barracks quarters, when in a kitchen frolic one of its recruits was stabbed accidentally by a company cook and died within the hour. The same day another soldier fell into a reservoir and was drowned.

Pay-Day Encounter Fatal.
Yesterday was the regiment's first pay-day in Hawaii and a large number of the men came from Lihue (the name of the military reservation in which Schofield Barracks is situated) to Honolulu, and many of them acted after the usual manner of paid-off men in a new country, with the result that after a fight over a Russian girl in an unsavory part of the city two men, Private Roscoe City, of the First Infantry, and Trooper Frank Bostle, of the Fifth Cavalry, were taken to Queen's Hospital, where Bostle died this morning and City is dying, having been shot through the body. The girl and others are under arrest, but as the fight took place after the lights were extinguished and as many of those taking part were Japanese, the police have made little headway in placing the blame.

Military Patrol Talked Of.
However, the affair has resulted in the placing of a military patrol in Honolulu at least for the time being, but the military authorities are seriously considering the advisability of creating a permanent soldier police, as was in vogue in Manila for years. The city authorities will offer no objection to this; indeed, they would welcome such a move on the part of the army, for the small police force would be of little avail in maintaining order with hundreds of soldiers upon the streets. In ordinary times the soldiers have given only a minimum of trouble, and clashes between them and the police have been so rare and far between that they are forgotten.
