

SERIOUS DAMAGE DONE TO CROPS

Southeastern Washington and Oregon Farmers Suffer From Heavy Storms.

FIRST NEWS EXAGGERATED

Grain Shattered in Places but Area Injured Is Not Great Enough to Make Appreciable Difference in Total Yield.

A general storm through the grain growing sections of Oregon and a portion of Southeastern Washington Saturday night and Sunday caused widespread uneasiness.

Up to the present time conditions have all been favorable and farmers of the Northwest have in prospect the largest crops in years and in many localities the largest crops ever grown. Early reports from the storm centers were disquieting, but later information, based on actual knowledge shows that while considerable damage has been done it is not serious enough or spread over a large enough area to make any appreciable difference in the aggregate yield.

MORROW COUNTY HAS STORM

Large Hall Stones Fall and Grain Is Seriously Damaged.

HEPPNER, Or., July 21.—(Special).—An electrical storm struck the western part of Morrow County last evening. From the meager reports coming in the damage to the wheat fields done by the hail was severe.

The storm centered at what is known as the Cliff Jones place and traveled in a northwesterly direction. The worst damage was done at the Ed Huston farm.

The hail stones were as large as hen's eggs and beat the limbs off of the fruit trees. At Frank Glascock's place it broke the windows on one side of the house.

It is impossible, owing to the telephone lines being out of commission, to estimate the damage, but it will reach into the thousands of dollars.

CROP DAMAGE NOT SERIOUS

Wheat Is Not Ripe Enough to Be Shattered by Hail.

HEPPNER, Or., July 21.—(Special).—The damage to the crops in the eight-mile country from yesterday's hail storm was much less than first reports indicated. The wheat was not quite ripe enough to shatter easily and to this fact is due the small loss.

At the same time as the hail storm in the eight-mile country, a cloud-burst occurred on the head of Butter Creek in the eastern part of the county which washed away the residences of F. F. Hufford and A. B. Chapman, together with the barns and outbuildings.

Robert Young, the son of J. S. Young, County Commissioner, was seriously injured last night by a horse falling on him, the saddle horn crushing his breast.

POTATO CROP IS LARGE

Hood River Will Produce Between 25,000 and 30,000 Sacks.

HOOD RIVER, Or., July 21.—(Special).—The potato crop in the Hood River Valley is estimated this year at between 25,000 and 30,000 sacks, the largest ever raised here. A number of the tuber growers here reaped a rich harvest last year, shipping a number of carloads to Texas and receiving excellent returns.

While most of the acreage is composed of land just cleared or that with potatoes planted between young trees, a few have planted on a commercial basis. The orchardists who plant between their trees expect their crops to furnish them their own supply and enough over to have a wagonload or two to haul to market.

Albert Crocker, John Koberg and F. H. Button are the heaviest growers of potatoes. Mr. Crocker has a large tract on the Paradise farm.

It is probable that the Hood River Applegrowers' Union will handle potatoes this season. Wilmer Sleg, the manager, who has gone to the states, will attempt to establish relations with firms in order to dispose of the local tuber crop to advantage.

NEWLYWEDS ARE VICTIMS

Bridegroom Kidnaped at Vancouver, Bride Enjoys Charivari.

VANCOUVER, Wash., July 21.—(Special).—Charivaring a youthful bride, with the bridegroom kidnaped and spirited to Portland by another crowd of merry-makers, was the order of the day for a band of conspirators here Friday night, when they invaded the home of K. Johnson, brother of Mrs. Athol of this city.

Portland friends of Mr. Johnson arrived here early in the evening, placed him by force in a machine, took him across the river where he was invited to buy supper and champagne at an expensive grill. In the meantime, the Vancouver boys invaded the Johnson home and found the bridegroom absent. Mrs. Johnson made the uninvited guests welcome, however, provided refreshments and asked the neighbors to come in and enjoy the merriment. About midnight, the bridegroom telephoned his whereabouts and early next morning was allowed to return home.

PAROLE MAN IN TROUBLE

Accused Watch Thief Identified as Burglar From Walla Walla.

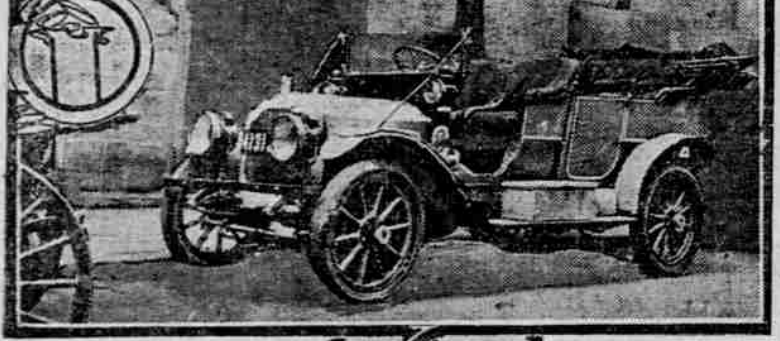
SACRAMENTO, July 21.—(Special).—Three hours after Emil Steinman, proprietor of a jewelry store at 822 K street, had reported to the police that his place of business had been entered and robbed in the early hours of the morning, Frank Cummings was arrested with 23 stolen watches in his possession. One hour after his arrest Cummings was positively identified by Max Fisher, of the Criminal Identification Department, as Austin Downey, a parole breaker from the Walla Walla penitentiary, serving an indeterminate sentence for second degree burglary committed in King County, Washington.

Cummings vigorously denied that he had anything to do with the robbery of the jewelry store and declared that he had never been in the state of Washington. The warden of the Walla Walla penitentiary was informed.

Harlem Ruffians on Raid

Encouraged by the success of Zellig with whom they had been long affiliated, the Harlem ruffians, "Whitey" Lewis, "Lefty" Lowry, "Gib the Blood" and others of the Harlem section of the Zellig band, are reported to have decided that it was an easy way to attain a surplus. They made raids of their own, but the players were robbed too, and the games were broken up.

Zellig went to Harlem and thrashed the men named. They were in disgrace with him thereafter and were not permitted to participate in the conference or band operations of the leader. They were handled roughly and felt themselves in danger.

When those most interested decided that Rosenthal must be put out of the way, Zellig is said to have been consulted.

Murderers Try to Redeem Selves

When the murderers of Rosenthal were selected they are said to have made a last effort to redeem themselves.

"Dago Frank" was the spy who went ahead in the attack upon "Dick" Curley in the Bowery and the Harlem ruffians who are charged with being in the car that carried Rosenthal's murderers to the Metropole are the same for whom he was vanguard in the attack upon Curley. He spied out Curley and induced Curley to go to the door of the Bowery saloon; pulling him into the street, where he was shot by the men in the automobile.

As well as the Taft voters at home this fall they could be re-elected, and they also figured that such a plan would not only turn the House Republican, but would make the Senate sure by Republican for another two years. The Flinn scheme appealed not only to insurgents but to regulars, and they were figuring on return by increased majorities.

Colonel Subject to Change

But now that Roosevelt has turned down the idea and has insisted on having a whole bull moose ticket in every state where he decides to make a fight, prospects for candidates for Congress and other offices will be less bright. In a three-cornered fight the advantage, as a rule, will lie with the Democrats, and the prospect for a Democratic House and Senate is good, if Woodrow Wilson carries the country in November.

The fact that Colonel Roosevelt has had his split with Flinn does not necessarily signify much, for Roosevelt is changeable of late, and demonstrated at Chicago that he was capable of taking up a new line of action at least once every hour. His plans in the evening were never the same as those he outlined in the morning; each day brought a different programme, and his

wobbling was largely responsible for his ultimate defeat. So that it is probable he may yet take up the Flinn idea, or he may subscribe to some new plan that neither he nor Flinn nor Munsey nor Pinchot nor anyone else has yet conceived. The Colonel don't know where he will get off, but he knows he is on his way.

Of course, Mr. Boss Flinn, being a political boss, is primarily concerned in concentrating great power in himself. Flinn doesn't care any more about the people than does Boss Murphy. He is chiefly concerned about himself, and his little plan of campaign was framed not so much to help Roosevelt as to help himself. He wants to be absolute dictator in Pennsylvania. Of course, he would sacrifice Roosevelt to save himself, but that is only natural, as he is a boss.

Party Needs Its Plutocrats

Roosevelt's predicament arises largely from the fact that he has arrayed himself with himself and plutocrats. While denouncing these who classes, he has been depending upon them to pull him through, and he must continue to depend upon them if he hopes to make any kind of a showing in the Fall. He cannot make a campaign without the funds contributed by the wealthy Flinn, Perkins, Pinchot, Kent and others, and he must continue to depend upon them just as much as he needs the support of Boss Flinn, of Pennsylvania; Boss Brown, of Ohio, and would-be Boss Johnson, of California.

Naturally, it is difficult for a "friend of the people" to make much headway when his chief support comes from bosses and plutocrats. But Roosevelt went head first into this predicament, and he must extricate himself.

HAY IS FORMALLY IN RACE

Washington Governor Files Declaration of Candidacy.

OLYMPIA, Wash., July 21.—(Special).—Governor Hay has filed his declaration of candidacy for the Republican nomination for Governor with Secretary of State Howell. Although two democrats have filed their names Governor Hay has the distinction of being the first Republican candidate to file a declaration.

W. V. Tanner, the present Attorney-General, and John F. Dore, of Seattle, have both filed their declarations for the Republican nomination to the office of Attorney-General. Attorney-General Tanner gave his residence at Seattle. He was a candidate for the office in 1908, but was defeated by W. P. Bell. Upon the appointment of the latter to the Superior Bench of Snohomish County, Tanner, who had been named as an Assistant Attorney-General, succeeded Bell to the office.

James M. Gephart, of Seattle, has filed his declaration of candidacy for the Democratic nomination for Congress from the First District.

DORMITORY FUND IN DOUBT

Proceedings Contemplated to Force Payment of Warrant.

SALEM, Or., July 21.—(Special).—That steps will be taken to determine whether the money appropriated for the new dormitory at the Monmouth Normal School is available was intimated today. Proceedings will probably be started to force Secretary Olcott to issue a warrant on a small voucher on the dormitory fund.

When the University of Oregon referendum case were up the Monmouth Normal School case was also brought in Circuit Court, and a stipulation was entered into between the attorneys that whatever decision was arrived at in the university cases would be adhered to in the normal school case. This was under the original university cases which were thrown out by the Supreme Court.

Newport to Have "Oregon" Home

SALEM, Or., July 21.—(Special).—E. Hofer, who left for Newport last night, contemplates the construction of a summer home at a resort by the sea. It will be a bungalow, and Colonel Hofer stated that he intends to construct it entirely from Oregon-made products and intends to have nothing in the bungalow or in connection with it that is not made in Oregon.

QUINABY LIVELY PLACE

UNITED EVANGELICAL CHURCH IN THIRD ENCAMPMENT.

Ministers in Overall Help to Clear Off Grounds Between Religious Services.

QUINABY PARK, Or., July 21.—(Special).—To the echo of hammer and saw, gospel hymns and singing pines a tented city of several hundred inhabitants has sprung up during the past few days at Quinaby, a little station on the Oregon Electric, seven miles from Salem, the occasion being the opening of the third annual encampment of the United Evangelical Church.

A commodious tabernacle, hotel and half a dozen small cottages give some appearance of permanence. Trains, automobiles and wagons are hourly adding to the population, until the 16-acre tract upon which the camping ground is located promises to be all under canvas before the close of the week. The grounds are laid off in streets, all named for distinguished churchmen. They are Albright, Silbert, Duds, Stanford, Hartzler, Hile, Swengle and Faulk. Camping privileges are free and many have availed themselves of the privilege and have been enjoying a several days' outing previous to the actual work of the camp-meeting, which opened Friday evening with an address by Dr. C. C. Poling, of Portland. Last evening Rev. S. M. Wood, of Corvallis, was the speaker. Following was the order of today's services:

10:00 A. M. Sunday School led by Rev. H. Barendrick, of Portland.

11:00 A. M. Preaching service by Rev. S. M. Wood, presiding elder of the Salem district, followed by communion service in charge of Rev. Charles C. Poling, presiding elder of the Portland district.

2:30 P. M. Sermon by Rev. D. V. Poling, of the Dalles.

3:30 P. M. Sermon by Rev. D. M. Metzger, of Dalles, preceded by a 30-minute song service.

Tomorrow and Tuesday will be given up to the Bible conference, the following ministers to appear on the program Monday for short addresses: Rev. Victor Ballantyne, Rev. F. E. Brickley, Rev. William Plowman, Rev. Fred Uriebo, Rev. Samuel M. Wood, Rev. Charles A. Burris, Rev. Marlin J. Ballantyne, Rev. Floyd E. Fisher, Rev. Samuel S. Mumey and Rev. Chester P. Gales.

One of the notable figures on the camp ground is that of Rev. John L. Burns, who with his wife and son drove 75 miles in a covered wagon from the Alsea country to be present at the camp-meeting, this courageous worker never having missed a session, although living at so remote a point from the place of meeting. Many distinguished ministers have temporarily discarded broadcloth and donned overalls, spending the time between services actively engaged in cleaning up

the grounds and chopping wood. One of the most impressive services of the day is the sunrise praise service, when the deep woods resound with gospel hymns, where only the call of the wild bird is heard at other times of the year.

PACKING-HOUSE OPENED

GROWERS NEAR WEISER, IDA., HAVE NEW PLANT.

Shipments of Fruit District Will Grow Rapidly as Result of \$2000 Structure, Is Belief.

WEISER, Idaho, July 21.—(Special).—To provide for handling and shipping the phenomenal 1912 fruit crop of the Weiser Valley, a new \$2000 packing-house has just been completed. This week at Johnathan, four miles west of town, by the Weiser River Fruitgrowers' Association, an organization composed exclusively of orchardists. Until an experienced packer is employed, the warehouse will be in charge of Russell Kimball, the secretary. Miles Cannon, a well-known grower, is president.

Through the new packing-house between 350 and 500 cars of apples and pears will be shipped this season, all bearing the Weiser brand. Last year less than 50 carloads were shipped.

Affiliated with the Northwest Fruit Exchange of Portland, the local association will observe all of its rules in packing and shipping, and only the highest standards and grades will be maintained. As a result, farmers expect to realize much better prices for their shipments and an increased revenue generally.

In constructing the new packing-house, arrangements were made for handling greatly increased shipments in the future, as the territory which it will serve has thousands of young trees which will be coming into bearing in a few years. Wives of the fruitgrowers in the little rural community of Johnathan provided a social, with refreshments and a country dance, when the packing-house was opened, and it was attended by a crowd.
