

24-HOUR STRIKE IS MARKED BY RIOTS

"Demonstration" Is Called Off Pending Procedure of Labor Leaders' Trial.

SCORES ARE UNDER ARREST

With Opening of Mill Gates Pickets Armed With Guns, Hammers and Other Weapons Try to Stop Workers Entering.

LAWRENCE, Mass., Sept. 30.—A "demonstration" strike against the imprisonment of labor leaders took place here today. After a hand-to-hand clash between rioters and police lasting all day, the "demonstration" was declared off by the Industrial Workers of the World.

The strike was called for 24 hours, beginning this morning, in protest against the imprisonment of Joseph J. Ettore, Arturo Giovannitti and Joseph Caruso, whose trial in connection with the death of Anna Lopez opened today in Salem. Seven thousand of the 35,000 operatives in the cotton and woolen mills here obeyed the call, forcing out 5000 others either through intimidation or the closing down of departments.

Workers Told to Return. At a mass meeting late today the workers were told to go back to work tomorrow, ready to come out again at the call of the Industrial Workers, if the leaders were satisfied with the progress of the trial.

The worst rioting occurred at the opening of the mill gates this morning. Pickets armed with revolvers, knives, hammers and other weapons attempted to stop operatives from going into the mills. When police interfered to maintain order the pickets struggled with them desperately. Swinging their clubs, the bluecoats drove back the pickets. A score of arrests were made.

Men, women and children on their way to work were held up and attacked by strikers or sympathizers. It was announced at headquarters that a vote will be taken on a general strike among the textile unions of Lowell on the matter of striking in the big cotton mills there, and that similar action this week will be taken at other New England mill centers. The Industrial Workers are sending out circulars throughout the country asking individual mill operatives whether they are ready to go out on a general strike as a protest against the trial of Ettore and Giovannitti, "if it is not conducted properly."

CLASH OCCURS AT NIGHT

The rioting which continued at intervals all morning flashed again at closing time tonight on Essex and Union streets, when a crowd of Italian operatives and sympathizers who were on strike met Polish workmen coming from the mills. The two parties at once came to blows, but after a few moments of hard fighting the crowd was dispersed.

One of the addresses in Italian that aroused the crowd at the afternoon mass meeting was translated into English and given out tonight in the form of a statement by the speaker, Carlo Treves. It said:

"If Ettore, Giovannitti, Caruso are found guilty, or either of them is found guilty, the Industrial Workers of the World will march to Salem, storm the jail and rescue the prisoners if possible."

CHECK ARTIST NERVOUS

Long-Distance Call Saves Money for Chechalis Merchant.

CHEHALIS, Wash., Sept. 30.—(Special.)—Late today a stranger entered M. Michael's store and ordered some furnishings. After making his selections he tendered Michael a check for \$24.50 on the United States National Bank of Centralia, and purporting to be issued by the Chechalis River Lumber & Shingle Company, which has a mill four miles west of Centralia. The check was made payable to J. H. Conner.

Mr. Michael was suspicious from the start and when he called the distant number on the telephone to make inquiry as to the check, the stranger grew nervous. At the merchant's suggestion that he call the police, the man tried to grab the check, and made a dash out through the store into the street and fled, with Mr. Michael doing a long-distance from him. The stranger finally made his getaway but the police are scouring the hills north of town trying to locate him.

CANAL TOPIC UPPERMOST

TEXAS GOVERNOR CHARGES HIS HAND

Permission Withdrawn for Mexicans to Cross State, but Act Is Too Late.

RISK THOUGHT TOO GREAT

State Department, However, Falls to Receive Message Before Closing and Troops Are Thought to Be Already on Way.

AUSTIN, Tex., Sept. 30.—Governor Colquitt has withdrawn permission for Mexican Federal troops to march from Marathon, Tex., to another point on the border over Texas soil. He announced today he does not care to take the risk.

The Governor sent this message from the Secretary of State at Washington: "Concerning the moving of Mexican troops through Texas from Eagle Pass to Del Rio and Marathon, my Adjutant-General calls attention to the fact that it will be a 70-mile march over rough territory from Marathon. I desire to withdraw my consent for the passage of these troops through Texas until I am advised more fully with reference to their movement. This march of 70 miles through the territory referred to will invite difficulties which I do not want to occur in Texas."

WASHINGTON, Sept. 30.—Even if it had any effect, which is considered doubtful, the objection of Governor Colquitt to the proposed transfer of Mexican troops through a portion of that state under permission accorded by the Secretary of State probably will come too late to be considered. It is said at the State Department that Governor Colquitt's consent to the troop movement was asked as a matter of courtesy. That consent has been given and the State Department having granted its own permission, General Steever was ordered today to furnish a proper escort and to lead Mexican troops safely through the Texan territory covered by the permit.

Up to the time the State and War departments acted for the day, Governor Colquitt's message seeking to withdraw his original consent had reached neither of the departments. Even if it had, it would be difficult to countermand the order to General Steever before tomorrow, and in the meantime, the Mexican troops doubtless will have passed the point of no return.

Officials here do not concede the right of any state authority to prevent the free movement of United States troops, nor the performance of such an international obligation as that imposed upon General Steever by the State Department in this case.

WISCONSIN FIGHT OPENS

LA FOLLETTE'S MAGAZINE ATTACKS DEMOCRATS.

Governor McGovern's Incumbency Praised—Publisher Promises Some Inside Information.

MADISON, Wis., Sept. 30.—The keynote of the Wisconsin campaign has been sounded by Senator La Follette. Branding the Democratic ticket and platform in Wisconsin as an "alliance between anti-Bryan, anti-Wilson, Tory Democrats and reactionary 'stairway' Republicans," La Follette in La Follette's Weekly Magazine, asks for the support of Wisconsin citizens for the Republican state ticket. There is a pointed paragraph in which the Senator shows the achievements in Wisconsin during the incumbency of Governor McFarland, and the platform of the state ticket of the Republican party.

"Governor McGovern's sorry and ill-fated attempt to serve those influences that caused him to slip his fingers into the Roosevelt tar-barrel at Chicago should not in this campaign be weighed against his record in the Governor's office—a record of earnest and faithful co-operation with the Legislature in carrying to fulfillment every pledge made in 1910. This record will be taken by Wisconsin progressives as assurance of the same devotion to platform promises in the future."

The editorial opens by saying the Republican party is an instrument with which the government is made to represent the will of the people. He shows how the people have been placed in control by the abolition of the spoils system, the emancipation of patronage, the crushing of the secret lobby and the rooting out of other devices of misgovernment.
