

PRESS OF STATE CENSURES BOURNE

Candidacy Is Regarded as Attempt to Nullify Very Law He Championed.

BEN SELLING IS INDORSED

Newspapers, Criticizing Course of Senator, Take Position That He Should Abide by Result of Primary Election.

With few exceptions, the newspapers of the state, Republican and Democratic alike, continue to censure Senator Bourne for his repudiation of the direct primary law. The press insists that the independent candidacy of Senator Bourne is inexcusable and indefensible, amounting to a desperate attempt on his part to nullify the very law of which he has been a champion.

Of the papers criticizing the senator's course, the Republican publications strongly commend the candidacy of Ben Selling, the Republican direct primary nominee. They take the position that Bourne, having entered the primaries and met defeat, should abide by the result. This is construed to be the only course left to him or to any other candidate defeated in the primaries if the direct primary law is to be maintained.

Criticisms Are Quoted.

The following are some of the most recent criticisms by the press of the state against Senator Bourne and his repudiation of the primary:

"Bourne's repudiation of the direct primary law puts him out of the running for United States Senator."—The Daily Chronicle.

"No voter favorable to the Oregon system of nominating candidates for office can conscientiously support Senator Bourne in his effort for reelection. In doing so they give the lie to their profession, and the senator himself has directly repudiated his past utterances. It is not enough to say that the people's choice was not selected at the primary, for Bourne is the only one who made a selection. If he can nullify the primary law why not others and if others can do so, why have a primary? Why all the talk about Statement No. 1 and why pledge a candidate to this statement when Bourne sets the example in overthrowing it? Bourne is playing politics, the old corrupt and nauseating politics and in doing so has obscured the good he possibly has done and made of himself a jest and discredited the system he has so earnestly espoused in the past."—Sheridan Sun.

Selling Is Praised.

"Voters of Malheur County are directly interested in the candidacy of Ben Selling for the position of United States Senator. Mr. Selling is a progressive and received the Republican nomination at the primary election. While visiting Malheur County a few weeks ago, Mr. Selling became acquainted with the great needs of Eastern Oregon. He has returned back for Oregon the lost irrigation money so much needed in the development of this section. If elected at the primary election, Mr. Selling will make another visit to Malheur County still better to become acquainted with the special needs of this section. Action Is Censured.

"Despite the flaws that may be picked in his public record, it can be denied that Jonathan Bourne attained nationwide recognition while serving in the United States Senate from Oregon. His speeches have been distributed broadcast and his articles in the Saturday Evening Post have met millions of eyes. Yet his candidacy is a slap at the direct primary, his pet law, and a traitorous act toward Ben Selling, whom he congratulated and promised to support.

"Has it become an essential phase of our political system that it is 'anything to get the coin' with our public men? Must they deceive and betray lest the people except them? Is there no honor in politics? The boom for Bourne was palpably inspired by himself and promoted by his close friends and relatives. Western League, he met the people and stood the test of close observation. Jonathan Bourne is a resident of Washington, D. C. owns great cotton mills in Lawrence and blatantly states 'the people—no I am on trial. That may be true, but every time there is a trial in Mr. Bourne's case he takes an appeal from himself to himself and goes after the place again. It is an instance of a resident of Oregon, old, honest and true, aspiring for an office against a non-resident who appeals to the voters in a play of empty words.'—Marshall Record.

Credit Given to Selling.

"Ben Selling, Republican candidate for United States Senator, was in the city interviewing voters yesterday. He says he is after the votes of good people. Mr. Selling is a successful business man and a great advertiser, spending thousands of dollars a year to make known his bargains. There are many good things about Selling's method of doing business that he does not publish and you only hear of them from those who are nearest to him. Among these is profit-sharing with his employees, and it is understood that his ultimate purpose is to make them owners of the business when it comes time for him to drop out of active business life. He also gives largely to charity. He never publishes these facts and doesn't wish to, but this paper is always willing to give credit where credit is due."—McMinnville Telephone-Register.

"Like the wall of a whipped schoolboy is that of the Bourne Popular Government Club. It could attempt to apologize for the Bourne candidacy. With the instrument of Bourne's creation, he was defeated at the primary and he now declares that it was 'unfair and illegal.' Of course it was, Jonathan. Any means that knocks out your theory that a Senatorial position once secured is retained at the will of the holder, is not only unjust, unfair, illegal, but an insolent crime against Bourneism."—Sheridan Sun.

"Bourne's Action No Surprise. Jonathan Bourne has announced his candidacy for re-election to the United States Senate notwithstanding his defeat in a fair manner in the primaries by Ben Selling. This action of the senator who is chiefly known at Washington for the costly parade of cigars which he smokes, is not surprising to

any one who has followed his checkered political career.

"Bourne has no political convictions—except as they may relate to his political preservation. Republican today, tomorrow a Democrat, Progressive, Standpatter or Bull Moose—as occasion may require. The present candidacy of this politician of guerrilla tactics, brought about by petitions—signers secured by hired workers at five cents per name—should meet a worse defeat November 5 than that administered at the primary election."—Metolius Oregonian.

"Ben Selling received the Republican nomination for United States Senator in a fair and square contest under the direct primary law. Senator Bourne was defeated fairly and squarely in the same election. Are the voters going to sustain the direct primary by supporting Selling, the direct primary nominee, or will they give their support to Bourne and repudiate the law? Oregon voters will not be parties to any such prostitution of this fundamental law of the Oregon system. They should accept the result of the primary nominating election and vote for Selling, who actively participated in preparing and enacting all legislation which has secured to Oregon its present system of popular government."—Oregon City Enterprise.

Observer Shows Bourne's Change.

"Try as he might, with all the artful methods, to escape the odium of openly opposing the direct primary law's working, Senator Bourne cannot get by in a graceful manner. His early allegiance to the cause of the people was thought by many to have been sincere. But in the direct primary election the senator is found trampling up excuses to set aside the people's verdict. Evidently he wants to return very badly when he will sacrifice the principles that he has openly advocated to make the race."—La Grande Observer.

RIVER RECEIVES ASHES

FINAL RITES ARE PERFORMED IN PIONEER'S MEMORY.

Ceremony for Late Kenyon Crandall, Who Came to Oregon in 1852, Takes Place.

Three men in a boat, in the Willamette River channel off the foot of Taylor street yesterday, performed the last rites in memory of the late Kenyon Crandall, Oregon pioneer of 1852, when they scattered his ashes on the waters of the Willamette. Mr. Crandall's last wishes were that his body be cremated and his ashes cast on the waters of the Willamette at the foot of Taylor street, where he landed December 24, 1852, disembarking from the vessel Charles C. Devins, in from San Francisco. The next day he walked to Hillsboro, Or., in a snow storm, and aside from two or three years passed in San Francisco and Los Angeles, Washington County had ever since been his home. He died October 24.

Early in life he was a seafaring man and sailed out of Boston to the Mediterranean. After an extensive cruise he returned to Boston and a few years later went to Illinois, where he remained until 1852. He crossed the plains to Oregon in the summer of that year, being in the same party with the late Harvey W. Scott, of The Oregonian, and Mr. Scott's sister, Mrs. Abigail Scott Dunway. Mr. Crandall left the party at Salt Lake, going to San Francisco, thence up the coast to Portland, where he remained for some time.

Mr. Crandall was born at Grafton Center, N. Y., July 21, 1830, and at death was aged 82. Of his immediate family

but one son, Jefferson L. Crandall, of Portland, survives. Lucius A. Long, with whom he lived at Hillsboro for nearly 35 years, was Mr. Crandall's nephew.

Mr. Crandall had been a reader of The Oregonian since it was founded, some twenty days before his death read his last number.

MEXICAN IGNORANT OF WAR

C. N. Thompson, Here on Business, Thinks Papers Exaggerate Facts.

Owning and operating thousands of acres of cattle ranges on the Eastern side of Mexico, C. N. Thompson, a former resident of Portland, is in the city for a few days assisting in the settlement of an estate in which his family is interested. Mr. Thompson, who is staying at the Perkins hotel, commented yesterday on how little he knew of the Mexican rebellion.

"For four years," he said, "I have been down in that part of Mexico and while we knew the Mexicans were having some trouble among themselves it never has interfered with our business as we shipped our cattle regularly to the United States by the Mexican Railroad and were still doing so when I left a few weeks ago. From what I could learn the trouble is entirely between the politicians and the citizens generally have no interest in it.

"In our section of Mexico, American and other interests have received full protection from the officials and it was not until I reached the United States that I could realize that the Mexican troubles were as serious as reported by the few newspapers that reached our section. As a matter of fact, I believe the whole matter has been much exaggerated for some personal or political reasons and if the United States newspapers would not publish so much about it the internal troubles of the country would soon be settled."

ROAD MILEAGE IS GREAT

BEND MAN TALKS OF PROBLEM IN OREGON.

Method of Raising Money for Proposed Improvements Discussed in Detail.

"The road problem is the most important of all issues before the people at this time," said Wesley Cantowine, of Bend, who is in Portland. "In the new districts of Oregon we realize the size of the problem in miles, at least. For down there distance has to be overcome by main strength and we have given some study to the problem of highway construction and some of the things I found true astonishing. For instance Oregon has about 94,000 miles of highway, proposed and in use. Two or three ranges of mountains must be figured on in any attempt to calculate road improvement. While in the state the western part has two ranges to contend with and the eastern section is crossed by the Blue Mountains.

"But six states have more mileage of highways than Oregon. The states are Texas, Nebraska, California, Illinois and Pennsylvania. All of these states are older than Oregon, yet the highway systems are not what they should be. In some of the Atlantic Coast states highway construction has become a science and the taxpayers pay for the work freely and even gladly.

"When it comes to raising money it should be remembered that the assessed valuation is the basis upon which operations must be carried on. At the present time but 22 states have an assessed valuation of \$10,000 or more per mile of road. All of these states except California are in the Central and Atlantic groups. Rhode Island leads with about \$200,000 assessed valuation a mile for the 2000 miles of highway. Massachusetts comes next with nearly \$200,000. Nevada has less than \$1000 a mile in assessed valuation for every mile of road in the state.

"Should Oregon improve one mile of four in the state, that is in the sections where there are people to use

them, at an average cost of \$2000 a mile the enormous sum of \$48,000,000 would be required. Should the work be carried into Central Oregon, where a great deal will be needed soon, the mileage would increase rapidly, while the cost of each mile might not be nearly so heavy as in other sections.

"Down in Central Oregon where roads are essential to the activities of the people, men are studying the problems of construction and maintenance. They are studying the means now before the people granting power to get the money with which to build roads. Business organizations have taken time to consider the various bills and give the benefit of study to the people who are busy building up the country. As a whole it is safe to say the people favor the bills granting the right to work on the highways, as it is considered the practical way to settle the labor problem. Many of the men who are making beginnings are opposed to the proposed wholesale bonding scheme, and prefer the Grange measures, 324 and 326, as a simple means of giving the people power to build highways and control the work themselves."

Parents Fight for Child.

A five-year-old boy, the only child of the couple, was fought for in Judge McGinn's court Monday in the divorce trial of Lottie Anna Evans against Ben Arthur Evans. Each was determined to have the child. Judge McGinn heard part of the evidence and then decided in favor of the mother. Not satisfied, George L. Masters, attorney for the father, put into the record considerable additional evidence to which the judge refused to listen, and the attorney announced that he will appeal to the Supreme Court. Mrs. Evans charged her husband with cruelty. He charged her with infidelity.
