BANK EXAMINER FILES SUIT Original Organizers of Defunct Depository Are Defendants. On behalf of the depositors of the defunct American Bank & Trust Company, suit was brought yesterday against the original organizers of the concern for \$15,000. The suit was filed by State Bank Examiner Wright and is founded on a charge of conspiracy and fraud. The defendants are G. W. Waterbury, E. C. Knoerschild, C. W. Miller, S. Logan Hays, James H. Alexander, John E. Davis and W. A. Curry. The complaint asks for judgment for the entire amount against each of the defendants, the object being to insure securing the entire amount from the solvent defendants. Attorney-General Crawford, L. H. Van Winkle and C. M. Idleman are the attorneys for the bank examiner.

Fire Warden Issues Order. OLYMPIA, Wash., Aug. 27.—(Special.)—Instructions have been issued by State Fire Warden Ferris to all county fire wardens and field men to see that as soon as conditions are favorable this fall, loggers, mill men and farmers burn over logged-off lands and log piles. "So far this season has been successful," says a letter written by Mr. Ferris to all county wardens, "but there are other years. Nearly all fires this year started on logged-off land or old works. This convinces us of the great necessity of burning over these tracts this fall, so that we may not have these hazards confronting us next year."
