ROME, Nov. 16.—Officers of the American battleships were present today at the ceremony in the Sistine chapel in connection with the coronation of Pope Pius X.

A large number of American sailors stood in line in the halls leading to the chapel to witness the passage of the pontiff, who was escorted by 25 cardinals.
