DEPARTMENT STORES PROTEST.—A committee representing department stores and other business houses of the city protested to Mayor Albee yesterday against the practice of drugstores being allowed to sell general merchandise on Sundays. It was declared that all stores excepting drugstores are required by law to close on Sundays and that it is not within the law for the drug establishments to sell general merchandise when the other stores are not permitted to do so. The Mayor promised to look into the proposition.

GAZETTE BLOCK TO GO.—The granite blocks which have formed the paving on Oak street from Sixth to Broadway for many years are to be replaced with a new bituminous pavement. Property owners on the street yesterday petitioned the city to start proceedings at once to repave the street. The petition resulted in the street being closed to traffic yesterday by City Commissioner Dieck. It will be about two months before the contract can be finally let and work commenced.

STREET SIGNS TO BE CORRECTED.—City Commissioner Dieck announced yesterday that incorrect street signs in the Sellwood district are to be changed at once. Several of the names of streets there have been changed within the last few years but the street signs have not been changed. In other places the old signs have been damaged or removed entirely. Later it is proposed to repair and change the signs throughout the city along the same line replacing those that are incorrect or damaged.

CURRENCY BILL LEADING TO OPTIMISM, DECLARED.

Eastern Men Do Not Anticipate Panic, Having Confidence in President Wilson, Says Business Man.

W. L. Morgan, president of the Morgan-Bushong Investment Company, owners of the Morgan building, returned yesterday from a two weeks' visit in New York City and parts of Kentucky and Tennessee.

"Business is good in the East," says Mr. Morgan, "and just as soon as Congress passes the currency bill it will be better."

"People in the East and South don't look for a big boom, but they confidently expect trade to be restored to a sound, substantial basis from which all parts of the country will derive material benefit."

"There will be no panic," is the opinion expressed by most Eastern business men whom Mr. Morgan met.

"Why?" he asked them.

"President Wilson won't permit it," was the reply almost invariably.

"I was surprised at first to meet with what I consider a remarkable feeling of confidence among Eastern business men in President Wilson," said Mr. Morgan, "they believe he is sincere and well fitted for his position. They are willing to give the new tariff law a fair trial and are inclined to feel optimistic over the proposed currency law."

Mr. Morgan also visited his former home in Kentucky. He reports that a rejuvenation of the agricultural lands of the South is in progress. In many instances the value of land has increased 50 per cent in the last two years. The increased production has justified the increased prices.
