PATTON AVENUE EXTENSION SOCIETY—Extension of Patton avenue by way of Maryland avenue down into Lower Albina, there to connect with Goldsmith street or Mississippi avenue, will be urged by the North Portland Commercial Club and the Overlook Club. R. M. Orth, president of the former organization, said yesterday that every effort will be made to get this extension under way after January 1. There are two routes, one by way of Delay street and one by way of Mississippi. The former route would require cutting through the Fisher block and the new concrete building of the Star Sand Company, which would be expensive if not prohibitive. The Overlook Club employed an engineer who has selected another route connecting with Mississippi avenue which may be adopted. The grades of both routes are moderate both for streetcars and other vehicles. This extension has been under consideration for the past year.

STREET IMPROVEMENTS COMPLETED—The improvement of Lombard street on the Peninsula has been completed from Washburn street to East Main at a cost of \$25,953. It is a hard-surface improvement. It is planned to continue this pavement to Albina avenue, and then on Albina to the Killingsworth avenue. Sewers are being put down on Albina avenue in advance of the improvement. This will complete a hard-surface system in the center of the Peninsula. The improvement of Fremont street has been finished from Lincoln Park to East Third-third street at a cost of \$25,452, and the assessment has been made. Minnesota avenue district improvement has been completed at a cost of \$15,784.

REQUIREMENTS FOR BONDS—New conditions for the certification and issuance of the bonds proposed by the Northwest Electric Company and the Anglo-California Trust Company, of San Francisco, were provided in a substitute mortgage filed for record yesterday in County Clerk Coffey's office. All of the property, and equities of the Electric Company are mortgaged to the San Francisco Bank to secure the payment of the \$10,000,000 5 per cent bonds issued by the company to construct the lighting and heating plant now in course of erection. The mortgage involved real estate in Clarke, Coville, Skamania and Klickitat counties, Washington, and Multnomah County.

SILVERSTONE ASKS \$50,000—Suit for \$50,000 damages for alleged libel was filed yesterday by Julius Silverstone, an attorney, against the Journal Publishing Company. The suit is brought because of what the attorney alleges to have been an untrue report of the testimony given by Harry Harris at his trial in Circuit Court last week. Harris, it is charged, mentioned the name of the attorney in connection with the collection of money from North End resorts, a part of which collections was to be paid to "higher-ups." The testimony was not pertinent to the issues at trial, it is alleged, and was given by a person who, the attorney said, the Journal knew was of questionable character.

INHERITANCE TAX RULING MADE—Over and above the \$5000 exempted by law from taxation, Mrs. Mary J. Anderson, widow of John A. Anderson, must pay an inheritance tax of \$222.90, 1 per cent on \$22,290.31. The order fixing the amount of the tax to be paid the estate was signed yesterday by Judge Cleaton. During her administration of the estate of her husband, Mrs. Anderson handled \$31,774.93. The expenses of the estate and the administration reduced the net estate to \$27,290.31, the amount inherited by Mrs. Anderson. All of this, except \$5000 exempted by law, is subject to an inheritance tax of 1 per cent.

LENTS LIBRARY GROWS—Figures show that the Lents Branch Library gave out 790 more books in November, 1913, than during November, 1912, or a total of 12,300. Owing to this increased patronage the substitute librarian will be at the branch to assist three afternoons weekly in addition to the two regular evenings. It is hoped to settle the question of a site for a permanent branch library in the near future so the new building may be erected next year.

McMullen formerly a district engineer in the city's public works department, now assistant county roadmaster, was appointed yesterday by City Commissioner Dieck a member of the city's committee on the standardization of improvement specifications.

NORTH BANK LAYS IRON—The North Bank Railway has started laying iron for the track that will enter Sullivan Gulch as far as East Eighteenth street. This track starts at East Second street near East Ankeny and crosses the lot occupied by the Pacific Iron Works and passes under the approach to the Burnside bridge. It is being built toward the gulch. It has not yet been decided whether the approach to the Burnside bridge will be raised or not in order to comply with the requirements of the Railway Commission. It probably will be raised or the track lowered some more.

BARNES SECURES JUDGMENT—Judgment for C. M. Barnes in his suit against Elizabeth E. Yates for the possession of a picture house and five housekeeping-rooms at East Twentieth street and Hawthorne avenue was entered by Judge Davis yesterday, who directed the defendant to settle with the lessor of the premises within two days or vacate the property. Barnes charged that the defendant made a lease for the property last July, to take effect October 1, and has failed to make payments according to the terms.

CITY TO GIVE NO PRESENTS—City employees are to receive no Christmas presents from the city this year as a result of the adoption recently of the "day later" system in place of the system whereby the men were paid by the month. Heretofore laborers, janitors and others have received a day's pay on Christmas and have not been required to work. This year they will receive no pay for the day. The plan affects about 560 men and will mean a saving to the city of about \$100.

ROBERT BURNS' MOTHER DYING—Robert Burns left Portland for Washington, Kan., Saturday to be at the bedside of his mother who is thought to be dying. Burns' brother, State Attorney of Kansas, notified Burns of his mother's illness and it is probable that the former of the Milwaukee Tavern will remain there to look after the family estate.

WESTERN UNION CASE CITED—Having received information to the effect that the Western Union Telegraph Company is operating a messenger service without the payment of a license, City Commissioner Bigelow has addressed a communication to City Attorney LaRoche asking him to investigate and take whatever action is necessary.

ALLEGED ROBBER ARRESTED—Dobson Simich, one of a duo charged with robbing the store of Jake Tony, at 273 Northrup street Saturday night, was arrested yesterday by Detectives Hyde and Vaughn. Simich, 35 years old, his alleged partner, was arrested Sunday. Both are in jail, being unable to obtain bail.
