

WILLIAM HANLEY TO SEEK SENATORSHIP

Burns Man Will Make Race as Independent, According to Intimate Friends.

NEWS CONFIRMS GOSSIP

Decision to Run Without Party Designation Due to Mix-up That Caused Him to Support President Wilson.

William Hanley, of Burns, will be an independent candidate for United States Senator from Oregon at the general election next November. While he is not ready to make his formal announcement, this information comes from personal friends, to whom he said yesterday that he had concluded definitely to enter the race.

They were not asked to keep the news secret. The information they gave confirms previous political gossip to the effect that Mr. Hanley would take a hand in the Senatorial situation. Mr. Hanley will attend the Oregon Congress which convenes in Portland next week, and he is now at the Hotel Benson with Mrs. Hanley.

Decision Due to Party Mixup. His decision to run as an independent is Mr. Hanley's solution of a party mixup that has occasioned considerable conjecture as to what party affiliation, if any, he would be a candidate under.

At the last Presidential election Mr. Hanley cast his vote and gave his support openly to Woodrow Wilson. This was, as he says, the first Democratic vote he ever had cast, as he had been a lifelong Republican and a party leader in his section of the state for many years. Feeling that in the three-cornered fight, Mr. Taft had no chance of election, and that Mr. Roosevelt ought to be defeated, he allied himself with the Wilson forces.

In running as an independent candidate now, he will do so with the promise to support President Wilson and his present policies.

Nomination by Petition Is Plan. Mr. Hanley will not, of course, compete in the primaries, but will be nominated by petition. As he is one of the most widely known men in the state, his friends figure that it will be an easy matter, prior to the general election, for him to obtain the necessary number of signatures to his petition.

Mr. Hanley has long been active in work for the development of Oregon. He is president of the State Irrigation Congress, president of the Central Oregon Development League and vice president of the State of Oregon Development League. In December, 1913, he was one of the delegates to the National Conservation Congress at Washington.

He is a believer in the principle of having the people of the state develop their own resources. He was born at Jacksonville, Or., just 53 years ago next day, and has lived in Oregon all his life.

Two announced candidates for United States Senator already are in the field. These are R. N. Felt, of Clatskanie, a candidate for the Republican nomination, and George B. Chamberlain, an ex-United States Senator from Oregon, a candidate for the Democratic nomination. A few days ago, in a letter published in the newspapers, gave out what is considered by many as his preliminary statement before formally announcing himself.

PRINTING TEACHER NAMED

A. W. Lawrence to Instruct Jefferson High Class.

A. W. Lawrence, one of the representatives from Multnomah County in the last session of the Legislature, has been appointed to teach in the new printing department which is to be established in Jefferson High School, and will begin supervising the installation of the plant and the organization of the work Monday. A class of about 25 will begin the course under him. The work is comparatively small, but it is expected that it will be enlarged rapidly as the demands for instruction in that line of work increase.

In addition to acting as a practical shop for preparing pupils to enter on a substantial basis as apprentices in regular shops of the city after graduation, the Jefferson High School shop will be used to care for a good portion of the printing work of the school district.

JUDGE SYDNEY FOX DEAD

Son of Late Dr. J. N. Fox, of Portland, Dies in Montana.

Notification came to Portland last night of the death of Judge Sydney Fox at Red Lodge, Mont. He died yesterday, after a short illness of pneumonia. Judge Fox was the son of the late Dr. J. N. Fox, of Portland, and his mother, his daughter, Virginia, and two unmarried sisters live in Portland. Before moving to Montana about 25 years ago, Judge Fox was a member of the firm of Dolph, Mallory, Bellinger & Simon. In Montana he was engaged in practice at Big Timber, Helena and Red Lodge and served for six years as Judge of the Thirteenth Judicial District of Montana. Eight years ago he married Elizabeth Bradley. They have one child, who survives her parents, has been living with her grandmother, Mrs. J. N. Fox, in this city.

JOB FOR IDLE MEN SOUGHT

Thomas Withycombe Advertises in Behalf of Unemployed.

If every 100th person in Portland would do as much to alleviate the suffering of the conscientious unemployed as Thomas Withycombe, of 432 Twelfth street, has done, no more would be heard of the urgent necessity of providing labor.

Last Sunday Mr. Withycombe, through the columns of The Oregonian, offered to serve without pay as an individual employment agency. He invited requests for land-clearing labor, and offered to list all applications for such jobs and take or send the men to the work. He will provide the workmen, as far as possible, with tools and utensils. Already he has found employment for a large number of men, and letters are coming in every day in answer to the invitation. Here is an example:

Sheridan, Or.—Dear Sir: Saw your advertisement in The Oregonian about getting work for the unemployed and request for farmers and landowners to communicate with you. I wish to state that I have about 100 acres of stump land which must be cleared, but which must be done by contract. The price for clearing this land is between \$40 and \$45 per acre.

This job would afford employment for 50 men for some little time if it were arranged. The man must, however, have his own tools, cooking utensils and necessary tools and board himself.

BLUEJACKETS LAND TO STOP PILLAGING

American Forces Act Under Order to Protect Interests of All Foreigners.

Peaceful Entry Desired. The diplomatic representative at Port au Prince is making efforts to assure the peaceful entry of the Zamor brothers. Latest reports from Captain Russell, of the battleship South Carolina, at Port au Prince, expressed apprehension for the safety of the city. However, he reported no organized efforts to expel the foreign naval forces police, though his earlier reports indicated dissatisfaction by natives generally at the presence of the sailors and marines ashore.

Captain Russell is expected to carry out the request if it becomes necessary for his judgment to protect life and property. In view of the threats of rebel leaders.

Armory Is Field Camp.

The south section of the big main floor of the Armory was transformed into a field artillery camp last night, with field guns in position, horses

tethered to a picket line, tents pitched in a half circle, a commissary department in full blast and a guardhouse yawning for breaches of military etiquette. The occasion was the celebration of the 48th anniversary of the organization of Battery A, Field Artillery, Oregon National Guard, the oldest military organization in the West.

Long camp tables were placed on three sides of a roaring baseburner stove, which acquired itself capably in the role of a campfire.

There was a full attendance. Many former members of the battery were present, and a movement was started to organize them into an association to participate with the battery in its social affairs.

A four-page newspaper, The Shrapnel, was published during the evening. It was filled with articles relating to military affairs. Its editorial page was graced with a column of editorials from the pen of Colonel James Jackson.

Captain Hiram U. Welch, commander of the battery, was toastmaster, and the speakers were Adjutant-General Finzer, Colonel Jackson, Colonel Sam White, Harvey O'Bryan and Professor E. D. Curtis, a former officer of the battery.

Red-hot war news was received from Mexico, and the Huerta army was even reported to have effected a landing on the Columbia. A zone of peace was brought in, unconscious with fright, and was only resuscitated when he caught sight of the vanishing banquet.

AUDITORIUM SITE IS UP

COMMISSION EXPECTED TO FAVOR MARKET BLOCK.

Executive to Be Held Today to Consider Location and Early Building Is Desired.

The Auditorium Commission will hold an executive session this afternoon to consider the site for the proposed structure. At this meeting the suggestions of the three preceding public sessions will be discussed. It is probable that the Commission will recommend to the City Commission that the Auditorium be erected on the Market block site with the funds now available for the purpose.

At the last meeting, Commissioner Brewster said only about \$50,000 would be available for a site. The extra land that must be acquired adjacent to the Market block site is already the property of the city, will cost, it is estimated, not to exceed \$65,000. Among all of the suggestions of other sites brought before the commission at previous meetings no site was mentioned that would be available at a sum anywhere near this figure, and it was made fairly clear that the exchange for the Lincoln High School site or the Armory site could not be made at this time.

The Commission has declared its intention to begin the erection of the building as quickly as possible, according to the urgent suggestions from the Commercial Club and other organizations of the city, and the preponderance of sentiment expressed at the last public session appeared to favor the Market site. These reports lead to the general opinion that the report of the Commission will recommend the Market site.

HUNDREDS PAY LAST TRIBUTE TO FRANCIS XAVIER MATTHEW.

Willamette Valley Towns From Portland to Salem Represented at Services Conducted at Butteville.

Pioneers of the Willamette Valley from Portland to Salem, as well as the entire population of Butte
