

OHIO BOXING RULES
HELD UP AS GOODState Commission Opens Guns
on Ring Nuisances and
Promise War.

THIRD "SECONDS" TARGET

New Regulations Limit Number to
Be Allowed on Stage—Present
Method of "Breaking" by
Referee Is Scored.

The Ohio Boxing Commission has the right idea. The latest rule which it champions is one which forbids, absolutely, anyone standing about the ring or on the stage with the exception of the referee and two seconds for each man.

Third seconds and those nuisances who occasionally get near the corner posts and disturb the equality of all present will be dealt with summarily by the boxing commission of the state. The penalty for this form of pest has not been announced, but the nuisance is probably no more popular there than it is here.

The commissioners know what they would like to do and just how much they dare do without getting called in for murder in the second degree.

The question of "breaking" boxes by the referee was also scored. If the first warning to "break" is unheeded, the referee shall bring them apart by force if necessary.

Contracts will be insisted upon between even the preliminary fighters. These must state the amounts, the time of paying and the commission will see that they are enforced to the letter.

The "weighing in" will take place before the commission's physician in the afternoon previous to the fight. The weights will be official and will be announced.
