

WOMAN REMOVED IN ACCUSING SENATOR

Mrs. Bond Testifies Health Is Permanently Impaired Because of Attack.

HINT OF DEFENSE IS GIVEN

Cross-Examination Goes Into Acquaintance With Gore's Political Enemies, With View to Establishing Motive.

OKLAHOMA CITY, Okla., Feb. 12.—Mrs. Minnie E. Bond told a jury in the District Court today of the indignities which, she declared, she suffered at the hands of United States Senator Gore, of Oklahoma. She described the attack, which she alleged occurred in a Washington hotel March 24, last, the basis for the suit on trial, in which Mrs. Bond asks \$50,000 damages.

Meeting at Hotel Described. According to Mrs. Bond, she met the Senator in Oklahoma several years ago and went to Washington last Spring, when her husband, Julian Bond, was a candidate for appointment as internal revenue collector here. She visited Senator Gore in the interest of her husband's candidacy at his office, she said, where on two occasions, she charged, he seized her.

Because of the number of men about the Senator's office, she refused, she said, to make further visits there and by arrangement he met her at her hotel, March 24, when, she alleges, he caught hold of her and threw her across a bed. In her efforts to free herself her eyeglasses were broken, her face scratched and her hand lacerated, she said. In cross-examination she said her health had been impaired as the result of the alleged attack.

Mrs. Bond was questioned by attorneys for Senator Gore as to her acquaintance with politicians in Oklahoma, laying the foundation, it is believed, for introduction of testimony in support of their contention that the suit is the result of a political conspiracy. Senator Gore is a candidate for renomination at Oklahoma primaries in August.

Women Sit Facing Each Other. Mrs. Bond, a mild-mannered woman and rather frail in appearance, maintained her composure throughout the examination. Mrs. Gore, wife of the defendant, sat directly opposite Mrs. Bond throughout the day and frequently the gaze of the two women met. On cross-examination, the witness admitted that she had been married to her former husband, a man named Farrer, two times, the second time because he had not been divorced when they first married in June, 1903. She said they had a child born in December, 1903, but she did not know what had become of it. The defense offered to introduce a copy of her petition for divorce from Farrer, but Judge Clark ruled it out.

Office-Seekers Are Disappointed. All the witnesses heard today in support of Mrs. Bond admitted that they failed to accomplish the purpose of their visit to Washington last Spring—appointment to Federal positions. Earp said he had a promise of one of three positions; Fitzpatrick sought appointment as attorney-general in the Department of the Interior, and Robertson said he was there expecting to obtain a place in the Interior Department in the event Robert A. Rogers was named as Secretary. Robertson also asserted that James R. Jacobs, in whose apartment at the hotel the attack on Mrs. Bond is alleged to have been made, was seeking appointment as United States Marshal for the Eastern District of Oklahoma. Jacobs also was not appointed. He will be called as a witness for the plaintiff tomorrow.

Earp asserted he acted as an emissary for Senator Gore in an effort to arrange matters with Mrs. Bond and have her leave Washington. He visited the Oklahoma Senator the morning after the alleged incident to ask concerning his candidacy for a Federal position. "Doc, they set a trap for me and I walked into it," Earp testified. Gore said to him, "I would like to see Mrs. Bond and get her out of town."

Woman Does Not Leave. He testified Gore told him to promise Mrs. Bond anything, but not to use his name. Earp advised Mrs. Bond to leave Washington, but that she did not do so. Robertson and Fitzpatrick, as eyewitnesses to the alleged occurrence, corroborated in substance Mrs. Bond's narrative. Fitzpatrick said Jacobs' apartment was selected for the conference between Senator Gore and Mrs. Bond because the hotel parlors were crowded and Mrs. Bond's room had not been put in order. Attracted by the noise, he went to the hall and had a view of the interior of the room through a partly open door.

On cross-examination, Fitzpatrick admitted that he told a friend that if Robertson were appointed a deputy United States attorney the matter would end. He also said he had reported the matter to the Attorney-General of the United States. Robertson's testimony was much the same as Fitzpatrick's. It was testified that he had expressed himself as aggrieved and had "cussed out" Gore, but denied having said to a Washington hotel man that he would "get" the Senator or that if Gore would pay \$25,000 to "hush the matter up" he would be able to repay a small debt he owed a man here.

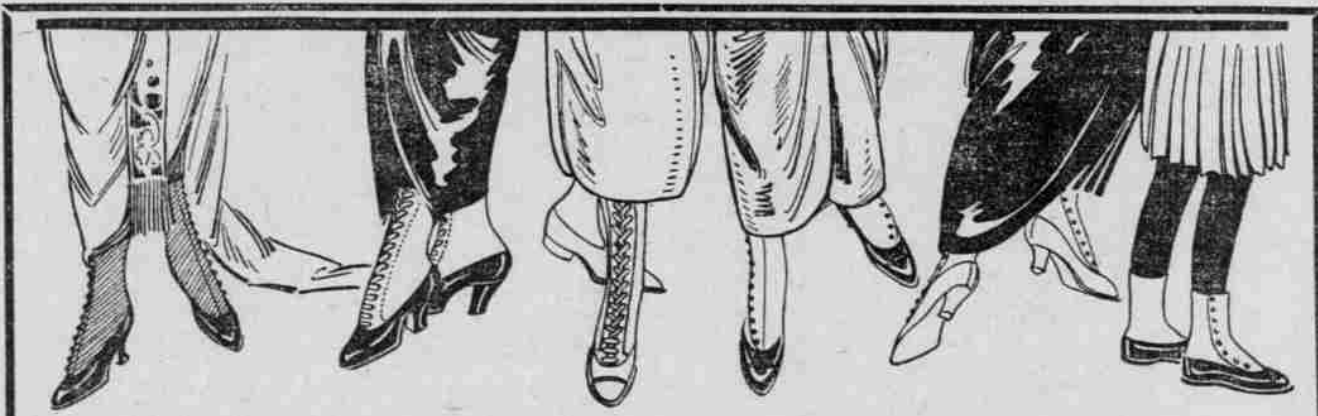

WILSON IN BED WITH COLD President's Illness Is Slight, but Precaution Is Taken.

WASHINGTON, Feb. 12.—President Wilson spent today in bed pursuing cold. All engagements were cancelled and he received only Governor Fielder, of New Jersey, who had come to attend the reception at the White House tomorrow in honor of officials of the President's home state. The New Jersey Governor and the President talked reminiscently of New Jersey affairs. The dinner which was to be given for the President tonight by Postmaster-General Burleson and the President were similarly cancelled. Dr. Cary T. Grayson, U. S. N., the President's physician, said the President's cold was only a slight one, but he thought it best to keep his patient indoors as a precaution. The President expects to be able to receive the New Jersey folk at the White House reception. About 800 have been invited.

EPIDEMICS RAGE IN ARMY HUNDREDS OF FRENCH TROOPS GO TO HOSPITAL—SCORES DIE.

Outbreak of Contagious Diseases Said to Be Due to Overcrowded Condition of Barracks. PARIS, Feb. 12.—Epidemics of scarlet fever, pneumonia, cerebro-spinal meningitis and scarletina have broken out in a serious form in the French army. Today's figures, which are incomplete, show that 800 soldiers are in the hospitals suffering from these diseases at Toul, where there have been 40 deaths from these causes among the troops since January 1. BIG BALLOT PROMISED CALIFORNIA TO VOTE ON INNUMERABLE MEASURES.

Twenty-Three Amendments, Initiative and Referendum Petitions and Many Candidates Appear. SACRAMENTO, Feb. 12.—The ballot for the November election in California promises to be exceedingly large. On it will be 23 constitutional amendments passed by the last Legislature, to be submitted to popular ratification, each of which must have its title printed in full on the ballot. Also it will carry four referendum petitions, six initiative petitions and an amendment to the Torrens land act for the simplification of real estate titles and transfers and poll tax abolition. SWEDISH LIBERALS ALOOF King Calls on Conservatives to Take Up Government.

STOCKHOLM, Feb. 12.—The refusal of the liberals to accept office has compelled Baron de Geer to withdraw from the task of attempting to form a cabinet. The King tonight invited the conservatives to take control and it is expected that M. S. A. A. Lindman, ex-Premier and Minister of Marine, will assume the Premiership. Dissolution of the riksdag will follow immediately.

HUNGER STRIKE IS BRIEF Blacks in San Quentin Prison Eat After 18-Hour Fast.

SAN FRANCISCO, Feb. 12.—The first so-called hunger strike on the Pacific Coast collapsed tonight after an experiment of 18 hours. Due to friction between whites and blacks, 125 negro convicts in San Quentin were segregated yesterday. In protest, a majority of blacks refused to eat yesterday. All but five or six ate today. There has been no disorder. Warden Johnston said today that the order had not originated in any idea of race discrimination, but was intended to remove the source of minor disorders.

PROFIT FOR PUBLIC IDEA BRITISH COLUMBIA BILL PROVIDES SHARING OF TIMBER EARNINGS.

Measure Introduced at Victoria by Minister of Lands Expected to Stimulate Industry. VICTORIA, B. C., Feb. 12.—An entirely new plan in public policy is embodied in a bill presented today by William R. Ross, minister of Lands, in the British Columbia Legislature, providing for adjustment of all timber royalties. It introduces the principle of profit-sharing by the people in industries which utilize natural resources. The bill provides a comprehensive plan for fixing the price of timber cut on limits leased by lumbermen. Under the British Columbia system, lumbermen may lease timber land by paying a royalty per thousand feet on

Scientist's Widow Rewarded.
