American Citizenship Taken to Work for Currency Reform, Committee Is Told.

SACRIFICE DECLARED BIG

To Bring What He Terms Great Constructive Work Into Operation, Reserve Board Member Says Other Connections Given Up.

WASHINGTON, Aug. 12.—(Special).—Paul M. Warburg told the Senate committee on banking, according to the report of the testimony made public today, that as a member of the Federal Reserve Board he would leave Kuhn, Loeb & Co. as well as his Hamburg firm and all other corporate connections. Also, he said, he intended to leave every educational and philanthropic association with which he was connected.

Mr. Warburg told the committee that his chief purpose in becoming a naturalized American citizen in 1911 was to bring currency reform in this country.

Great Sacrifice Admitted. "A sacrifice, yes," Mr. Warburg replied. "I think it will be a bigger sacrifice than any of these gentlemen around the table has any idea of."

Law's Weakness Pointed Out. The present currency law Mr. Warburg deemed superior to the Aldrich bill in that, dealing with the entire country, it gives different rates of discount while the Aldrich bill provided a uniform rate of discount.

Questioned as to his politics, he said that primarily he was a Republican, but that in the last contest he was for Wilson.

Whether Six of Seven Initiative Measures Are Entitled to Places on Ballot Is Question.

OLYMPIA, Wash., Aug. 12.—(Special).—When the Thurston County Superior Court today started the series of tests to determine whether the initiative measures are entitled to places on the ballot, backers of the measure No. 11, the proposed fish code, radically increasing the scale of licenses, is denied ballot space, a campaign would be inaugurated immediately to bring before the voters the next Legislature under the Washington law.

Should initiative signatures be assured, the Legislature would be compelled either to pass the measure or submit it and any substitute bill that might be enacted at the 1916 election.

Twenty-seven different classes of questioned signatures are subjects of litigation, 15 classes are under official count and 12 are under official count.
