RERKELEY, Cal., March 5 .- The Hague peace conference under its pres-ent status is useless to prevent war, de-ciared August Schvan, ex-Chamberisin to the King of Sweden and lecturer for the Carnegie Foundation, in an address to the students of the University of California today. "All nations should disarm and a su-

preme world court of one judge for every 5,000,000 of population, not more than 10 from any one country, should be established to rule on every question arising among nations. With it a police force, including a navy, should be main-tained," he said.


