

BRYAN APPEARS AS WILSON'S DEFENDER

Ex-Secretary Tells Convention United Party Is Prepared for Battle.

MEXICAN POLICY UPHELD

Annexation Is Declared Next Step After Intervention and Speaker Fears Cry of "On to Panama" Will Go Up.

COLISEUM, St. Louis, June 15.—When William J. Bryan addressed the Democratic National Convention here to-night, under suspension of the rules necessitated by the fact that he was not a delegate, he opened by expressing his appreciation of the honor conferred by the invitation to speak to the convention. "Every Democratic convention is a lovefeast to me," he said. "It gives me an opportunity to meet and renew acquaintances with men with whom I have been associated in politics for more than 20 years."

He paid his respects in complimentary manner to Democratic officers and leaders of the present convention.

Reviewing the struggles of the Democratic party, Mr. Bryan said:

"After 16 years of waiting, our party entered the White House and fortunately we won the Senate and House at the same time. Our party became responsible for National affairs and now we come after three years of labor to make our plans for the future and to submit to the American people the claims of our party to continued confidence."

"Whatever differences of opinion may exist, or may have existed, as to particular measures or particular acts, we are here to begin the fight of 1916, a united party in every state in the Union, ready for battle."

Administration Is Defended.

"Today those who stand for the Democratic party are able to go before this Nation and not only give a reason for the faith that is in them, but give a defense of the Administration's claims to the confidence of the people."

"You may take all the Administrations from the beginning of our history as a Republic to the beginning of the present one, and you will not find as many laws written upon the statute books of greater importance to the people as you will find written in the last three years by Woodrow Wilson, a Democratic President."

Briefly Mr. Bryan then referred to the tariff revision, the Federal reserve law and the strengthening of the anti-trust laws.

"Here were three great measures, carrying out the promise of a Democratic platform, and these three great measures constituted a record of achievement that the Republican party dare not attack," he said.

"The electorate before which the Republican party must now go is controlled as the convention at Chicago was by the expert representatives of the favor-seeking corporations."

Federal Reserve Law Praised.

"No President in our history," said Mr. Bryan, "has had so much as an unholy combination of the powers of high finance and even Jackson himself never met a situation better than Woodrow Wilson met it. We have just commenced to learn what the Federal reserve law means for this Nation."

"This great piece of legislation, the greatest piece of constructive statesmanship in a generation, has not only broken the grip of Wall Street upon the business of the nation, but it has broken the grip of Wall Street upon the politics of the United States. For 20 years there has not been an election but what a hundred men in Wall Street could, by coercion they had in their power, change the result of the election. Another one who, like myself, has felt their power, must be pardoned if he rejoices that the United States Administration that has broken the power and set a Nation free."

"While our President and our Congress were at work on this splendid pyramid of performance, a war came that threw upon this Administration such burdens as no President has had to bear within the last 50 years. We inherited from a Republican Administration a revolution in Mexico. This Administration has dealt with that situation and the Republican party dare not challenge a verdict before the country on the Mexican question."

Annexation of Mexico Feared.

"We have a few men interested in ranches and a few interested in mines, who would use the name of American soldiers to guarantee profits and their investments in a foreign land."

"Why, my friends, if President Wilson yielded to the demand of men who have clamored for intervention in Mexico, we would no sooner have crossed the line than the same men would tell him that the soldiers must never come out, for, my friends, annexation is the next step after intervention has been undertaken. And."

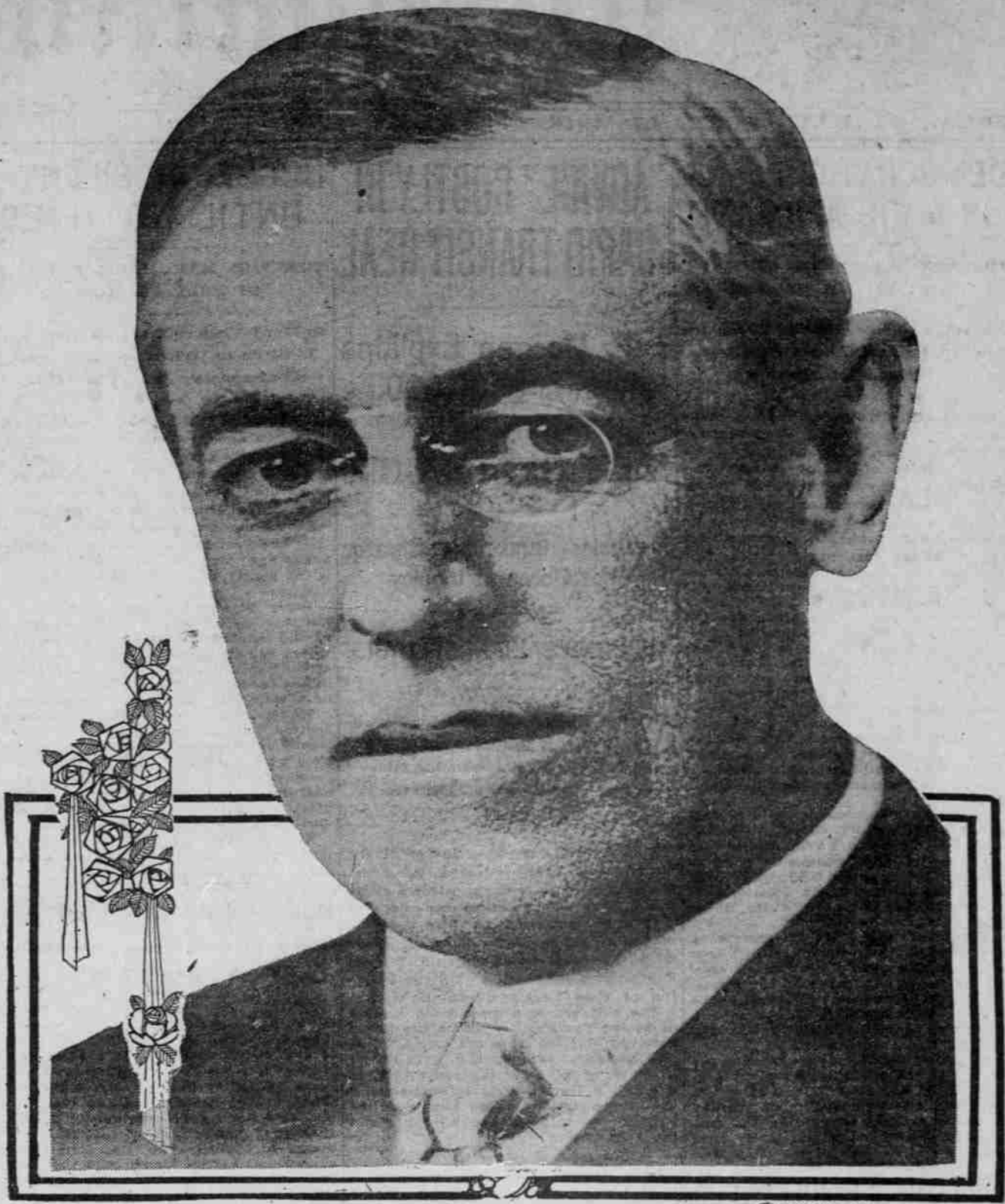

"But, my friends, the President not only has had to deal with war to the south of us, but with war to the east of us. My friends, I have differed from our President on some of the methods employed in that war, but I am one of those who desire that this Nation shall not become a participant in the dreadful conflict."

"We have a record upon which we can appeal to the people for their support, without fear and without blush. I believe the American people, grateful for what this Administration has done, grateful that we have peace in this country while war stalks through out the world, will not be unkind to the country the horrors of that war."

"My friends, I believe that there is now before this country an opportunity such as no other country has had since the beginning of time. I believe that God, in his providence, has reserved for the United States the honor and the task of lifting the moral code that governs individuals up to the level of nations and making it a part of the code of all nations."

"I understand this Nation's opportunity and this Nation's task, it is to lead the world away from its false philosophy and help it to build its hope of peace on the enduring foundation of love and brotherhood and co-operation."

would not only impair but limit their earning power. It would wipe out wage increases that the men have fought for and gained during the last 25 years from individual railroads and systems, they assert. The monthly remuneration of certain engineers would be reduced by \$25, they assert, while certain firemen would suffer cuts averaging \$30 to \$40 a month.

Whereas under the present rules, the men say, an engineer or brakeman, for example, now receives pay for two full days for performing a duty other than that prescribed in his class of work within one working day of 10 hours, under the railroads' ten-hour plan he would receive pay for only one day and eight hours and the new overtime rate for overtime no matter what the varieties of duties assigned him.

OIL WELL Drilling Resumed.

CENTRALIA, Wash., June 15.—(Special.)—John Young, of Aberdeen, general manager of the Pacific States and Morgan Oil companies, which combined about a year ago, was in Centralia today, and stated that drilling has been resumed at the Pacific States well, located at Meadows, six miles west of this city. Three thousand feet of 8 1/2-inch casing has been delivered at the well, and this additional depth will be drilled if necessary. The well is at present down 1500 feet, 10-inch casing having been placed up to this time.

Democrats Nominate Wilson and Marshall, as Expected.

UNANIMOUS ACTION TAKEN

Confusion Reigns at Night Session of St. Louis Convention—Prominent Leaders Are Marooned Outside of Coliseum.

for the sudden order to bring the convention to a close, and it is believed their losses are heavy.

When the gravel fell calling to-night's session to order, John W. Westcott, of New Jersey, who nominated President Wilson at the Baltimore convention, was ready on the floor to deliver the speech of renomination; Senator Kern, of Indiana, to renominate Vice-President Marshall and John H. Atwood, of Missouri, to deliver the speech nominating Governor Major for the Vice-Presidency.

Fire Department Takes Charge.

Before the convention was called to order the fire department took charge of the entrances and permitted no more to come in. William J. Bryan, however, managed to get by and got his usual uproarious reception as he took his seat.

At 9:15 o'clock Chairman James rapped the convention to order. The Rev. W. J. Hardesty, chaplain of the Missouri Senate, offered a prayer.

The gavel long enough to hear the prayer and then renewed its demands for a speech from Bryan. Chairman James admonished the galleries.

Senator Thompson then moved a suspension of the rules to permit Mr. Bryan to speak. The motion was put there were some "noes," but the chairman ruled two-thirds had voted in favor.

A committee headed by Senator Kern, of Indiana, escorted Mr. Bryan to the speaker's place, while the floor and galleries roared their approval.

Police Battle With Crowds.

Senator James introduced Mr. Bryan as "one of the leading citizens of the world, and America's greatest Democrat."

Outside the hall meanwhile had the crush become so great that the police fairly battled with besieging throngs. Several arrests were made. Ticket speculators were quoting "a last-instantaneous" rate of \$1 apiece.

Senator Hughes, of New Jersey, asked in the role of an officer of one of the entrances, aiding the police in trying to control the crowd.

While Mr. Bryan was speaking word came in from time to time of leaders marooned outside and of more than 200 delegates who could not enter. Rescuing parties of officers went out and got them inside. Norman E. Mack, the National committeeman from New York, and Charles F. Murphy, leader of Tammany, were among those who struggled for nearly an hour to gain recognition before getting through the lines.

Marooned Delegates Rescued.

Chairman James directed the police to go to the entrances and admit all delegates, alternates and members of the press marooned outside. Ticket speculators were quoted as saying that the roll of the states was called for nominations. Alabama yielded to New Jersey, and Judge John W. Westcott began his speech nominating President Wilson.

Applause was given to Judge West-

cott's remarks on the Administration's policy toward Mexico. The crowd was attentive and quiet. It voiced approval of America's maintenance of international law. Some of the crowd, however, were eager for the nomination.

"Name him, name him," came cries from the galleries.

Judge Westcott hastened a little and concluded his speech renominating the President at 10:49 P. M.

When Judge Westcott closed with a mention of the name "Woodrow Wilson," the crowd broke into a great demonstration. Moving picture flashlights blazed and flags were paraded in front of the stand. The band played "The Star-Spangled Banner" while a huge banner bearing the President's likeness was unfurled from the roof of the hall. The delegates began a parade bearing state stanchions.

Woman delegates were among the paraders in the aisles. Senators and Representatives helped carry banners. Senator Hughes personally bore the New Jersey flag.

Crowd Joins in Singing Medley.

Sergeant-at-Arms Martin stirred up the enthusiasm by waving the Texas "Lone Star" flag over the heads of the crowd from the chairman's rostrum. Other state flags were taken to the platform, and the crowd joined in singing a medley, including "How Dry I Am," "Old Black Joe," "The Red, White and Blue," and others.

After the demonstration had been under way 30 minutes, New York and some other delegates resumed their seats. Waving a cane over the rail at the chairman's desk, Senator Hughes renewed the clamor by leading three cheers for the President.

The band exhausted the list of popular airs, then turned to "Tipperary" and "The Girl I Left Behind Me." Some of the delegates stopped demonstrating long enough to drain pop bottles and then went back at it again. There was no attempt to control the crowd while the demonstration was going on. The crowd roared and several women suffrage workers with golden umbrellas and yellow sweaters mounted the platform and held a suffrage umbrella over the head of Representative Heflin, of Alabama, one of the most vigorous "antislavery" Congressmen. He apparently enjoyed the situation.

The band, its repertoire taxed, turned to such ancient ballads as "On the Banks of the Wabash" and "Turkey in the Straw."

When all but a few delegations had taken their places, apparently ready to go on, and at 11:30 Chairman James rapped the first gravel rap. The demonstration had lasted 45 minutes.

Delegates Clamor for Vote.

The rollcall of states was resumed and Arizona yielded to Ohio. Governor Hammond, of Ohio, made the first second speech in behalf of President Wilson.

The second speech in seconding the President's nomination was made by Governor Stuart, of Virginia, to whom the Arkansas delegation yielded. Referring to Virginia as "the mother of Presidents," Governor Stuart referred to the President as "her illustrious son."

The delegates wanted to wait no longer and cried, "Vote! Vote!" On motion of Senator Hughes, of New Jersey, the rules were suspended and no ballots whatever were taken. The delegates simply roared, "Aye" when the names of Wilson and Marshall were called.

Chairman James declared them nominated by acclamation. Senator Kern, nominating Vice-President Marshall, had discarded a long prepared speech, and simply said:

"I nominately Thomas Riley Marshall."

The nominations of both candidates were completed four minutes before midnight.

The convention waited for a time in the hope of completing its work by acting on the platform. Learning, however, that the committee on resolutions was not ready to report, it took recess at 12:31 A. M. until 11 o'clock this (Friday) morning.

Traveling Man Passenger.

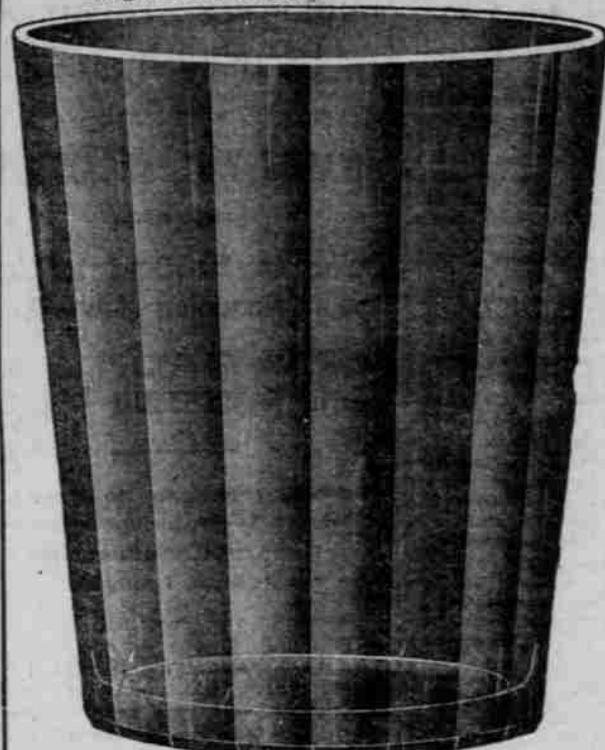

LABOR DRAWS SWORD

COUNCIL WITHDRAWS FROM MEMBERSHIP IN CHAMBER.

Adjustment of Strike Predicted, but Declaration for Open Shop Stirrs Up the Delegates.

Representatives of the waterfront unions expect a speedy adjustment of the strike situation, according to information brought out at the meeting of the Labor Council last night.

The executive board of the council reported that it had taken no official action to brand the river boat "unfair," owing to the fact that representatives from the waterfront had declared the expected disagreements to be settled shortly.

On the advice of E. J. Stack, secretary, the council requested the State Federation of Labor to appoint a committee to consider the advisability of consolidating the various boards and commissions now handling labor problems in the state.

The council heartily favored a Fourth of July celebration.

When it was announced that the Chamber of Commerce had declared for the open shop at a meeting of the board of directors, action was taken by the Labor Council withdrawing from membership in that body. A committee was appointed to take up a fight against the action taken by the Chamber of Commerce.

Eugene E. Smith, president of the council, declared that the board of directors of the Chamber of Commerce had repudiated the fundamental principle on which that body was organized, the principle of "All for one and one for all."

"I think the Chamber of Commerce is due for a fight," he declared, "and it is up to us to lead it."

ROAD TAX IS APPORTIONED

Marion County Court Divides \$13,625.23 Among Towns.

SALEM, Or., June 15.—(Special.)—The Marion County Court today made its apportionment of the 1916 four-mile road tax among the cities and towns in the county whose charters give them jurisdiction over the roads and streets within the corporate limits. The total amount apportioned was \$13,625.23, divided as follows:

Aumville, \$516.13; Aurora, \$732.34; Gervais, \$439.80; Hubbard, \$383.61; Jefferson, \$912.36; Mount Angel, \$1352.75; Silverton, \$4146.66; Turner, \$668.20; Woodburn, \$3719.55; Butteville, \$52.43.

SUFFRAGISTS NOT PLEASED

Democratic Declaration for Submission by States Unsatisfactory.

COLISEUM, St. Louis, June 15.—Leaders of the woman suffragists, who have spent the last four days in St. Louis in behalf of a platform declaration for Federal action to secure the ballot for women, were disappointed tonight when they learned that the resolutions sub-committee of the Dem-

ocratic National committee had agreed on a suffrage plank recommending that the question be submitted to the people of the various states at once by their Legislatures.

Failure of the convention to declare that suffrage is a matter for Federal action, they said, will result in personal appeals to President Wilson to urge action by Congress and upon Charles E. Hughes, Republican nominee, for a statement of his views on the question.

T. R.'S INJURY IS SLIGHT

X-Ray Shows That Small Tendons Attached to Ribs Have Snapped.

NEW YORK, June 15.—The X-ray examination made to determine the condition of Theodore Roosevelt, who suffered an attack of pain in his side yesterday, disclosed that several small tendons attached to one of his ribs had snapped, the Colonel told inquirers today.

He said that his physician had assured him, however, that the injury due to his violent coughing, was not serious and would heal in a few days if he remained quiet.

British Advance Is Checked.

CONSTANTINOPLE, via London, June 15.—The repulse of an attempt to advance made by the British force that remained on the Tigris below Kut-el-Amara, after the surrender of General

Townsend, was announced by the War Office today.

The engagement occurred on the right bank of the river, near Felahie.

STATE TO AID MULTNOMAH

\$5000 Will Be Taken From Wasco County Fund Not Used.

SALEM, Or., June 15.—(Special.)—To finance the survey of a road connecting with the Portland city streets and the state highways south of the city, the State Highway Commission today decided to divert \$5000 from the amount allotted to Wasco County for road work, if it is found that Wasco County will not do the work contemplated this year.

From information which the commission now has, it appears improbable that Wasco County will vote bonds for road construction before the general election in November, and if bonds are voted at that time, it is not thought likely that work can be started before next year. The commission allotted Wasco County \$45,000 for road work this year and an equal amount for next year.

Aliens Asked to Resign.

LONDON, June 15.—The Chamber of Commerce today passed a resolution requesting all members of German, Austrian birth, even if naturalized subjects of Great Britain, to resign.
