

JUDGE ESTABROOK TO SPEAK TONIGHT

New York Orator Delivers
Hughes Talk From Stage of
Eleventh-Street Theater.

H. H. PEARCE IS CHAIRMAN

Committee of Prominent Men Will
Welcome Distinguished Visitor
to City and Occupy Seats
on Platform.

Henry D. Estabrook, of New York,
a lawyer and orator of national reputa-
tion, will deliver a Hughes address
tonight at the Eleventh-Street Theater.

The meeting will be held under the
auspices of the Young Men's Republi-
can Club. Harry H. Pearce, president
of the club, will call the meeting to
order and introduce George L. Baker
as chairman of the evening. Mr. Baker
in turn will introduce Mr. Estabrook.

Mr. Estabrook is due to arrive in
Portland on the Shasta Limited at 1:50
o'clock this afternoon from San Fran-
cisco. He is to be met at the Union
Depot by the following reception com-
mittee appointed by the Young Men's
Republican Club:

Members of the committee will also
sit on the stage at the theater during
the meeting, which begins at 8 o'clock.
Boxes at the theater will be reserved
for the various Republican candidates.

Mr. Estabrook is widely distinguished
as an orator. He was chosen by the
Lotus Club, of New York, to deliver the
principal address at the reception given
Governor Hughes after his re-election
as Governor of New York in 1909. In
the course of his address, Mr. Estabrook
said of Mr. Hughes:

"He is a great lawyer, who has been
true to the best ideals of his profession
because, best of all, he has been true
to the ideals of an honest gentleman;
a lawyer who only a few years ago
was almost unknown, but who rose to
the knock of opportunity and to-
night is world-famous, world-admired,
applauded, trusted and venerated."

The Lotus Club again chose
Mr. Estabrook to deliver the address
at the reception given Governor Hughes
after his appointment to the Supreme
Court of the United States. He con-
cluded by reading from a Thanksgiving
proclamation issued by Governor
Hughes, and said:

"These words, gentlemen, were writ-
ten by our honored guest when Gov-
ernor of New York; and if I were per-
mitted to add to them, it would be sim-
ply to thank God for the man who
wrote them."

Representative McArthur, who will
also speak briefly at tonight's meeting.

Another speaker of national reputa-
tion will deliver a Hughes address in
Portland tomorrow night. He is Albert
J. Beveridge, ex-United States Senator
from Indiana, one of the leaders in the
Progressive party movement, who was
chairman of the Progressive National
convention of 1912 which nominated
Colonel Roosevelt for President.

Senator Beveridge will speak at the
Portland Armory, Tenth street, between
Cough and Davis, at 8 o'clock. Earlier
in the day he is to address a meeting
of Oregon Agricultural College stu-
dents and citizens of Corvallis at that
city.

CHINAS TO BE FREED

STATE GAME COMMISSION WILL
LIBERATE 2000 SUNDAY.

Birds Kept as Near Wild State as
Possible, and Are Expected to
Hide Away From Hunters.

Two thousand China pheasants are
to be liberated in different parts of
the Willamette Valley next week by the
Oregon State Fish and Game Com-
mission. The birds have been hatched from
eggs on the state game farm near Cor-
vallis. As soon as the hunting season
closes at sundown on Sunday, the birds
will be allowed to take up their abode
in Oregon woods and fields.

The number of pheasants this year
has been considerably diminished, ac-
cording to Game Warden Carl D. Shoe-
maker. "There is not likely to be a
single pheasant in the first broods
this year which survived the hard
winter," said Mr. Shoemaker yesterday.
"The young birds were literally
drowned by the thousands during the
rainy weather. The long periods of
cold weather also caused much de-
vastation, for while the snow was on
the ground it was exceedingly hard for
the birds to find food."

The birds which are to be turned
loose next week have been kept as
much as possible in the wild state.
The pens in which they are confined
at the game farm are never approached
by any humans except the three men
who feed the birds. Thus, when they
are turned loose they will not be ac-
customed to people, and will seek hid-
ing places away from hunters and thus
preserve themselves.

a big fee is in prospect to the clerk of
the Circuit Court on Friday the 13th.
Not many clients wish to have their
cases filed on such an inauspicious day.

though he expects nobody will read it
at the marriage license window.
