> PARIS June 26 .- The French made h surprise attack northwest of Hurtebise last night, after brief artillery preparation. The War Office announces the capture of the entire first line German trenches which were held against desperate counter-attacks. More than 300 prisoners were taken

LONDON, June 26 .- "There was a successful local operation last night northwest of Fontain-les-Croisilles, resulting in the capture of a number of German prisoners," says today's official statement. "A hostile raiding party was repulsed in the night west of La. Baase."

BERLIN, via London, June 26 .- The French troops which penetrated the German lines northwest of Hurtebise on the Alsne front were subjected to a counter-attack and ejected from the greater part of the positions they had cupied, army headquarters announced today.

Great quantities of ammunition are being expended in artillery fire along the front held by Crown Prince Rupprecht (the British front in Belgium and Northern France), the statement declares.


