He waived preliminary examination yesterday and was held in the city jail on \$2500 bail. It is alleged that Stephenson under the name of Price caused five or six checks in Portland during a period of several months. His exertions have been spasmodic. He was arrested in Seattle Wednesday night. The forgeries charged to him total in the neighborhood of \$2000.

CITY MAY PAT CENSUS COST.—Whether Portland will foot the bill for the recent census registration will be decided by the City Council when City Commissioner Kellaker completes an investigation and makes a report. The question was put up to the Council and referred to Mr. Kellaker yesterday by Mayor Baker. It has been explained that the great majority of cities have not this expense, relieving the Federal Government. This is true of practically all parts of Oregon outside of Portland. Portland's bill amounts to about \$5000.
