FIRST IMPRESSIONS OF RUTH CHATTERTON, NEW STAR, HOLD

Not Satisfied With Gentle, Well-Bred Parts, Actress Will Attempt More Strenuous Roles With Close of Present Tour.

FIRST impressions, they say, are the most faithful, and the first impression on meeting Ruth Chatterton, the new star who is at the Heilig this week in "Come Out of the Kitchen," is that of her gentleness. She is gentleness itself and she wears the attribute gently.

It is little wonder, then, that she fits so like a glove the part of Miss Ellen in the play, "Come Out of the Kitchen." Miss Ellen is such a well-bred character and that, too, is characteristic of Miss Chatterton. Webster says to be gentle means to be well bred.

But, when next Miss Chatterton comes to Portland, it will be in a part, it is perhaps a direct antithesis of the gentle Jane Ellen.

"I do not believe in leaning on one's personality," she analyzed, in explanation of her ambition to do the intense, heavy, dramatic and sometimes unbecomingly things that advanced acting demands. "It is so easy to do that, and to rely on the fact that one has the opportunity in the play, 'Daddy Long Legs' and 'Come Out of the Kitchen.' I want to efface personality altogether and do the part of the character as it is, and not as it is presented to the audience."

Miss Chatterton is ingeniously earnest about it. She has a golden opportunity to try it out in Mrs. Pike's "The World Is Full of Good Men" and in the play, "A Bit of Love," in the repertoire which Mr. Miller provided her, and the critic hailed her work.

"With the close of this tour, except for perhaps occasional revivals which may or may not come, I shall try the sterner work, or I shall remain on the stage until I find something that gives me that opportunity."

Miss Chatterton is eminently fitted, no doubt, for the attempt. She is promisingly young and has done so much already. It will be seven summers before she reaches the feminine golden age of 20. She is only 22, and her mother, Mrs. Lillie R. Chatterton, who accompanies this new satellite on tour, will tell you truthfully, Miss Chatterton is fitted for her proposed debut into the heavier work because she has read—read a lot. Without the gold in fact or fancy she has reaped the emoluments of maturity through her books and she confesses that her reading has been genuine.

Because theater-goers are interested in the off-stage personality of a new star, it should be told that Miss Chatterton is a devotee of music; is a New York girl, with apparently a brilliant education. She is just as fetching in her street clothes as she is in the kitchen apron of the play, and her work is just as ready as that which enriches the character of Jane Ellen. She is distinctive, and, again, gentle. She radiates gentleness and thus has the foundation for that greatness that has been predicted for her by producers and critics alike. She has already achieved stardom.

Incidentally, Miss Chatterton has brought to Portland to visit with her during the engagement a distinguished guest. She is the Comtesse Ada De Lachau. They are good companions, and with the star's mother, live in a little world quite their own, with books and music and the stage.

Miss Chatterton has made of her theater career the up and down of early success has added to her charms instead of taking them away. She has mastered the art of assimilating victory.

Present and Prospective Troubles Will Be Discussed.

MILK SCARCITY IS FEARED

Cattle Being Sacrificed Constantly Because of High Cost of Feed and Materials as Well as Inability to Get Help.

Troubles of dairymen, present and prospective, will be threshed out this morning at a meeting of dairymen called at the Imperial Hotel at 10 o'clock. It is expected the meeting will be well attended.

Owing to the high cost of feed, the scarcity of farm help and other things incident to the milk business, many dairymen are said to be contemplating going out of business. That moves along these lines are serious is evident from the reports being received by dairy inspectors and others connected with the City Milk Inspection Bureau. They say each day some dairymen are quitting and selling their cows to the butcher.

Information gathered from milk producers is to the effect that a serious condition has been brought about by the scarcity of help. Men are in such demand that wages have been greatly increased and it is almost impossible in many instances to require the men to live up to the sanitary rules laid down by the dairymen whose business depends on putting out a product that passes the muster of the milk-inspection force.

The dairymen are independent and many dairymen are having trouble in getting men at any price. This has caused the general movement to get rid of cows to such extent that the work can all be done by the owner and his family.

The price of feed for cows is soaring and milk prices are going along with it. The prices of all other commodities which are a part of the business are also going up by leaps and bounds. It has been predicted that not only will Portland have a milk scarcity this winter, but that prices will advance far beyond their present range.

It is to discuss these conditions and to try to see what can be done at the meeting this morning. The meeting is being called by the dairymen who are fearful of a serious milk shortage.

Ivan Humason, special investigator for the city, has been instructed by Mayor Baker to attend the meeting. He will take a hand in the question of increased milk prices.

CAR SERVICE IS NORMAL
 Labor Situation in Butte Mines Is Not Promising.

BUTTE, Mont., Aug. 9.—With streetcar traffic at normal again today, following nearly a week's tieup due to the strike, the labor situation seemed much relieved.

The situation at the mines is not so promising. Radical members of the Metal Trades Council are seeking a resolution blank for the vote of the Sheet Metal Trades Council by which the new contracts with the mining and smelting companies are ratified. 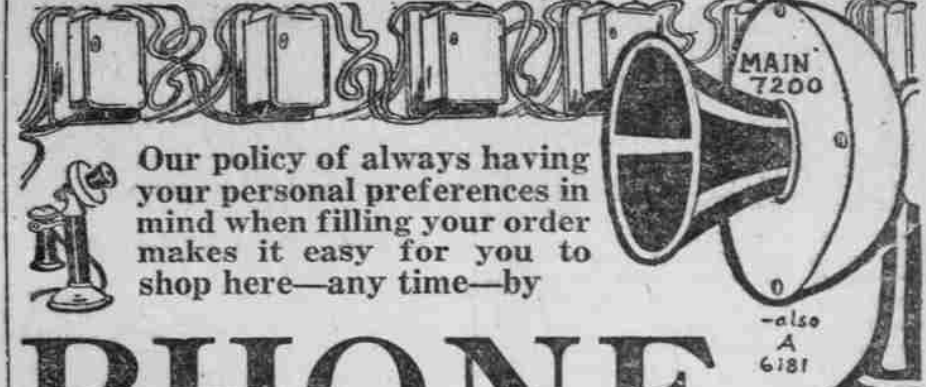
MORE TRAINING ORDERED
