COMPLAINTS FILED AGAINST JUNKMEN.
 Complaints have been lodged with
 City Health Officer Parrish against the
 practice of junk dealers working men
 and women in their establishments
 where all kinds of materials have been
 collected without first having been
 sterilized or even washed. There is an
 ordinance compelling the sterilization
 of rags before a sale is made to the
 public, but it does not require such
 action when they are purchased at re-
 sales or other places in the city. Dr.
 Parrish is considering asking for such
 a law.

ELEVATOR CONDUCTOR WANTED.—The
 United States Civil Service Commission

USE OF FISH REQUESTED.—In an ef-
 fort to reduce to a minimum the waste
 of any food product or by-product, City
 Commissioner Mann, in charge of the
 municipal incinerator, has written the
 Union Meat Company, asking the man-
 agement to utilize in its reduction
 plant fish that is not usable for food.
 Of late several loads have been sent
 to the garbage plant for incineration and
 as there is considerable oil in the fish,
 he thought it might be possible to
 make a saving.

OIL EXPECTED FOR FIREBOATS.—Inas-
 much as the Federal Government is
 deeply interested in the best possible
 protection for the large number of
 boats that are under construction along
 the waterfront, it is now deemed cer-
 tain that a supply of fuel oil for the
 operation of the city's two fireboats
 will be allowed. It would be impos-
 sible to get any other near the efficiency
 from coal, the city informed the Gov-
 ernment.

VACATION FOR MAYOR UNLIKELY.—
 Mayor Baker said yesterday that he is
 afraid he will not be able to take any
 time off for a vacation this year. Press
 of official business is so great, he ex-
 plained, that it is doubtful whether he
 will be able to leave the city hall for
 a few days. He said he would like
 to do so, but that subjects of great im-
 portance are pending and he probably
 will remain "on the job."

WOOD DEALERS CATCHING UP.—E. D.
 Jones, city sealer of weights and mea-
 sures, states that the wood dealers are
 making rapid deliveries now and are
 catching up with their orders. He is
 kept busy every day checking up on
 cordwood and slabwood on calls from
 the public. Some slabwood is being
 brought into the city from down-river
 points and this also has to be measured.

CHILD FALLS 15 FEET.—Berlina Ken-
 nedy, 23-month-old daughter of Mr.
 and Mrs. E. Kennedy, of 321 West Park
 street, was seriously injured yesterday
 morning when she fell 15 feet from a
 window to the ground below. She was
 badly injured about the head and it is
 possible she is suffering from a frac-
 ture of the skull. She was taken to
 Good Samaritan Hospital.

HUMANES SOCIETY CARS.—SLOAN—A
 light touring car, bearing license num-
 ber 13413, the property of the Oregon

E. J. MATLOCK IS DEAD.
EUGENE MERCHANT SUCCEEDS TO
INJURIES RECEIVED IN AUTO.

Death List Following New Era Hill
Accident Two Weeks Ago Is Two;
Other Victims Recovering.

E. J. Matlock, who sustained a
 broken back, which resulted in total
 paralysis, in an automobile accident on
 New Era hill two weeks ago, died at
 Good Samaritan Hospital yesterday
 morning. Mr. Matlock had shown signs
 of improvement a few days prior to his
 death, but Thursday his condition
 changed for the worse.
 In the machine with Mr. Matlock at
 the time of the accident were Miss
 Ollie Marquis, of Eugene, who was al-
 most instantly killed; Mrs. Matlock;
 Mrs. Sarah Marquis, B. J. Marquis and
 Maudie Marquis. Every member of the
 party was more or less injured, and the
 last four persons are recovering.
 Mrs. Matlock was 45 years old, and
 had been in the general merchandise
 business in Eugene for 18 years. He
 was widely known throughout the state,
 and was active in social and civic mat-
 ters in Eugene.
 J. P. Finley & Sons have charge of
 the funeral services, which will be held
 today. Funeral services will be held
 Tuesday and interment will be in the
 Oddfellows' Cemetery.

PUBLIC HELP URGED

One Delivery-a-Day System
Begins in Portland.

STORES TO ENFORCE RULE

Volume of Parcels Now Sent Out
Is Tremendous and Every Pur-
chaser Is Asked to Carry Home
as Much as Possible.

Men, money and gasoline must be
 conserved for war uses and for that
 reason milady must begin today to car-
 ry home her parcels with her or must
 be prepared to wait in her shopping
 for the parcels to come home under
 the one-delivery-a-day system.

This system will go into effect in
 the principal stores of the city this
 morning. All through the week just
 closed efforts have been made to raise
 home to the shopping public the im-
 portance of economy in deliveries and
 to prepare them for the adoption of
 the new system.

The one-delivery-a-day system has
 been taken up throughout the coun-
 try in response to the demand for the
 commercial economy board of the Coun-
 cil of National Defense. It is possible
 that the movement may be carried still
 further and may develop into a co-
 operative delivery system in the use of
 which the principal stores of the city
 will share and to the maintenance of
 which they will contribute two rats.

Charge Made for Extra Trips.

In the stores where the one delivery
 system is in force a minimum charge
 of 15 cents will be made for special de-
 liveries, except for parcels sent to ho-
 tels, depots or in cases where errors
 have been made by the store employees.
 A rule has been made also under which
 goods returned must be sent back within
 48 hours after purchase, and no article
 will be accepted for return ex-
 cept in as good condition as it was de-
 livered.

Several wholesale establishments will
 join the movement, but the principal es-
 tablishments that are putting it on
 are found among the retailers dealing
 in groceries, milk and hardware; the
 cleaners and dyers, butchers, laundries,
 milliners, florists, druggists, furniture
 dealers, florists, glove and hosiery de-
 alers, confectioners, etc.

"Get the Habit," Says Berg.
 "The volume of parcels to be deliv-
 ered by the stores of Portland is tre-
 mendous," says Mr. Berg, "and under a
 one-delivery-a-day system the problem
 of handling them will be a serious one.
 If shoppers form the habit of carrying
 home as many of their parcels as con-
 venient it will help a great deal to-
 ward reducing the volume of deliveries
 necessary and will make it possible to
 conduct the one-delivery service quite
 effectively. The help of the public in
 this is help in a movement that means
 much toward the organization of effi-
 ciency for the war."

GERMAN BOOKS POPULAR

OTHER LANGUAGE PUBLICATIONS
LIE IN LIBRARY.

Literature on Shipbuilding and Other
Subjects Bearing on War Also
Are in Great Demand.

German has been in brisker demand
 than any other foreign language books
 since the United States declared war,
 it was authoritatively stated by an at-
 tache of the Portland Library yester-
 day.
 Russian and French were distanced
 in the foreign language field.
 Books and literature on the ship-
 building industry, both steel and
 wooden construction, led the list of
 subjects matter bearing directly upon
 the war.

The library has been unable to
 supply the demand for material on the
 subjects of engineering in all its
 branches and the closely allied line of
 wireless.
 Indicative of woman's interest is the
 fact that large numbers of calls have
 been received for matter pertaining to
 canning.
 Probably next in demand has been
 the line of manuals on subjects associ-
 ated with the war, such as those deal-
 ing with the work of the surgeons of
 the Army and Navy, etc.

War-gardening stimulated the de-
 mand for the kind of literature deal-
 ing with the subject of small-plot and
 commercial truck-farming and agri-
 cultural subjects.
 Among subjects for which there has
 been a demand far exceeding the calls
 prior to the war are those dealing
 with technical lines, fiction stories
 about the kind of military situations
 of the day and geographical features.
 There are long waiting lists for
 nearly all of the subjects enumerated.

Mute, Eager to Join Army,
Has Original Scheme.

Draft Summons to Be Ignored,
Whereupon Law Abiding Member of Fight-
ing Force.

VANCOUVER, Wash., Aug. 10.—(Spe-
 cial).—J. Frederick Meagher, the deaf
 post-wrestler-boxer, who is one of the
 only two deaf men in America having
 a police power, has hit on an origi-
 nal scheme for being mustered into
 the Army.

A year ago he offered the services of
 a company of deaf marksmen to the
 War Department, for use in the puni-
 tive expedition after Villa, and was
 turned down. In March he offered a
 deaf regiment to Colonel Roosevelt and
 after some correspondence received a
 tentative acceptance. He comes of
 fighting Irish stock and has set his
 heart on "taking part in that grand
 old shindy," as he calls it.
