ARCHBISHOP HERE

Rt. Rev. Alexander Christie
Celebrates Completion of
40 Years in Priesthood.

PONTIFICAL HIGH MASS SAID

Clergy of Diocese at Informal Luncheon
After Ceremony—Reception
Held at Archbishop's
Residence.

In celebration of the 40th anniversary of his ordination, the Most Rev. Alexander Christie, Archbishop of Oregon, held solemn pontifical high mass yesterday morning at St. Mary's Cathedral before a large congregation and the assembled clergy of the Diocese of Oregon. The music was by the monastic choir of Mount Angel College. The assistant priest was Rev. Father Hilbrand, of Oregon City, and the deacon of the mass was Rev. Father Arthur Lane, of Albany; the sub-deacon, Rev. Father William Cronin; the deacons of honor, Rev. Father Gregory, U. S. B., and Prior Olsen, O. P. Rev. Father Ignatius MacNamee was master of ceremonies.

In the sanctuary were Bishop Carroll, of Helena, Mont., with Rev. Father Boland, C. S. C., president of Columbia University, and Rev. Father George Thompson, as deacons of honor; Bishop O'Reilly, of Baker City, with Rev. Father Buck, of Salem, and Rev. Father Cartwright, as deacons of honor.

Following the celebration of high mass, Archbishop Christie and the clergy of his diocese attended an informal luncheon at St. Mary's Academy and College, where a number of speeches were made in appreciation of Archbishop Christie's work in the field and in congratulation of the anniversary of his ordination.

Archbishop's Career Sketched.
Rev. Father William Daly acted as toastmaster, and the guests were addressed by Archbishop Christie, by Abbot Adolph, founder of Mount Angel College, Rev. Father Hilbrand, Rev. Father Edwin V. O'Hara, Rev. Father Olson and others.

Archbishop Christie spoke on the historical aspect of Archbishop Christie's career, both in the Oregon diocese and elsewhere, and paid a glowing tribute to his energy and the constructive worth of his service and leadership. Father O'Hara spoke on the educational and charitable institutions, the Home for the Aged, the Baby Home, the Orphanage for Boys and the Orphanage for Girls, which he called monuments to Archbishop Christie's administrative capacity and toil. Father Olson spoke on the several lay associations.

Last night, from 8 to 10 o'clock, Archbishop Christie held an informal reception at his residence, at which both clergy and laity were present.

More than 65 clergymen, from all sections of the diocese, were in attendance, a happy holiday gathering that forgot dignity for the time being and laughed and feasted as in their college days. The guests were in the building, bracing all territory from the Columbia River to the California boundary, and from the coast to the Cascades.

Work in St. Paul.
Archbishop Christie, an ecclesiastical graduate of the Grand Seminary in Montreal, was ordained to the priesthood in December, 1877, and for some time labored in the arch-diocese of St. Paul, with Archbishop Ireland. Missionary experience received in Southern Minnesota has proved of high value to him in his career.

After a period of years in charge of the parish of St. Stephen, in Minneapolis, he was transferred to Vancouver Island, with his residence at Victoria. In 1899 he was advanced to the Metropolitan See of Oregon, upon the death of Archbishop Conroy, and was given the title of archbishop.

MRS. FRASIER ANXIOUS

EUGENE FORGER NOT LOCATED BY
LANE COUNTY OFFICERS.

Wife and Daughters of Convicted Man
Say They Have No Knowledge
of His Whereabouts.

EUGENE, Ore., Dec. 12.—(Special.)—B. L. Bogart and E. U. Lee, of Eugene, bondsmen of Eugene Forger, had not been officially notified tonight of Judge Hamilton's action in declaring Mr. Forger's bond forfeit.

Mrs. Frasier and her two daughters were at their home in Eugene tonight. She said Mr. Forger went away Saturday night, and that she had heard nothing from him since that time.

"I have not the slightest idea where he is," Mrs. Frasier said. "He said something about going to meet his brother who lives in Washington, or that his brother was coming to meet him half way."

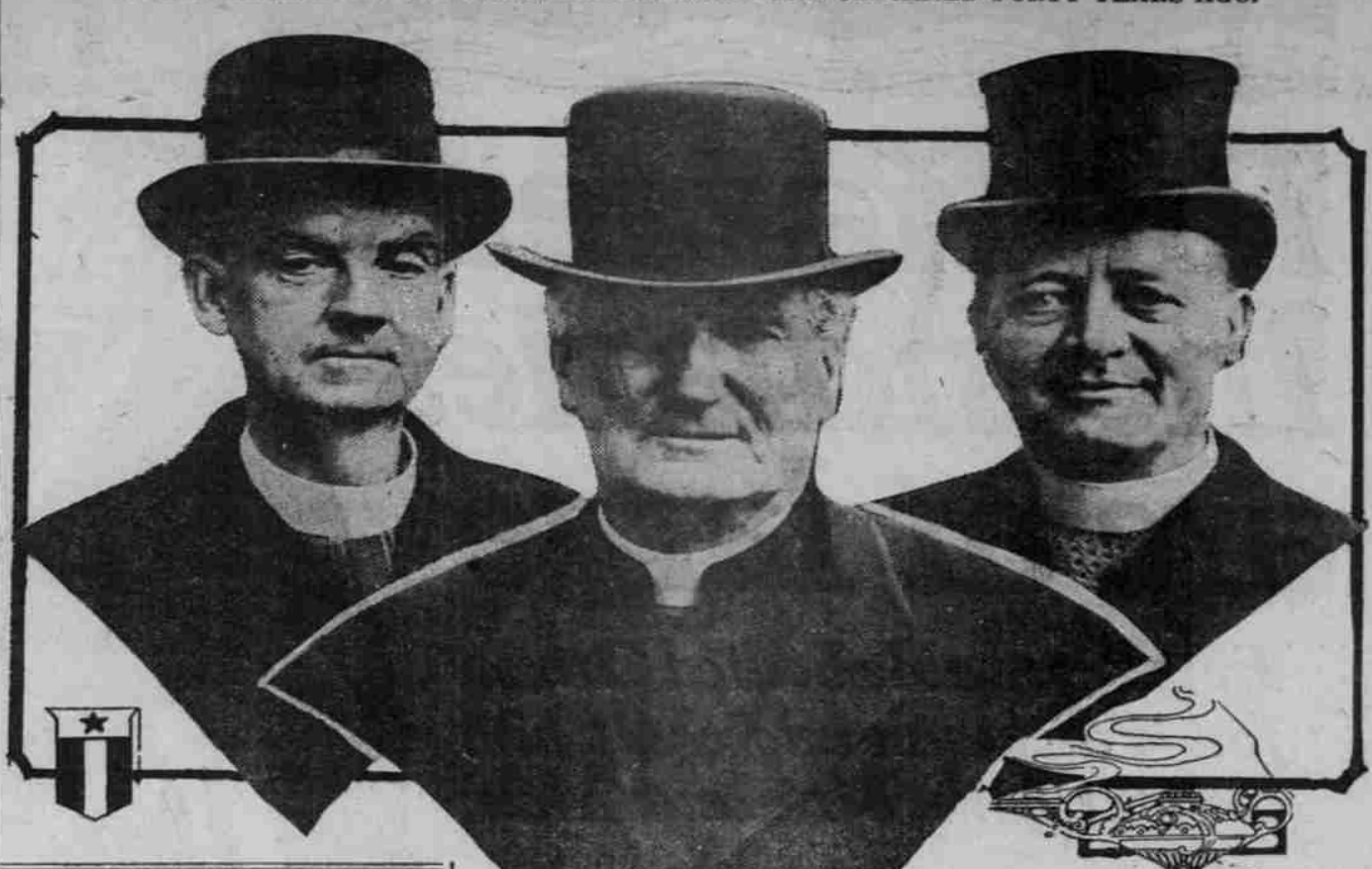
Whitton Swafford, of counsel for the defendant in the trial at Corvallis, said he had received no word from Mr. Forger.

"The mystery is just as deep to us as it is to the public," Attorney Swafford said. "He agreed to be back in court at a certain date and failed to show up."

Mr. Forger is about 65 years of age. He has been a resident of Oregon over 40 years. After coming to this state he was employed in Marion County, where he taught school. For a time he was connected with the State Insane Asylum. He came to Eugene about 30 years ago and has since been engaged in the real estate business.

At one time he owned property in Lane County estimated to be worth \$150,000. He was convicted of forging a check for \$69.

TREASON IS HINTED

General Dubail Accuses ex-Premier Caillaux.

LETTERS GIVE EVIDENCE

Correspondence With Bolo Pasha
Continued Even After Latter's
Arrest—Proof of Crimes Al-
leged to Lead to Execution.

PARIS, Dec. 12.—General Dubail has written a letter to Premier Clemenceau, accusing Joseph Caillaux, ex-Premier, of violating certain articles of the penal code, which condemn to death any one conspiring or having dealings with foreign powers or their agents, engaging them to commit hostilities or to make war against France, or conspiring with enemies to weaken the fidelity of officers, soldiers and sailors.

General Dubail in his letter says: "In the course of the investigations of communication and commerce with the enemy, the results of which are now before the civil and military jurisdictions, it has been discovered that in possession of nearly all the accused were a great number of letters emanating from Joseph Caillaux, which do not leave any doubt upon the relations existing between him and the persons accused."

"The examination of this correspondence is singularly disturbing and necessarily requires that it should be drawn to the attention of justice."

Caillaux Called to Account.
"If M. Caillaux is able to present the argument that at the commencement of these relations he was ignorant of their significance, how would he be able to explain why he did not break them off when he learned the sentiments of the men whom he had so imprudently admitted into his confidence? He did not lack warnings of every sort. The correspondence seized in the course of the investigation of Bolo Pasha is particularly suggestive."

General Dubail submits various letters, in one of which M. Caillaux writes to Bolo Pasha, desiring to talk with him and to discuss about his visit to America and invites him to dinner.

A quotation is given from a letter purporting to have been written by M. Caillaux from Rome, October 29, 1916, in which he says:

"Soon, dear friend, I must talk seriously with you of a great many things."

Bolo Pasha His Friend.
General Dubail, after quoting these letters, remarks that the correspondence continued in identical tone after P. lo had been accused of high treason and the entire press had announced the institution of judicial inquiry.

Louis Loustolot, member of the Chamber of Deputies from Landes, is accused with Caillaux.

If correspondence with the enemy has not crime for its object, but results in supplying the enemy with information injurious to France's military and political situation, the law says those holding such correspondence shall be punished with imprisonment.

Crimes against the allies of France are liable to the same penalties as those against France.

Ex-Premier Caillaux presided yesterday at a lecture in the theater at Marnes by the general commanding the district, on the subject of the origin of the war. M. Caillaux is reported to have been received warmly in Marnes, which he represents in the chamber.

ECLIPSE VISIBLE IN SOUTH

Greatest Possible Number of Phenomena Occurs This Year.

A fine view of tomorrow night's eclipse of the sun will be obtainable in Tasmania, Patagonia and from the South Pole. The best event of the solar system is not being staged for Portland's benefit this season. Over the entire Northern Hemisphere the eclipse will be invisible.

The eclipse of tomorrow, which occurs tomorrow, is visible only in the south polar regions. It is one of the series of seven eclipses, four of the sun and three of the moon, the greatest number possible, for which the passing year is notable.

There were seven eclipses in 1905, and the number will not be repeated after this year until 1935, and again in 1952.

Mr. Chapman is sending out letters to various business establishments making this suggestion and calling attention to the fact that Portland's quota is 100,000 members.

MR. HARLEY DISAPPOINTED

Astoria Submarine Base Appropriation Far Away, He Says.

OREGONIAN NEWS BUREAU, Washington, Dec. 12.—Mayor Harley, of Astoria, after inquiry at the Navy Department and around Congress, is convinced that no appropriation can be obtained this session for the Columbia River submarine base, which he has been advocating for some time.

The Mayor will urge the members of the Oregon delegation to co-operate with the delegations from Washington and California.

ENORMOUS BUSINESS COVERED IN SINGLE PRINTED PAGE.

Rear-Admiral Taylor Tells of Biggest Naval Programme Ever Undertaken Anywhere.

ONE OF EARLIEST WHITE MEN IN OREGON DIES ON OLD HOMESTEAD.

WASHINGTON, Dec. 12.—One single printed page constitutes the annual report, made public Tuesday, of Rear-Admiral David W. Taylor, chief of the Bureau of Construction and Repair, although that officer is carrying out the largest naval building programme ever entered upon by any nation.

More than 800 vessels are under construction, from dreadnaughts and battle cruisers of a size never before contemplated to submarine chasers designed, built and sent abroad immediately after the declaration of war. In some cases a year has been saved in the construction of destroyers.

Vessels not expected for delivery until late in 1918 are today in actual service in European waters. Billions of dollars are involved in the contracts, yet the report says only that all building facilities are being used and exceptional measures to accelerate construction of certain types have been taken.

"These measures are producing results," Admiral Taylor concludes, summarizing his gigantic task in what is probably the briefest report ever made by a Government bureau.

TEACHER HITS PUPIL

S. C. May, of Jefferson, and
Junior Himple "Go to Mat."

SCHOOLROOM IS SCENE

Sensational Episode Takes High
Students by Surprise—Janitor
and Fellow Educators Pry
Contestants Apart.

Sampel C. May, teacher of civics and track coach in Jefferson High School, engaged in fist encounter and rough-and-tumble fight with William Himple, a high school junior, yesterday morning in the register room. They were pried apart by the janitor and H. Smith, teacher of English.

Witnessed by all of the pupils present in the room at the time and some who rushed in when the noise of battle resounded through the halls of the big "high," the affair caused a sensation among the students.

That Mr. May struck the first blow, is said to be admitted by him, although when he was asked for a statement he curtly replied that he had none to make. Witnesses agree that he hit Himple first.

Hopkins, principal of the school, declined to discuss the case prior to filing his official report of the fight with Superintendent of Schools Alderman today.

That a further investigation may be had, directed by members of the Board of Education, is the general belief. Junior Himple did not report to him when leaving class at 3:30 Tuesday, as per the rules, is the direct cause of the episode.

When young Himple entered the register room yesterday morning, for study period, he was encountered by Mr. May, who upbraided him for his failure to report off the previous afternoon.

Himple's reply was inaudible to those in the room, and is said to have "assumed a defiant and combative attitude" toward Mr. May.

Suddenly Mr. May struck Himple a smashing blow in the face. Himple struck back, they clinched and went to the "mat," with the onlookers too startled and surprised for the nonce to act. In a moment, however, Mr. Smith, aided by the janitor, pulled them apart.

CITY TO GO FISHING

Ordinance Authorizes Leasing
Boat From Port of Portland.

SEA FOOD PURCHASES BIG

Commissioner Kellaher Tells Council
Municipal Fish Market Great
Benefit to Retailers Who Seek
to Have It Abolished.

The city will go into the fishing business. The City Council yesterday authorized Commissioner Kellaher to lease a boat from the Port of Portland to be sent to the fishing banks off the Oregon coast and catch fish of all kinds for sale at the municipal market. Mr. Kellaher says he expects to get the boat from the Port of Portland rent free.

The ordinance also provides for a campaign of education along fish eating lines and for the advertising of the food values of fish.

It was declared before the Council that the fish market already has caused a big increase in the local consumption of fish. This increase, Commissioner Kellaher said, has benefited the very fish dealers who are now seeking to have the Circuit Court to put the municipal market out of business. He said that wholesalers have admitted to him that formerly 500 pounds of black cod in a day would glut the local market, while now the market stands as high as 2000 pounds in a day. Also he produced Government reports showing the fishing possibilities off the Oregon coast.

Among other points brought out was a report from a private fishing boat which showed that for halibut caught during the past season the fishermen were paid 2 cents a pound. That same fish, Mr. Kellaher said, was sold on the Portland retail market for better than 20 cents a pound.

Notations for the lease of the boat "Joseph Pulitzer," owned by the Port of Portland, are under way, and Mr. Kellaher says that while fish dealers are trying to keep the city from getting into the fishing business, he has confidence that the port will turn the boat over to the city rent free. He says he feels that there should be no charge for the boat because the Port of Portland and the City of Portland cover virtually the same territory and are both supported by the same taxpayers.

F. J. CARLISLE IS DEAD

MANUFACTURER CAME TO OREGON
FROM SOUTH DAKOTA.

Although 54 Years of Age, Philanthropist Was Studious Performer in Y. M. C. A. Gymnasium.

F. J. Carlisle, president of the Wire Tie & Manufacturing Company, died yesterday in Good Samaritan Hospital following an illness of two weeks. The funeral will be held Friday at 3 o'clock at the First Presbyterian Church, Dr. John H. Boyd, pastor, officiating.

Mr. Carlisle was widely known in church and business circles. Coming West from Brookings, S. D., seven years ago, he took an active interest in Y. M. C. A. work in Portland and was a studious performer in the physical department. He was 54 years old when he died. He often attributed his good health the last six or seven years to his activity at the Y. M. C. A. gymnasium. Mr. Carlisle was an officer of

the First Presbyterian Church and was always active in organized philanthropy. Prior to coming to Portland Mr. Carlisle was engaged in the banking and abstract business in South Dakota.

Probably few men knew baseball as did Mr. Carlisle. To his last days he kept in close touch with all the baseball players of the major and minor leagues. He knew their batting and fielding averages and had these at his fingers' tips at all times. As a young man he played "back-lo" baseball and was considered a promising player, but he refused to enter the professional lists.

Mr. Carlisle is survived by his widow, who lives at the family home, 135 East Fortieth street North.
