

TASK IS SIMPLIFIED

George Shepherd Prepares Chart to Help Registrants.

QUESTIONS ARE ANSWERED

Data Assembled in Condensed Form by Chairman of Advisory Board Will Prove Helpful to Those Handling Questionnaires.

George S. Shepherd, chairman of Advisory Board for District No. 3, who recently prepared a chart showing at a glance when questionnaires are due, has also prepared a list of answers to the questions most frequently asked by the registrants. The questions asked are those on a point which is baffling to registrants in other districts. For the purpose of simplifying the problem as it affects those making out their questionnaires, Mr. Shepherd has submitted the following suggestions which may be helpful to some registrants.

Page 1—The registrant should give his telephone number, as it will facilitate communication with him. He should claim his classification, and give his address, date and sign his claim of exemption.

Page 2—Question 1 (b)—If the registrant is married, his wife is his nearest relative; if not, then his father, next his mother, brothers and sisters.

Question 2—The name of the employer should be the full name of the corporation or firm which employs the registrant, not the foreman or superintendent or manager of the company.

Question 3—The number of hours per week the registrant has been employed since May 18, 1917.

Page 6—Questions 14 and 15 should be answered in addition to answering the question whether the registrant ever has been convicted of a crime, as questions 14 and 15 deal with the fact of the registrant being out on bail or awaiting trial. They are not necessarily answered by reply to the question whether he has ever been convicted of a crime. After these questions he must sign his name, and also sign his name to questions under physical fitness whether he is physically fit or not.

Date of Marriage Essential.

Page 9 (under dependency)—Question 3—The registrant should come prepared to give the place and date of marriage and the name and initials of the person performing the ceremony.

Question 4—In giving list of dependents, an unborn child should be included.

Page 10—Question 5 (under dependency)—Registrant should state (a) the total amount for 12 months, and also (b) the monthly amount necessary to support his wife and children. These amounts should not include the sum necessary for the registrant's own support, but only for his wife and children.

Question 12—The answer should include all the property owned by him, which is divided into real and personal property. Real property includes only land and the buildings on the land. Personal property is all other property owned other than land and buildings; for example, personal property includes automobiles, cattle, furniture, jewelry, library books, musical instruments and generally all property except land.

Affidavit Is Required.

Question 13—The name and address of landlord and the amount of rent should be given if the registrant pays rent.

Question 20—He should also look up his tax receipts and be able to give the amount of taxes paid on real as well as personal property, and to whom same was paid.

Question 21—He should be able to give the exact amount earned by each dependent during the past year.

In order to claim deferred classification under the head of "Dependency," the statement of the registrant must be supported by the affidavit of the dependents, which affidavit, however, need not be signed by any member of the Legal Advisory Board or before any notary public within the state, and the supporting affidavit should be made before the questionnaire is returned to the local board.

NEW SYSTEM MORE COSTLY

Expense of Caring for County Automobiles Greater Than Year Ago.

Adoption of the new system of caring for Multnomah County automobiles has not resulted in any saving, according to figures submitted to the County Commissioners by County Auditor Martin. The report shows that county automobiles cost \$152.14 during November, 1917, as against \$132 for November, 1916, when the practice of using "for hire" automobiles was in vogue.

Under the system recently adopted every department must use the county machines exclusively. The employment of one man at \$125 a month to take care of all machines has resulted in increased cost to the county in automobile service. The present plan, however, will be given a thorough trial and may result in a material reduction in cost of service. Every employee using a county machine must give a daily report showing the number of miles traveled and the consumption of gasoline and oil.

NO MONEY, SLACKER'S PLEA

Judge Reprimands Man Who Refused to Join Red Cross.

William Hill tackled more than he expected when he charged a Red Cross worker on the street the other day when asked to be a member. Hill, who is 23 years old and says he has a brother in the United States Army in France, told Municipal Judge Rossman yesterday afternoon that he "is for the war heat and soul," but the court gave him a strong lecture on his conduct in raising a disturbance when asked to join the Red Cross. "I was financially unable," was Hill's explanation. He was arrested for disorderly conduct in refusing to join the organization, and, as he had been in jail two days, was turned loose with a severe reprimand by the judge.

COURT CASES ON INCREASE

District Court Fees and Fines Total \$29,203.25 During 1917.

A total of \$29,203.25 was received in fees and fines in the District Court during 1917, according to the annual report of W. J. Richmond, clerk of the court. Of this amount, \$13,748.60 was collected in fines in criminal cases. There were 1453 criminal cases filed during the year and 5375 civil cases. The number of small claims accounts amounted to 1115.

Both in fees, fines and number of cases filed, the 1917 business exceeded that of 1916. In the preceding year a total of 7325 cases was filed, as against 8143 for 1917, while the total received in fees and fines in 1916 amounted to \$22,775.75, the 1917 increase being \$6427.50.

Eight-Hour Day Adopted.

TAKIMA, Wash., Jan. 2.—(Special.)—The Cascade Lumber Company today adopted an eight-hour wage basis, in conformity with the decision of the association of lumbermen of this part of the state. The new schedule, which applies both to the company's mill here and the logging camps furnishing its material, is expected to add about 55 per cent to the payroll. The mill has been shut down for the winter, however, and the effect of the change will not be felt here for some time.

Huge Combine Due?

If persistent rumors, a confession or two, and further reports following a meeting in New York of producing officials mean anything, the early part of 1918 is going to witness the formation of a huge organization of film producers and distributors. Such an organization would give the industry two big systems, instead of a dozen or more of smaller caliber, with the saving of millions yearly on distribution and the shattering of the frenetic finance of stardom.

It has been an open secret for weeks that World and Triangle would soon combine, according to the New York Review. Then Goldwyn was scheduled to align with Paramount, but Goldfish of Goldwyn severed negotiations and this new concern is a prospective member of a group which would include Triangle, World, Metro, Mutual, Universal, Fox, Pathe, Goldwyn, Advanced, Paralta and General Film.

The Paramount combination, the biggest in the field today, consists of Famous Players, Jesse L. Lasky Company, the Marocco Company, Artcraft, probably Select, and the producing organizations headed by Thomas H. Ince, D. W. Griffith, Mack Sennett and J. Stuart Blackton.

Liberty. "Alimony," the sensational divorce drama dealing with the methods employed by unscrupulous lawyers who prey on rich men and women, black-mailing them within the law, will be shown at the Liberty Theater, commencing today.

CAMP LEWIS COST TOLD

FIGURES OF QUARTERMASTER SHOW TOTAL OF \$7,353,491.

Quota of Drafted Men Still 1572 Short. Only 22 of Whom Are Due From Oregon—Wyoming Lacks None.

TACOMA, Wash., Jan. 2.—A total of \$7,353,491 has been expended by the quartermaster department, quartermaster corps, Camp Lewis, since the camp was established, according to figures given out today. This sum represents the payrolls and such material as the camp quartermaster has purchased, but does not include money spent in the building of the cantonment. The casual office reports a total of 45,463 drafted men have entered the camp, not including two regiments of regulars nor the many voluntary battalions. The totals to date for the states sending recruits here are as follows:

California, net quota 23,060, furnished 22,100, balance due 960.
Montana, net quota 7877, furnished 7454, due 223.
Wyoming, net quota 805, furnished 819, due none.
Utah, net quota 2370, furnished 2302, due 68.
Nevada, net quota 1051, furnished 977, due 74.
Washington, net quota 7296, furnished 7171, due 125.
Oregon, net quota 717, furnished 695, due 22.
Total net quota 45,463, furnished 43,891, due 1572.
Outside states sent 253 men to Camp Lewis on transfer.
