

HOOVER'S POLICIES IN APPROBATION

President's Appointment of
Oregon Man Praised by
Fred Mason.

ROTARIANS HEAR ADDRESS

"I'd Rather Be a Clerk and Live
Under Old Glory Than Have a
Million and Be Ruled by Kaiser," Eastern Visitor Asserts.

Unqualified commendation of Herbert Hoover and his policy as Federal Food Administrator, despite the fact that the conservation of wheat cuts the output of his company by 30 per cent, was voiced yesterday afternoon by Fred Mason, president of the Shredded Wheat Company, in a talk before the Rotary Club.

A huge man, with a big, booming voice, and a penchant for merry anecdotes, Fred Mason told the Rotarians laughing from the outset, though when in serious vein he held their close attention and won spontaneous applause.

Mothers' Sacrifice Greatest.
"I am glad to have this opportunity to say something for the business man and the sacrifice he has made for this war," said Mr. Mason. "But what we have given or can give is as nothing to the sacrifice made by the mothers of America, who have sent their sons overseas. To them is the highest honor due. We business men are only doing a small part in giving our money, and giving it gladly, to back Woodrow Wilson."

"Woodrow Wilson has been a great man at a great crisis, but one of the greatest things he has done was the appointment of Herbert Hoover as Food Administrator of the United States. Such sentiment from me may sound strange, when you understand that 100 per cent of our business is wheat. This is why we are ready to go down the line for Hoover—because he is surrounding himself with men that know our business."

Mr. Mason told of the meeting at Washington called by Herbert Hoover, where wheat cereal manufacturers, met in conference with him, were told of the pressing needs of America and her allies and of the share they must take in the sacrifice.

Business Can't Buck Hoover.
"Why, the man has you licked from the start," laughed Mr. Mason. "You can't fight anything like that. We simply said, 'All right, Mr. Hoover, we'll give up 30 per cent of our wheat.'"

Mr. Mason looked a trifle of plaudits when he exclaimed with great sincerity at closing:

"I'd rather back again as a grocery clerk without a dollar and live under Old Glory than to have \$1,000,000 and have this country of ours ruled by the detestable Kaiser."

Impressive warning that nothing save complete and abject defeat will suffice to lay the peril of Prussianism was given by L. D. Wishard, recent investigator at the front as the personal representative of the President.

With possession of much conquered territory at present, said the speaker, Germany would like nothing better than to wheedle the allies and America into a false peace, while she held the conquered lands and trained her newly acquired subjects for another and even bloodier phase of her war for world dominion.

**OREGON AGRICULTURAL COLLEGE
WAR GARDENS**

The use of ashes in preparing vegetable gardening land.

(Continued.)
The fact that the ashes contain considerable lime makes them of value in being a repellent of insects which may cause trouble in the garden. There is necessarily a physical improvement of the soil where ashes are applied, inasmuch as the lime has a tendency to break up the fine particles of the soil which have a tendency to run together in the summer time and bake and the soil of these fine particles, therefore, makes the soil more porous.

It is important that not too heavy an application of ashes be applied to the ground, otherwise the soil might be rendered strongly alkaline, which would make it unfavorable for the growing of vegetables. From 10 to 50 pounds to the square rod should be spread broadcast in the spring at the time at which the ground is being worked up so that the ashes will be thoroughly incorporated in the soil.

It is not advisable to apply wood ashes to those places where potatoes are going to be planted, later in the season, as it has a tendency to increase the scabiness of the potatoes from the application of the wood ashes to the soil.

Incinerator ashes, of course, will vary a great deal in their composition from day to day, and, therefore, have to be uniform analysis such as that which might be obtained from the ashes from hard or soft wood. The incinerator ashes in general will have about 17 per cent lime, and about 2 per cent potash, which is in an available form. There is little phosphoric acid present, and, as I have previously mentioned, the variation of the incinerator is ordinarily quite wide. The figures mentioned probably will serve about an average.

In general, therefore, it can be seen that ashes are of considerable value in many ways in the soil if properly applied and given proper care. In view of the high cost of other fertilizer materials, they should be given serious consideration in the preparation of vegetable land in the spring.

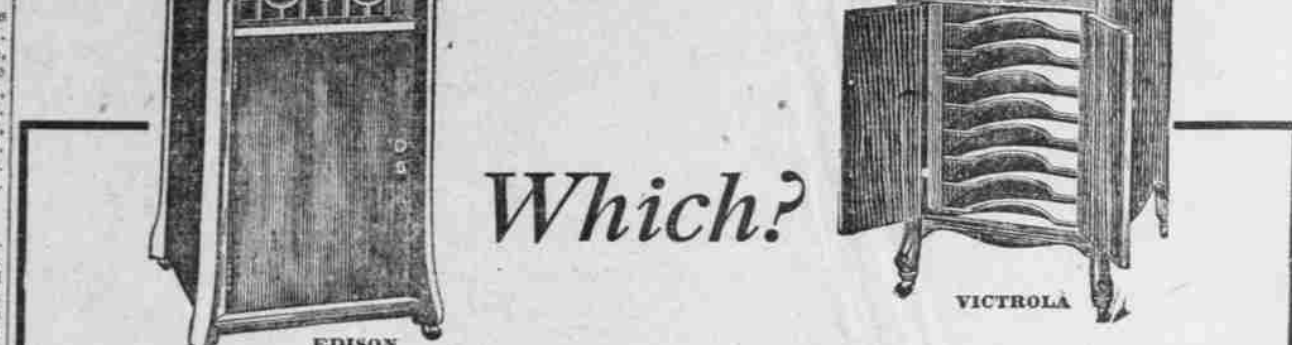

Sneezing and Coughing.
THE other morning I noticed a gentleman boarding the elevated train at a station between his home and the downtown district. I asked him why he was getting on at that station and this is what he said: "I started down this morning on my regular train. Every car was crowded. Nearly every person in my car was coughing and nobody was holding his handkerchief before his face. About a quarter of the way downtown I concluded I had had all the germs that I could handle for one day, so I got off the train and waited for one that was less crowded."

"There was no chance to get the people to protect me by sneezing and coughing into their handkerchiefs, so I concluded to protect myself by running. A few years ago I got my antrium infected in some such way and I am not taking any chances now. Why cannot the newspapers through articles, editorials and cartoons educate the people not to spit in each other's faces?"

When a person sneezes or coughs violently he throws small droplets of spit and germs 20 feet or more. A mild cold will throw them five or six feet. Rapid, hard breathing will infect the air for a foot or two around. These are not loose statements, for each is based upon repeated, careful tests, including bacteriologic tests.

Colds are contagious. The bacteria spread by sneezing are those which cause colds, sometimes pneumonia and bronchitis, occasionally, and suppurative of the antrum every now and then. The most common of all diseases is the common cold. Right there is where the trouble comes in.

We are careless and indifferent about them because they are so common just as the Mexican is careless about smallpox, for he thinks everybody has it and must have it, just as the Chinese mother, in asserting over her baby's death, saying most babies die, just as the Cuban 50 years ago accepted yellow fever as inevitable.
