

AMERICA IN WAR TO FINISH, SAYS BAKER

Secretary Issues Message of Cheer to Nations Fighting Teutons.

OBJECTS OF TRIP STATED

Greeting of President Wilson borne to Marshal Joffre in Course of Extended Conference with Hero of Marne.

PARIS, March 11.—Newton D. Baker, the American Secretary of War, met a number of American, English and French newspaper men today and gave out the following statement concerning his visit to France.

"Our purpose in visiting France is to confer with General Pershing and visit the American expeditionary force and inspect its lines of transportation and its storage and supply systems, in order that we in America can more effectively support our own Army and the armies of our allies.

"Of course, any visit to France at this time is a pilgrimage to the very shrine of heroism, it is a visit to the country actually to see the great commanders and the armies which have so long held the frontiers of freedom against all attacks.

"In America, as in France, we have a civilian Secretary of War and civil power is supreme. That is one of the characteristics of the democracy which we are fighting to maintain.

"Civil Power Important in War. "Civil power must bring up the supplies of organized industrial resources and support its armies."

"In America now the dominant thought in all minds is war. The country is organized and supplies are being produced in satisfactory quantities. War materials are accumulating and a great Army is completing its training to join the force already here.

"There can be no doubt when the forces of civilization in great countries like those now allied are combined to defend the vital principles of liberty."

"Our President has nobly phrased the spirit in which America entered the war and his subsequent declarations reflect the feeling of the entire country that we are committed with all our resources to the winning of the war."

"Secretary Baker plunged into his work soon after the President's strong morning calls on Premier Clemenceau and Ambassador Sharp. General Pershing accompanied him. This afternoon the Secretary was received by President Poincare.

"War Spectacle Viewed. Shortly before landing Secretary Baker saw French dirigibles and a large flotilla of hydroplanes flying out from a French port in search of a German submarine that had been reported off the coast."

"The Secretary called on Marshal Joffre and told the noted French soldier that he had been charged by President Wilson to express the President's strong personal friendship for him and to assure the Marshal that he preserved the warmest recollections of his visit to the United States."

"The President, Mr. Baker added, had directed him to convey to the Marshal an expression of the high esteem with which 'the hero of the Marne' had inspired him."

"The Secretary conversed with Marshal Joffre for nearly an hour. WASHINGTON, March 12.—Secretary Baker's letter to President Wilson asking for permission to absent himself from his office long enough to make an inspection trip of the American expeditionary forces in France and a visit to London and Paris was made public here today, together with the President's reply granting his request."

"Mr. Baker wrote the President that he had been repeatedly urged by General Pershing to visit the Army and inspect ports, transportation and storage facilities and maps. The President replied that he believed the Secretary's visit would add to the morale of the Army abroad and at home and that his visit would be 'serviceable to all of us to have the comprehensive view which you will bring back with you.'"

The accused men were located by Detective Coleman, who intercepted a woman friend of Carpenter, who had his address and correspondence from him in her possession. It is probable that Detective Molony will leave for San Francisco to bring the prisoners back.

LARGEST BALLOON PLANT TO BE BUILT

Arcadia, Near Los Angeles, Has Been Selected as Site for Mammoth Station.

4000 MEN TO BE TRAINED

Aeronautical Committee Appointed to Survey Industrial Conditions; Air Mail Service in East to Start May 15.

WASHINGTON, March 12.—Representative Randall, of California, announced today he had been informed that the War Department would establish the largest balloon training station in the country at Arcadia, Cal., 12 miles east of Los Angeles. He said 4000 men would be sent there for training.

LOS ANGELES, Cal., March 12.—Establishment of "the largest balloon station and school in the world" near here by the Army Signal Corps was announced today by Representative Charles H. Randall in a telegram from Washington. The message said supplies already had been ordered shipped to the site designated is about 20 miles from here.

WASHINGTON, March 12.—Appointment of a committee to make a survey of the Government's aeronautical programme with relation to industrial conditions was announced today by the War Department. It will comprise Snowden Marshall, former United States Attorney at New York; Edward Wells, of the Babcock & Wilcox Company, and a third member whose name will be announced later.

The start of the airline mail service between New York, Philadelphia and Washington will be delayed probably as late as May 15, because landing rights at New York, Philadelphia and New York have not been found. The service was to have been begun April 15.

If everything is in readiness before May 15 the service will be inaugurated at the earliest day possible.

LONDON, March 12.—The members of the American standardization board, who are now in England, were the guests of honor at a reception given last night by their English counterparts. Those present were Winston Spencer Churchill, the Minister of Munitions.

Colonel Churchill, in discussing air raids, said that allied superiority in the air is shown by the ease with which allied airmen continually bomb interior German towns in broad daylight, while the Germans are able only with difficulty to reach English and French cities at night.

U. S. MAY EXTEND CONTROL

Express Companies Will Probably Be Taken Over by Government.

WASHINGTON, March 12.—Government control probably will be extended shortly to the leading express companies, it was officially intimated today at the Railroad Administration. The companies that would be affected are the Adams, American, Wells-Fargo, Southern, Great Northern, Northern, Canadian and Western.

Most express companies' earnings last year were far below the record of the year before, and some, notably the Adams, recorded an actual deficit in the latter months. Government operation and compensation on the basis of the average earnings for the last three years is sought by most companies.

Some decision probably will be reached within 10 days. Action has been delayed by discussions of the proper basis of compensation.
