COUNTY DEPOSITORIES, NAMED.—The Board of County Commissioners, on approval of County Treasurer Lewis yesterday named 17 banks as depositories for county funds for the year ending June 30, 1919. Under the arrangement with these banks, the county is paid interest at the rate of 2 percent per annum on daily balances. The banks selected are: First National Bank, United States National Bank, Ladd & Tilton, Northwestern National Bank, Hibernia Savings Bank of California, Security Savings & Trust Company, Peninsula National Bank, State Bank of Portland, First National Bank of Lincoln, Citizens Bank, Bank of Keaton, Bank of Seaside, Montaville Savings Bank, Livestock State Bank, Bank of Gresham and Multnomah State Bank.

TESTIMONY IN DIVORCE CASES TAKEN.—Testimony in support of allegations of cruelty was heard by Presiding Judge Morrow yesterday in the default divorce suits of Josie Snyder vs. Charles Snyder and Ray Barkhurst vs. Constance A. Barkhurst. Decrees in both cases will be signed later. Mrs. Snyder was arrested recently with her husband, former floorwalker in a local department store, for taking and receiving stolen goods. Mrs. Snyder was acquitted and Snyder, upon pleading guilty, was sentenced to six months in the county jail, where he is now incarcerated. Judge Morrow yesterday granted B. A. St. John a divorce from Louie W. St. John.

COOKED FOOD SALE FOR SOLDIERS.—The Auxiliary of the 6th Artillery Co., C. A. C., held its regular meeting Monday evening, June 10, at the Court-house, Matinee interest was discussed as well as some interesting letters read. This was followed by the election of officers for the ensuing year. Mrs. Geo. Williams was elected president; Mrs. E. T. C. Stevens, vice-president; Miss Sutherland, secretary; Mrs. Arthur Jones, treasurer. At this meeting it was decided that the Auxiliary would hold a cooked food sale, Saturday, June 15, at Lippman, Wolfe & Co.'s store.

LARCENY BY BURGLARY IS CHARGED.—Following a hearing before District Judge Holt, J. T. Adams was held to the grand jury in \$500 bail on a charge of larceny by bailment. The complaining witness against Adams was Edward G. Weber, a sergeant in the United States Army, who, prior to his enlistment in the service, sold his pool hall to Adams, accepting in part payment a mortgage for \$300 on the personal property. Weber alleges that Adams later sold the property to a third party and removed it from the state without liquidating the mortgage.

JUDGMENT FOR \$450 AWARDED.—M. Leibo was yesterday awarded judgment for \$450 against Nathan Strauss and his co-partners in the firm of Fleischer, Mayer & Company, by a jury in Circuit Judge Tucker's court. Leibo testified that he had an oral understanding with Mr. Strauss by which he was to work for the firm from August, 1917, to January, 1918, at a monthly salary of \$150 and expenses. The defense denied such an agreement and contended that Leibo was employed only from month to month. Leibo sued for \$500.

STREET BOMBING.—F. C. Antonsen yesterday filed suit against W. P. Fuller & Company for \$25,000 damages for personal injuries alleged to have been suffered March 1 in a collision between an automobile in which he was riding and a truck belonging to the defendant company. Plaintiff alleges that he was riding in an automobile owned and being driven by J. S. Benson, when struck at Twelfth and Couch streets by the truck as it was being turned around at the street intersection.

CHILD OF 5 BADLY BURNED.—Helen Marie Peterson, aged 5, daughter of Mr. and Mrs. John Peterson, of 190 North Seventeenth street, was badly burned yesterday afternoon when her clothing caught fire when she was playing in the yard. It is not known how the clothing became ignited, but it is presumed she was playing with matches. Her back, arms and shoulders were burned. She was taken to St. Vincent's Hospital. Hospital attendants believe she will recover.

STAGE BUILDER FALLS AND DIES.—J. W. Johnson, a stage builder, employed at the Foundation Company's shipyard, fell from the top of a vessel yesterday afternoon at 4 o'clock and died from his injuries at Good Samaritan Hospital half an hour later. He received a fractured skull and internal injuries. He was 23 years old and lived at the Vernon Hotel. He was unmarried.

W. T. FOSTER HONORED

PRESIDENT OF REED COLLEGE INVITED TO VISIT ENGLAND.

British Government Would Pay Expenses of Lecturer for Three Months' Tour of United Kingdom.

An invitation has been extended to President W. T. Foster of Reed College, by the British Government with the approval of the United States Committee on Public Information, to spend three months lecturing in the British Isles, as a guest of the Government.

This is in accord with the policy of the British Foreign Office to use every means to bring about a better understanding between the peoples of the two nations, as a basis for more effective co-operation in fundamental interests held in common.

President Foster finds it impractical to accept the offer of the British Government as soon as desired, because of the new war work which Reed College has undertaken for this summer under the Surgeon-General and because of the unit of the United States Army to be established at Reed in the Fall by direction of the Secretary of War. If, however, the opportunity is still open after this work is well under way, it is likely Mr. Foster will accept the invitation to go abroad.

The invitation comes in recognition of work done by Mr. Foster for the American Red Cross in France a year ago, at which time he also visited around the country in England. It is likewise true that Mr. Foster has gained considerable prominence in connection with the building up of Reed College.

ROAD INFORMATION SOUGHT

City and County Officials Leave on Tour of Inspection.

County Commissioners Holman, Holbrook and Mook, City Commissioner Barbur, Assistant Road Master Chapman and Superintendent of Machinery Hatchel will leave this morning on a highway inspection tour that will extend into Lane County.

The object of the trip is an inspection of road work being conducted in Lane County, where, with labor saving machinery, remarkable results are being obtained in highway construction.

Lane County officials have informed the Multnomah commissioners that with their present equipment they are grading and redressing with crushed rock prairie roads at a cost not exceeding \$200 per mile, this record being made by a crew consisting of a foreman and five laborers.

The trip the Portland party will pass over the Pacific Highway. Having recently awarded contracts for paving sections of this highway in Multnomah County, the commissioners are interested in ascertaining what other counties through which the highway passes are doing.

Council to Decide What Constitutes a Plumber.

License Refused to Man Who Has Been in Business 14 Years.

Is a man competent in a profession if he is unable to draw plans for a building? This question pertaining to the profession correctly in an examination?

This question is before the Council on appeal by Joe Antman from a decision of the plumbing division refusing him a license as master plumber.

Mr. Antman told the Council he had been seven years in the plumbing business in Portland and for seven years prior had been a journeyman plumber in Eastern cities.

Chief Plumbing Inspector Hay said another applicant, as capable as any plumber in the city, had failed to pass the examination and had gone into the shipyard.

The Council referred the appeal to City Commissioner Barbur with a request to investigate the examination and see if it is practical.

36 STARS ON SERVICE FLAG

Fruitful Work of Boys' and Girls' Aid Society Commemorated.

A service flag bearing 36 stars has been presented to the Boys' and Girls' Aid Society by Mrs. C. R. Templeton, who gave this emblem of the society's loyalty to the board of directors at their meeting Tuesday at the home of Mrs. William H. Skene. Thirty-six boys, former wards of the home, have entered the service of their country.

MRS. H. L. PITTOCK DIES

LONG ILLNESS PROVES FATAL TO WELL-KNOWN PIONEER.

Deceased Was Prominent in Philanthropic Work and Was Wife of Publisher of The Oregonian.

Mrs. Henry L. Pittock, pioneer of Oregon and prominent in Portland philanthropic work for many years, died yesterday morning at 7:35 at the family residence on Imperial Heights, after an illness of four years' duration. She was the wife of Henry L. Pittock, publisher of The Oregonian.

Four years ago Mrs. Pittock suffered a paralytic stroke, which terminated her many activities and confined her to her home, though she retained her mental vigor to the last. One week ago she suffered a relapse, and relatives were notified that there was no hope of her recovery. Death came peacefully yesterday morning, and consciousness was retained until a moment before she passed away.

She was born in Clark County, Missouri, on November 14, 1844, the daughter of E. M. Burton and Rhoda Ann Burton, her maiden name being Georgiana Martin Burton. Her early childhood was spent in Keokuk, Iowa, just across the Missouri border.

In 1862 she crossed the plains with her parents, who settled at Milwaukee, where Mr. Burton established and operated one of the first flouring mills in this district. They resided at Milwaukee for several years, afterward coming to Portland, where the daughter was educated at the old Portland Academy.

Mr. Burton entered the contracting business in this city and is remembered as the builder of many of the older structures of Portland. He was the builder of the former courthouse, which was replaced by the present structure.

On June 20, 1860, Georgiana Martin Burton was wedded to Henry L. Pittock, the ceremony taking place in this city. For more than 50 years their home was on the site of the present Pittock block. Several years ago construction work was begun on the present residence on Imperial Heights.

Four years ago, when illness overcame her, the new residence was occupied before completion, in the hope that the change would be beneficial.

Up to the time of her illness Mrs. Pittock was an active worker in the congregation of the Unitarian Church of Our Father, and was equally interested in philanthropic work and private benefactions.

For several years Mrs. Pittock served as president of the Portland Women's Union, taking the keenest interest in the organization and its various enterprises. Also she served for several years on the board of the Mann Home and the Ladies' Relief Society, which conducts the Children's Home. A great deal of her time was devoted to the work of these organizations and to similar projects.

Mrs. Pittock is survived by her husband, five children, 14 grandchildren and two great-grandchildren. The children are: Mrs. E. F. Emery, of Milwaukie, Pa.; P. F. Pittock, Mrs. F. L. Leadbetter, Mrs. L. C. Leadbetter and Mrs. J. E. Gantenbein, all of Portland.

Mrs. Emery, at word of her mother's illness, had started for Portland and was hastening home when advised of Mrs. Pittock's death. She is expected to arrive on Friday morning.

Mrs. Leadbetter, who left for Washington, D. C., several days ago to follow her son, Henry Pittock Leadbetter, who has enlisted in the Navy, was turned back at Denver, Colo., by a telegram announcing the serious condition of her mother, and a second telegram announcing death.

Two nephews and two nieces also survive Mrs. Pittock. Corporal Elwood Gallien enlisted with the Marine Corps and is now stationed at Bremerton, Wash. Charles Gallien, Louise Gallien and Helen Van Houten are residents of this city.

Arrangements for the funeral service have not yet been made, but it is probable that the funeral will be held on Saturday.
