

GERMAN STRATEGY FOILED BY AMERICA

Arrival of U. S. Troops Defeats Designs on Allied Reserves, Says Bonar Law.

OPTIMISTIC VIEWS VOICED

British Chancellor Declares Italian High Command Has No Fear of Result of Austria's Big Offensive.

LONDON, June 18.—Andrew Bonar Law, Chancellor of the Exchequer, discussing in the House of Commons today the Austrian offensive, said that the Italian high command has no fear of the result.

"The danger is not yet over," he said, "but the government can express its admiration and gratitude to the Italians for the share they have taken in the terrible struggle."

Mr. Bonar Law added that the results which had been attained justified the changes which were made leading to unity of command of the allied forces. He said it was a part of the German scheme to use up the allied reserves before the arrival of the American troops.

America Already in It.

"This has failed," he said, "America is not coming into the war, but is in the war."

The Chancellor said that American troops were pouring into France and had reached the front in a few months ago would have been thought impossible. American military co-operation, he continued, would not be limited by the lack of troops.

Mr. Bonar Law read extracts from the minutes of the last Supreme War Council, which was held at Versailles. They stated that, thanks to the prompt and cordial co-operation of America, it would be impossible for the enemy to gain a victory by wearing down the allied reserves before exhausting his own.

"After three days of attack the Austrian offensive has not secured the objectives hoped for on the first day," said Mr. Law. He added there was reason to believe that the initiative of the Austrian offensive had come from Berlin.

Enemy Foiled on West Front.

On the western front, after three months of fighting, said Mr. Bonar Law, although the allies have had to give much ground, not one of the enemy's strategic points had been attained. Great Britain's daily average expenditure during the current financial quarter was \$6,848,000, said Mr. Bonar Law in introducing a vote of credit for \$500,000,000 in the House of Commons today. He said that the present vote, which would bring the total war credits to \$6,342,000,000, would cover expenditures until the end of August.

The debt due Great Britain from her allies is \$1,370,000,000, Mr. Bonar Law said, while the dominions owe \$206,000,000.

The shipping figures, which will be published this week, he said, would show that world ship construction for the first time since the German submarine warfare began is exceeding the destruction of ships by U-boats.

U. S. EMBARRASSES GERMANS

Hun General Admits American Army Hampers Boche Military Plans.

WASHINGTON, June 18.—A dispatch to the State department today says that the Berlin correspondent of the issue of June 10, quoted a German General as saying that the American military activity, the present offensive, was hampering German military strategy and military writers, as it did not coincide with the German programme for influencing opinion at home.

U. S. TO SEEK SLACKER

STATUS OF MANY MEN FOUND TO HAVE CHANGED.

Registrants Granted Deferred Classification and Not Now Entitled to It Are Warned.

Federal authorities have outlined a campaign for apprehending and punishing a new form of draft slacker.

This new type of slacker is the registrant who was granted deferred classification at the time of his registration, but whose status since has so changed that he is no longer entitled to exemption, yet who remains silent about this change in the hope that it will be overlooked.

It is estimated there are a great many such cases in this state.

Suspicion has been directed particularly against a great many of the deferred classification grants for industrial reasons. It now appears that the status of many of these men is not the same as when they were granted their original classification. Yet they have failed to notify their local boards and continue to enjoy exemption from military service. In some cases, also, the original classification was not justified.

The draft regulations are specific in describing the penalty for failure on the part of a man granted deferred classification to notify his board at once if his status has been changed. He is required within five days to report to his local board any fact which might change or affect his classification.

Failure to make this report is punishable by one year's imprisonment.

"Every patriotic registrant who has been granted deferred classification but whose status has changed so that he is no longer entitled to that classification will report the change immediately to his local board," said Captain John E. Cullison, in charge of the execution of the draft law in the office of Adjutant-General Williams, yesterday.

"Those who have not the patriotism to report voluntarily will gain nothing by it. They will be found out and, not only reclassified, but will be subject to severe punishment. If any man is in doubt as to change of status, he should see his local board at once without delay."

CONTRACTOR NEAR DEATH

John Hakanson Narrowly Escapes Drowning at North Bend.

NORTH BEND, Or., June 18.—(Special.)—John Hakanson, a well-known contractor of this city, who is engaged in road work and has a construction camp on the east side of the bay near Glasgow, narrowly escaped drowning yesterday.

He was towing a scow loaded with a horse, hay and grain to his camp.

The scow became submerged, precipitating the contractor into the water. He was nearly exhausted, was rescued by Captain Charles Vanzile, of the tug Rambler.

O'LEARY LIKENED TO HARRY THAW

Friend of Sinn-Feiner Describes Prisoner as Being Very Restless.

"DUTCH" WOMAN FEARED

Witness at New York Trial Declares Irish Agitator Said Madame de Victorica Might Be Led to Tell All.

NEW YORK, June 18.—An apparent attempt to lay the foundation for the defense for Jeremiah O'Leary, the Sinn Fein leader, charged with conspiracy to commit treason, was made in the Federal courts today during the trial of his brother, John, who is charged with aiding the former editor of Bull to escape.

O'Leary arrived today from Sara, Wash., where he was arrested on a chicken farm by Federal agents. He was arraigned and pleaded not guilty to the two indictments. At the same time witnesses at the trial of John O'Leary were telling of Jeremiah's mental state.

Nervous Condition Alleged.

Arthur Lyons, Jeremiah's "traveling companion" on the trip west, who turned Government witness, described him as "very restless and nervous, with no fixed mental condition."

When James R. Speer, a New York lawyer, who occupied offices with Jeremiah O'Leary, was asked on the stand his opinion of Jeremiah's "about some," he replied that he "looked upon him as a replica of Harry Thaw."

Before he was placed in his cell Jeremiah told newspaper men that he had had six weeks' rest, adding that he needed it, for he was "in pretty bad shape."

Details of Jeremiah's flight were told in court by Lyons. After stating that there never was any agreement or understanding between him and John O'Leary that the former was running away from the jurisdiction of the court, he asserted that Jeremiah had asked him on May 3 to accompany him to Reno, Nev., "to try a divorce case."

John O'Leary bought two tickets for St. Louis, Lyons said, and when Jeremiah said good-bye he told his brother he would be back for his trial.

"Dutch Woman" Mentioned.

On the eve of their departure, Lyons said, O'Leary had complained of being "constantly hounded" by secret service agents; that he had talked "about some" Dutch woman being a dope fiend; that he expressed fear he would be "framed up" in connection with the German plot; and declared "political prisoners had no chance."

O'Leary, Lyons said, mentioned the name Victorica; said the woman was a drug user and that "she would tell all she knew" if deprived of her "dope."

Farm Plans Announced.

After arriving at St. Louis, he said, he and O'Leary finally made their way to Portland, Ore., where Jeremiah said he was going to buy a farm. After purchasing an automobile and some other things, he said, he and O'Leary took him to Sara, where the chicken farm on which O'Leary was captured, was bought in Lyons' assumed name—"Thomas J. Corbett."

After they had taken possession, Lyons said, he and O'Leary returned to New York immediately, but "Jerry" wanted him to stay, the place being "well stocked up."

Martyr Pose Assumed.

On May 27, Lyons said, he showed O'Leary an article in a New York paper regarding O'Leary's "dictum" with four more Americans and two Germans on charges of conspiracy to commit treason and espionage, and the fugitive said that he "expected" "about some" of being a "martyr for Irish freedom."

He said he finally obtained \$200 from O'Leary with which to come home, after O'Leary had suggested that he return via Mexico to leave the impression that O'Leary was there.

Lyons said that Jeremiah's "physical decline," during which he had lost 20 pounds, began two years ago. Lyons was questioned concerning the fugitive's mental state.

Egomaniac Hinted At.

Lyons said that Jeremiah, who believed himself "one of the greatest men this country ever produced—the man who would free Ireland," began to neglect his lucrative law practice six months after the war began.

When Speer was called, he testified that Madame Marie De Victorica, who was indicted with O'Leary, and other defendants on the treason and espionage charges had appeared three times at the office occupied by him and O'Leary and had asked for O'Leary. He did not know, he said, whether she and O'Leary had ever conferred.

FOREST FIRES SPREAD

DRY SEASON INCREASES DANGER IN MONTANA, IDAHO.
