City School Superintendent Is Named Chief of Newly Created War Work Office.

D. A. GROUT IS NEW HEAD

Mr. Aldermen Named Superintendent of War Work—Board Proposes to Terminate Litigation With Mrs. Alvin Alexander.

out discussion and the entire proceeding, so far as regarding the school administration, did not consume 10 minutes of actual time. An immediate adjournment was taken and the gathering had dispersed before it became apparent to some in the audience what had actually taken place.

Action Surprised, Says Mr. Alderman.
"The action of the board was a complete surprise to me," said Superintendent Alderman, who was present at the meeting. "At all times I have acted for the best interests of the schools as I have seen them. In the performance of my duties I have had to do some things that have hurt the feelings of some people, but in every case I did what I believed to be in the best interests of the schools."

"I have known all the time that Dr. Sommer was opposed to me and that he would do everything he could to injure me. I had never met Directors Grout and Thomas, nor they me, until after they were elected."

"Further than that, I have no statement to make at this time."

Mr. Alderman declined to say whether he would accept the proffered position in lieu of the City Superintendent. Neither would he say that he intended resisting the action of the board in displacing him as chief of the public school system of the city.

No Written Contract Made.
Mr. Alderman does not hold a formal written contract with the school district. He was chosen for a two-year term at a meeting of the board on January 25, 1917, the term to expire July 1, 1919. Two days later Mr. Alderman received written notice of his election. On the same day he signed his acceptance and returned it to District Clerk Thomas. The formal notice of Mr. Alderman's election, as transmitted by the clerk of the board, follows:

"At a meeting of the board held on the 25th inst. you were elected Superintendent of the City of Portland for the ensuing two years at an annual salary of \$5000. Your term of office under this election begins July 1, 1917. This agreement is subject to the rules and regulations of the board, which are at present in force or which may hereafter be made, and you are, in the service of the district."

Salary Cannot Be Altered.
It is understood that the board majority depends on the last sentence of this notice for its legal authority in assigning Mr. Alderman his new duties. On its face it apparently gives the directors the right to formulate whatever regulations they may desire to regulate his duties. The one thing that cannot be done, evidently, is to alter his salary, as the amount, \$5000 a year, is expressly stated.

The office of Superintendent of Schools does not come under the teachers' tenure of office law. When that measure was revised by the last Legislature through the action known as the Orton bill, it provided that executives in the school service should not come under its provisions.

It was predicted last night in some quarters that Mr. Alderman might go into the courts to fight yesterday's action by the board, which in fact was a dismissal of him from the school service.

Legal Status May Be Affected.
O. M. Plummer, a loyal supporter of Mr. Alderman, called attention to the fact that the action taken by the board was a dismissal of him from the school service, and that no notice was given of the action. This, he suggested, might affect its legal status.

He also said that it was doubtful if the board had the right to take the superintendency away from Mr. Alderman prior to the expiration of the term for which he was elected.

"It will be his duty to take general charge and direct all war work activities in the city schools," said Dr. Sommer last night, while in the particular functions of the new position of Superintendent of War Work to which Mr. Alderman was elected.

"During the last year there has been an absence of systematic war work activities in our schools. My idea is that so much time should be set aside and occupied in genuine result-producing war work by the pupils in the schools. Heretofore, this activity has been done in a haphazard manner, without any head and without anything to show for the time that has been devoted to it."

More Efficiency Needed.
"The superintendent of war work will be able to formulate and organize these activities in the schools to the end that we will have something to show for the efforts and time expended. What is needed is more efficiency."

"For instance, the work in the manual training schools should be better organized to meet the needs of the war. Then there are the Red Cross dressings, knitting and conservation cooking—all products of the domestic science department. There is room for accomplishing greater results in those activities by campaigns for the sale of liberty bonds, war-bus stamps and Red Cross subscriptions would all yield greater results and at the same time effect a big saving of time through proper organization and well-directed effort."

Mr. Alderman has been active in Oregon educational circles for many years. He is a native Oregonian, having been born near Dayton, in Yamhill county. He was graduated from McMinnville

College and then attended the University of Oregon, where he received a degree in 1898. He immediately took up the vocation of teaching, being employed at Brownsville and McMinnville. He was elected superintendent of schools of Yamhill county and later of the city of McMinnville, subsequently going to Eugene in a similar capacity. For two years he was at the head of the department of education in the University of Oregon and while serving in that position was elected state superintendent of schools.

Mr. Alderman Elected in 1913.
The resignation of Frank Higler as superintendent of schools in Portland created a vacancy in which Mr. Alderman was elected on March 25, 1913, his term beginning July 1 of the same year. His first term was for a period of one year, and he has been re-elected up to January 25, 1917, when he was again chosen for a two-year term that he is now serving.

From the very first there has been a considerable opposition to Mr. Alderman's administration. At practically every school election, when a member of the Board of Education was to be selected, an issue has been made on the standing of the candidates, either pro-Alderman or anti-Alderman. The board, as now constituted, however, is the first that has held an anti-Alderman majority. In the recent election it was generally understood that two of the candidates, Mr. Thomas and Mr. Grout, were opposed to the superintendent, although neither openly made this an issue. They received the support of the anti-Alderman votes and were elected by a comfortable margin. They were also endorsed by the labor unions.

The action of the board forecasting

the withdrawal of the appeal in the Alexander case will rank in public opinion with the demotion of the superintendent. The Alexander case, in fact, has been the chief grounds of the fight against Mr. Alderman.

About two years ago Mrs. Alexander, then principal of the Girls Polytechnic School, transferred to another school and assigned to teach history, her salary being reduced. She took the case to the courts and won in the Circuit Court, which held that the board had no right to give her a position of inferior standing. The board appealed to the Supreme Court and won.

Meanwhile the school board filed two charges against Mr. Alexander, accusing him of making fictitious entries in her school records, with incompetence and other shortcomings in her teaching.

The board appealed to the Supreme Court and it is this appeal which it is now proposed to dismiss. Since her original transfer from the Girls Polytechnic School Mrs. Alexander has not been teaching.

MEASURES GO BEGGING

FIVE PROPOSED INITIATIVE BILLS FAIL AT OLYMPIA.

Referendum on Bone-Dry Law Passed in 1917 Will Appear on Ballot at Washington Election.

OLYMPIA, Wash., July 5.—(Special.)—Five proposed initiative measures fell by the wayside tonight when no one appeared at the Secretary of State's department to file supporting petitions. Time to file petitions for the November election expires tomorrow.

Measures that died were state non-partisan, municipal marketing and strike-picketing bills, proposed by allied organized labor and farmers; universal eight-hour law, proposed by Socialists; and a bill to prohibit taking salmon, deer, or other game on the Columbia River and Puget Sound.

A referendum on the bone-dry law passed in 1917 will appear on the ballot, together with a referendum calling a constitutional convention, which was submitted by the last Legislature. The referred bone-dry act is drawn to prevent sale of anything intoxicating except raw alcohol for certain purposes.

It is more stringent than the present dry law, but the latter has been superseded by the Federal act, which has been applied to make the state bone-dry except in the case of brewers, whose purchases are subject to approval by prosecuting attorneys and who are supposed to sell liquor only on prescriptions.
